### Thayer Central lays out summer projects

Eight classrooms in the older part of the elementary building are on Thayer Central's summer to-do list.

## Haecker accepts superintendent position with Bruning-Davenport

Kolin Haecker, 6-12 principal of Raymond Central Public Schools has agreed to join Bruning-Davenport USD as the district's new permanent superintendent.

He will step in July 1 to fill outgoing superintendent, Trudy Clark's, chair and that is something the board of education noted — it is the first time most of them are seeing a change in the position.

"It's a new experience for everyone," president Mike Schroeder said. "It will be interesting. We'll make it work."

Haecker had passion, Schroeder said.

"It was tough for us to decide," Schroeder said about the five candidates they interviewed. "They all would have done a good job for everybody."

Haecker is new to the superintendent's chair. He became certified at Doane College and graduated in December.

"I'm excited for the opportunity and the challenge. My family and I are excited to come to the area and we're looking forward to the years

to come," he said.

His wife, Crystal, is preparing as well. She will be teaching at Sandy Creek. Their oldest daughter will be a senior at Bruning-Davenport. The couple has two other children, one teaching in Syracuse and the other, a student at Bryan Health in Lincoln.

In the time Haecker has served at Raymond Central, ACT and

reading scores have increased as well as graduation requirements to add more rigor to the program.

"Most important, we have a team effort here. They are a great staff to work with," Haecker said.

Raymond Central also added sixth grade and a preschool to his building. There were two major building projects — a new addition and renovation went through with a bond.

Asked why he applied to Bruning-Davenport, Haecker said he approached the idea of where, as a parent, he would want his children to attend school. Bruning-Davenport matched his personal criteria.

Haecker's teaching philosophy zeros in on students.

"It's very important to build relationships with students. When you have that, good learning and teaching happen. Teachers work for students and students work for teachers," he said.

"We liked his energy. I think he's excited to get his feet wet. Raymond Central is a little like us. They have three different sites for schools and the same challenges with transportation and getting people to the right spots," Schroeder said.

## Board offers position to Page

The Thayer Central Board of Education had two interviews April 9 for an interim superintendent and offered Randy Page, who is currently at Freeman Public Schools, and also served as superintendent at Cross County Community Schools.

Before that, Page was the elementary principal in Malcolm for six years and taught second, third, fourth and fifth grades collectively at Malcolm and Lincoln Public Schools.

The board was assisted by the Nebraska Association of School Boards that advised hiring an interim until a search in the fall will produce a better pool of candidates for a permanent position.

The Association also assists the board with interview questions and performs the legwork to organize the process, which will aide the board in its search after 13 years of working with Superintendent Drew Harris.

"We're pretty excited about Randy," board president, Tyler Tietjen said. "He has a lot of passion and is extremely energetic. We're looking forward to him working with us."

Page established a good rapport with the board, Tietjen added.

Page said he applied because Thayer Central is a "fantastic district with a lot to offer."

"In terms of academics and progress being made with the student body, the innovative things going on to help prepare kids with their future, these are people I'm interested to work with," Page said. "The administrative team is dynamic."

Page will start with the district July 1. He and his wife, Rhonda, live in Adams. They will live halfway between Hebron and Lincoln since Rhonda works for the Lincoln Community Foundation and they wanted to split their driving times. Interim superintendents are not required to live in the district they serve.

The couple also have four children, all of whom are adults.

His passion are the students — first and foremost, he said.

School and community are a partnership and in rural towns, Page sees a true connection between the two.

In his 10 years at Freeman, Page has seen the facility progress.

"Freeman has almost no facility needs," Page said. "The needs in every district are not the same."

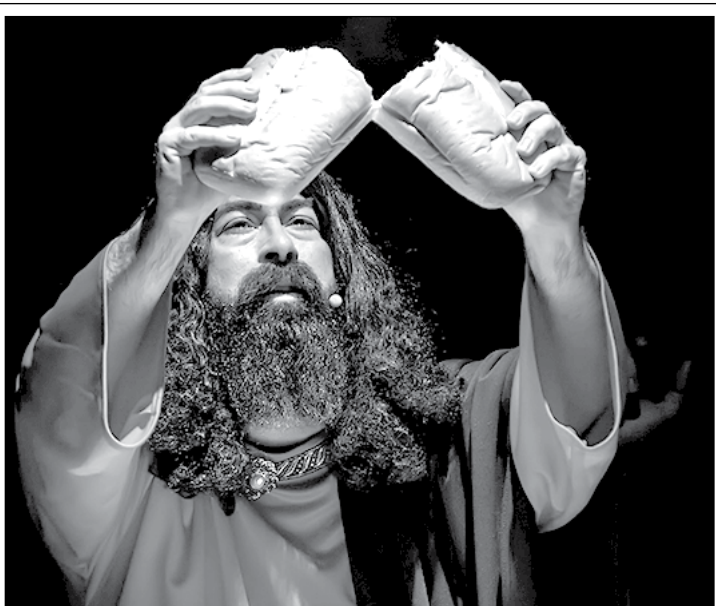
In addition, Page said Cross County improved to a complete relocation and creation of a brand new campus.

"The places I have gone as a superintendent, I felt when I left those places, in terms of facilities, curriculum and finances, I left those districts in a better position than I found them," Page said.

The board was aided by NASB for \$500, which may be applied to the total cost in the search for a permanent superintendent.

# Pages of the Past...

## 1879

### 140 Years Ago

S. M. Waterman is now mail carrier on the Little Blue route between Hebron and Red Cloud.

Our telephone works to a charm. We received the county commissioners proceedings by telephone this week.

Are not the wonderful inventions recently discovered in the material world, indicative of the progress.

There is an old lady living in this county who firmly believes that more men marry than women.

Belvidere, Neb. 4-18, 1879. Editor Journal:--A few days ago our village was visited by one C. A. Clise, who claimed to be the "Terror of the Woods." After taking in some of the horse medicine sold at our drug store, he made for the boarding house kept by Mr. Sherman. After entering the house he began to use indecent language, whereupon Mr. Sherman put him out of the house. This enraged the "Terror of the Woods," and putting his hand in his hip pocket, he said, "I'll shot the -----." Mr. Sherman fearing he had firearms with him, ran in the house and locked the door, when Clise went to the back door, found a hand ax, picked it up and went in. Finding the middle door locked, he split it open and ran Mr. Sherman out of the house, saying "I will kill him." Soon after, Clise was arrested and brought before Squire Warren, where he plead guilty, and was committed to jail to await his trial. Soon after Attorney Scott was employed, and had the prisoner brought before Judge Edwards and on writ of habeas corpus was discharged from custody, in fine style, they claiming that it was a fineable offense, but not a criminal one, as he did not kill. The law is plain and just, but our officers have laws of their own. We have elected these officers by our votes and for the last time. AN EYE WITNESS.

### 120 Years Ago

Among the "April Fool" pranks perpetrated, none afforded more amusement than the one Julius Thomas got off on his brother-in-law, Frank Shieferdecker of Alexandria, who was visiting him. He was sent all over town after a left handed monkey wrench.

The church organization known as the "United Brethren in Christ" of Hebron has concluded to erect a church building.

The farmers can beat the twin trust by establishing manufactories of their own.

Sale of School Property: According to previous announcement, the school district's Hebron real estate was sold last Saturday by virtue of resolutions adopted at the annual school meetings of 1887 and 1888. The building of the new \$20,000 school house rendered the occupancy unnecessary after June 1st, at which time the school house will be completed.

There was a good attendance at the sale, and the property realized much more than the minimum price placed on it by the school trustees, but sold very low, the reasons being that it was practically a cash sale. Following is a record of the sale.

## 1909

### 110 Years Ago

(The Bruning Banner) Quite a number of school children have been absent the past two weeks on account of measles, the school having about one-half the regular attendance.

Since Senator Ketchum showed his hand by voting against county option and also woman's suffrage many of his supporters in this county are very indignant. His vote was the deciding one on the option bill, which stood 16 to 16. Why will a minister so treacherously sell his word and honor for the hand-out of a brewery lobbyist?

The sound of the fire bell was heard Friday night of last week the first time in a long while, calling out the men to extinguish a blaze at the W.J. Strohecker residence, which was started by the explosion of an angle lamp. Before the fire wagon arrived the fire was under control, with no further damage than a few rugs and carpets.

## 1919

### 100 Years Ago

Carleton Gleanings by Pat: Ralph Barkell received an honorable discharge from military service at Camp Funston and arrived home Monday...Hermann Damm arrived home, having received his discharge from Great Lakes Naval Station...Sam Miller, Loren Shuttlesworth and Galen Lichty, who were in the same company in France for four months, are now home... Lee Wheeler, another of our boys who has been across the pond, is now home.

## 1929

### 90 Years Ago

Negotiations were completed this week through W. E. Goodhue as attorney, whereby several Fairbury people leased land belonging to Geo. W. Morris, M. G. and Reuben Corliss, for the purpose of mining silica and volcanic ash. These substances are used in the manufacture of cleansers, building board, paint, polish and some kinds of soap. A plant for drying and shipping this material will be built on the Rock Island right-of-way near Shearer's sand pit. This project will represent an initial investment of probably not less than \$10,000. A. M. Bery is at the head of the undertaking. The lease was taken for 25 years.

Hebron needs a hospital, a laundry, a creamery and a canning factory.

## 1939

### 80 Years Ago

Word has been received at the County Extension Office at Hebron from the REA at Washington, D.C., stating that this organization has approved an allotment for 172 miles of rural electrification. Also, today State Engineer A. C. Tilley approve creation of the Thayer County public power and irrigation district. Headquarters for the district will be at Hebron and John Bright of Alexandria will act as president. This is a \$182,000 project. The 172 pole miles will be augmented by 10 to 15 additional mile sidelines. On these miles there now are 276 rural signers and an additional 212 adjacent prospects.

Oranges are so plentiful in Texas, they feed them to milk

cows, says E. P. Dill, who, with his family returned last week from spending the holidays with his sister. He also reports that grapefruit is going to waste there.

The City Council passed a resolution confirming the appointment of H. H. Henningson, as consulting engineer for the Storm Water Sewer, in charge of designing, preparing plans and specifications and estimate of cost of storm water sewer. This is the project which includes the "Canal street eyesore." The estimated cost will not exceed \$13,500.

The Fairbury Live Stock Sale Barn Company reports one of the largest sales held in the past six months. Over \$24,000 worth of livestock passed through the sale ring on Tuesday as follows: \$7.55 top in fat hogs; 9.00 on stock pigs; 8.85 on stock cattle.

## 1949

### 70 Years Ago

The Hebron Golf Course is in fine early season shape and has been tried out by various local early birds. New flags have been ordered and the greens chairman will be in high gear before long improving the greens and grounds.

(The Alexandria Argus) Word has been received in Alexandria of the air rescue work in which Edwin Duncan, former co-publisher of the Argus, participated following the great blizzard which swept western Nebraska and its neighboring states. Mr. Duncan, who has been making his home at Bridgeport, Nebr., was the pilot of one of three planes operating from the Bridgeport field, flying food, medicine and fuel oil to the isolated farm homes in the stricken area. In nine days of flying, following the storm, the three planes patrolled an area of more than a thousand square miles searching for distress signals in the snow. When signals were located the places would land near the farm home to deliver the needed supplies, or when landings were not possible the supplies would be dropped from a low altitude. Edwin began flying at Hawks Field three years ago while a resident of Alexandria. From here he moved to Ogallala, where he received his private pilot's license, and then went to Bridgeport where he is flying with the Taylor Flying Service.

## 1959

### 60 Years Ago

(The Bruning Banner) According to figures released by the State Department of Agriculture to the Nebraska Irrigation Distributors' Association, there were 22,107 "registered" irrigation wells in Nebraska on January 1. Department officials believe if all the wells were registered the total would exceed 25,000. Thayer county has 409 irrigation wells.

## 1969

### 50 Years Ago

Mrs. Albert Werner of Desler received the national "Freddy" award at the Salina Ceramic Show for her artistic talents in carving, sculpturing and hand painting ceramics.

## 1979

### 40 Years Ago

Darrell Genereux was hired to serve as Hebron Junior-Senior High's new principal for the new year.

Area farmers were expressing concern about the condition of their wheat. The crop seemed to be behind its normal growth due to the harsh winter conditions.

Blue Valley Lutheran Home was second in the state to obtain a "mobile medication cart" which allowed medication to be given in unit dose form.

Paving was in full swing in Hebron following a siege of bad weather. Workmen were smoothing off the newly poured concrete at 8th and Duffield.

The Davenport Public Library received a \$743 state aid grant from the Nebraska Library Commission to be used for remodeling.

Dean Stewart became the new superintendent at the Bruning Public School.

## 1989

### 30 Years Ago

Jack Stewart of Hebron was honored by the Nebraska Pharmacists Association as its 1989 recipient of the A.H. Robins "Bowl of Hygeia" award for outstanding community service by pharmacists. Stewart was the owner of Stewart Pharmacy for over 30 years.

Little Blue NRD Manager Mike Onnen at Davenport told the Hebron Rotary Club that he was concerned with the declining ground water

levels throughout the NRD. Levels in the NRD dropped nearly two feet between the spring of 1988 and 1989. In Thayer County, levels dropped an average of 1.86 feet with the largest declines generally in the northern half of the county.

The Pollyann Shop in Alexandria was to opening soon. Operators of the new business were Wilma Busing, Jencina Walls and Bonnie DeWald.

## 1999

### 20 Years Ago

A ribbon cutting and formal opening of Metalquest Unlimited in Hebron was attended by a large crowd.

Five Brazilians visited the Hebron Rotary Club, Reinke Manufacturing Co., and Rock Creek Station.

Soaking rains somewhat delayed corn planting in the Thayer County area.

Florence Pearl Cameron died at the age of 91. She was the Village of Davenport's clerk for over 19 years.

Negatives of scenes following the 1953 Hebron tornado were found inside a wall of the Christian Church where remodeling was being done. The Christian Church was severely damaged during the tornado and had to be rebuilt, but how the negatives ended up in the wall was a mystery.

## What to do when you approach an emergency scene on the road

Many drivers who ap-proach an emergency scene on the roadway don't know how to react or what to do. This confusion can be deadly for first responders, vehicle crash victims, and other motorists approaching the scene.

Thayer County Health Services wants to share some tips for what to do when you are approaching an emergency scene on the roadway, whether it's an accident, a disabled car, a weather-related issue, or a planned closure.

- If at all possible, avoid the area and take an alternate route. Do not make an illegal turn to avoid the incident, but instead plan a different route when you hear there is an issue.

- SLOW DOWN as you approach and pass the incident. Remain alert for unex-pected occurrences, as this is a different situation than normal roadway driving.

- MOVE OVER any time you approach a stopped emergency vehicle. Move your vehicle over a lane away from the incident, as long as it is safe to do so. This gives first responders room to work on the incident.

- If no responders are yet on the scene and you have a hands-free cell phone, call 911 to report the incident. Note the location by mile marker and/or landmark so you can report it accurately.

- Look for and obey all temporary traffic control signs and direction from first responders, including lane closures. Temporary traffic control creates a safe work area for first responders to treat victims and remove damaged vehicles; motorist cooperation with traffic control is needed for the work area to be truly safe.

- Never attempt to go around an emergency scene on the shoulder, drive through it, or turn around to

avoid it or the traffic queue. These actions put you, other motorists, and first responders at risk of death and injury.

- Do not take photos or video of the incident as you pass it and do not post on social media. This distracts you from driving, which may cause an accident. It is also disrespectful to the victims and their families, who are going through a traumatic experience. There have been situations where families of victims have found out their loved ones were injured or deceased from social media posts, rather than through an official notification from emergency services, who can provide needed support during the notification. Don't put a family through the trauma of finding that out in a public forum.

- Do not pick up your cell phone to notify friends, family, or others of the emergency scene or that you will be delayed. Distracted driving kills 3400 people every year and injures 390,000, according to the National Highway Traffic Safety Administration. Don't be one.

- Remain alert, even if you have to sit in traffic. Now is not the time to let your attention wander or use your cell phone. Unexpected events can happen at emergency incidents and you must be alert so you can react.

By educating you, Thayer County Health Services can reduce the number of secondary crashes that occur every year and protect first responders from struck-by deaths and injuries.

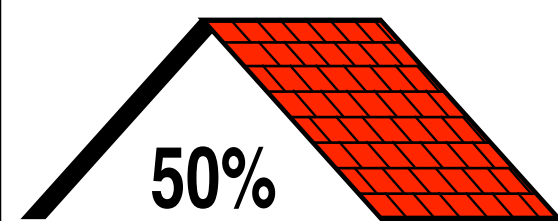

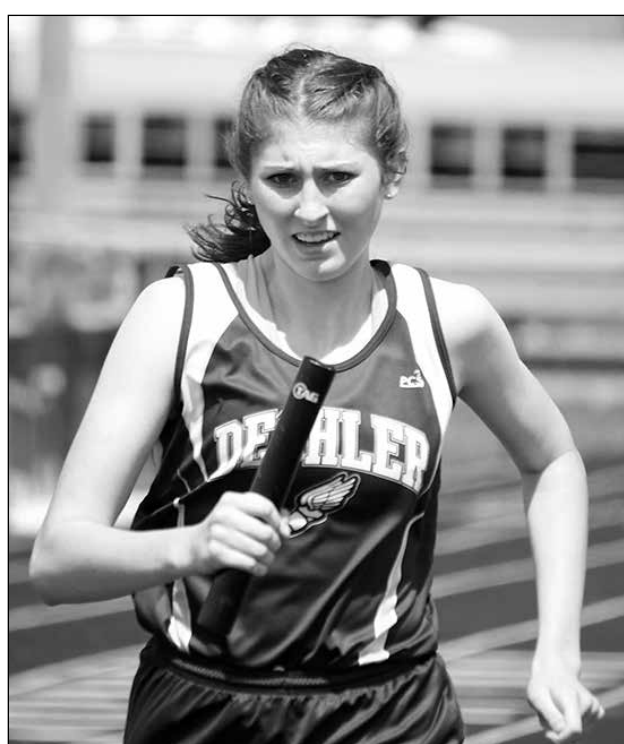

# Bowling...

About 190-200 people attended the banquet. Klaumann let them know where they stood:

"The people who came weren't customers. They were friends. You made our days and nights."

The night before, concerned bowlers from Hebron, Hubbell, Deshler, Ohiova and Geneva came to an informal meeting on the future of bowling in Hebron led by Hebron Mayor Doug Huber.

"It's been a part of my life. It was built when I was six. I think most of you are the same way," Huber said.

Pat Kenner presented a cost analysis to challenge any assumptions for income and costs.

"The greater challenge is figuring out the structure and management of the operation," Kenner stated in an email. "Working numbers is what we do in the bank, so I thought this would provide a starting point for the community to look at the business of bowling."

To break even on cash flow, the amount would be approximately \$240,000, which is \$20,000 more than the average history. A true break even point would be

about \$280,000 in sales.

Meanwhile, 300-bowler, Bryce Mammen was looking into bowling/pin units with setters, spare parts, seating and scoring from \$180,000 to \$220,000. Wood lanes would be an additional cost.

The bowlers at the banquet had a sign-up sheet at the banquet for those interested in future bowling.

"You're family," David Klaumann said at the banquet. "Thank you for all your support and if there is a chance we can have bowling here, we will support you 100 percent."

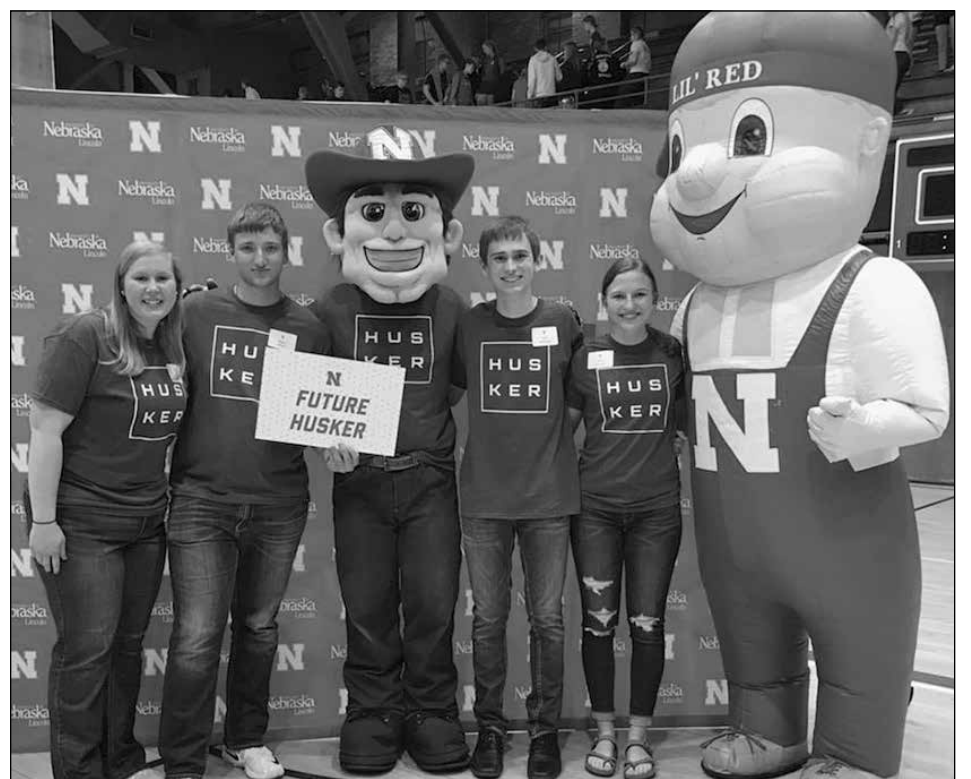

After 76 years and a five decade long banking career, I have been motivated to express my public disgust at the recent accusation toward Father Crowley. It has taken a few days for me to control my anger (I never get angry) about the attempt to destroy Father Crowley's reputation.

It is frustrating to attempt to defend my favorite priest against this claim when over three decades have passed since his death.

Although I will never believe this accusation, I, for sure, am convinced that this never happened in Hebron. Too many adult members of the Sacred Heart Parish would not have kept silent if there was even a whisper of impropriety. People like Virginia Hughes, the choir director; Ben Weidel, Cory Weidel, Ferd and Fred McKenzie, Don Lohmeier, and many other men and women I respect, would never have allowed us, their children, to be put in a position of vulnerability. My father, Robert Stutz, had been a Deputy Sheriff and then Judge, and would have been aware of

any charges/accusations.

There were at least a dozen nuns who served the Catholic school during his tenure as pastor. My brothers and sister and I attended Sacred Heart School for almost 20 years. My ancestors lived in Hebron since the 1880s.

I qualified as an Alter Boy at age 13 and, because we lived in town, about 100 yards from the rectory and church, I said Mass with Father Crowley almost every summer weekend for two years. I was alone with Father dozens of times and never witnessed or experienced any impropriety.

Hebron is too small of a community and an issue of this magnitude could not have been kept quiet.

I choose to honor Father Crowley and his exceptional reputation. He was a good person and a positive mentor in all our lives. May he rest in peace.

My best regards to all the parishioners of Sacred Heart and the Citizens of Hebron.

## Letter To The Editor

DEAR EDITOR:

The "Tidbit" on the front page of last week's edition of the Journal Register concerning Bob Schroeder's memory of a 3-lane bowling alley brought back some memories of my own.

First of all, that 3-lane alley was owned by my dad, Ed Wulfekoetter. Like Bob said the alley was on the North side of main street between 3rd and 4th streets. To be more specific it was behind Goldies' Cafe, just west of Kassebaum Ford.

I can remember setting pins by hand with my good friends, Bob's brother Billy Schroeder and Bill Kassebaum. We needed to set the pins as fast as we could so sometimes we would miss the spots and we would hear about it from the bowlers who were about to bowl. Then came along what at that time was considered to be the automatic pin setter. You had to put the pins into ten slots on the setter and they would automatically set on the spots by pushing the setter down with a lever. Because of the speed we could set the pins compared to setting them by hand, it only took two of us to do all three lanes. Usually, that

was Bill and myself.

Bob mentioned that it was kind of dangerous because sometimes pins would fly out of the pin pit and you only had to get hit once by one of those flying pins to know which bowler was mostly likely to make pins fly. I remember we knew to get out of the pits when Harry Dutcher was the bowler. There were others but Harry was the most prominent. I also worked at the Central Market at that time and my boss, Ernest Uphoff, was one of the most consistent high scoring bowlers of that time. He didn't throw hard like his brother-in-law Harry, but most of the time he would out score him.

This is just another reason that I still subscribe to the Journal Register. Articles like this and from "Pages of the Past" bring back fond memories of the hometown. Some of the last names that are mentioned in the current news of Hebron and surrounding communities are familiar but they are probably grandkids or maybe even great grandkids of the persons who live in Hebron in the 1940's and 1950's.

Thanks for the memories.

## USDA announces sign-up period for updated CSP

The deadline for Conservation Stewardship Program (CSP) applications to be considered for funding in fiscal year 2019 is May 10, 2019.

USDA's Natural Resources Conservation Service (NRCS) plans to invest up to \$700 million for new enrollments and contract extensions in fiscal year 2019. The 2018 Farm Bill made several changes to this critical conservation program, which helps agricultural producers take the conservation activities on their farm or ranch to the next level.

"CSP continues to be a very effective tool for private landowners working to achieve their conservation and management goals," said Craig Derickson, Nebraska NRCS state conservationist. "It is the largest conservation program in the United States with more than 70 million acres of productive agricultural and forest land enrolled."

CSP is a popular program for Nebraska's ag producers. Over 5.6 million acres are currently under contract in Nebraska. In 2018, over 550 farmers and ranchers enrolled over 1.3 million acres into CSP.

While applications are accepted throughout the year, interested producers should submit applications to their local NRCS office by May 10, 2019, to ensure their applications are considered

for 2019 funding.

Changes to the Program: The 2018 Farm Bill authorizes NRCS to accept new CSP enrollments from now until 2023, and it makes some important improvements to the program. These updates include:

NRCS now enrolls eligible, high ranking applications based on dollars rather than acres. For fiscal year 2019, NRCS can spend up to \$700 million in the program, which covers part of the cost for producers implementing new conservation activities and maintaining their existing activities.

Higher payment rates are now available for certain conservation activities, including cover crops and resource conserving crop rotations. CSP now provides specific support for organic production activities and for transitioning to organic production activities and a special grassland conservation initiative for certain producers who have maintained cropland base acres.

About the Program: CSP provides many benefits including increased crop yields, decreased inputs, wildlife habitat improvements and increased resilience to weather extremes. CSP is for working lands including cropland, pastureland, rangeland, nonindustrial private forest land and agricultural land under the jurisdiction of a tribe.

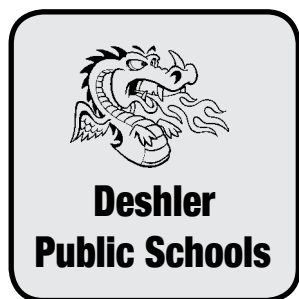
