Korean War veterans, Glenn Fischer and Dale Pletcher were two of 50 veterans recognized by the Ministry of Patriots and Veterans Affairs for the Republic of Korea with Ambassador for Peace medals. Veterans who served between June 25, 1950, and July 27, 1953, or participated in United Nations Peacekeeping operations before Jan. 1, 1956, were eligible.



Area Korean veterans honored

On July 30, Gov. Pete Ricketts hosted a ceremony for over 300 people with veterans from across the state and their family members.

In honor of the veterans for the National Korean War Armistice Day July 27, Ambassador for Peace medals were awarded to 50 veterans by the Minister of Patriots and Veterans Affairs for the Republic of Korea. Attending was the Deputy Consul General of Korea in Chicago, Donghan Yang.

"There are many ways to honor our state's veterans, and this is just one step we're taking to do that," director John Hilgert, of the Nebraska Department of Veterans' Affairs, said in a press release. "Whether it's through recognition, benefits, advocacy, care in one of our facilities, or any other service we can provide, serving Nebraska's veterans is our mission, our passion and our duty."

In Thayer County, veterans Glenn Fischer and Dale Pletcher of Hebron and Raymond Wharton of Deshler were honored with the medal.

Fischer served from 1952 to 1954 and then in the Army Reserves for a total of eight years of service, starting at age 20.

"If you volunteered, you were in three years, but if you were drafted, you were in two years," Fischer said.

His basic and advanced training of 16 weeks was completed in Fort Leonard Wood, Mo. He then attended engineering school in Fort Belvoir,

Va., and subsequently was shipped to Korea for the U.S. Army 3rd Division.

Fischer's job was to survey mines at night and replace them if needed.

He said if it hadn't been for the US, the communists would have ran the country. Fischer thinks it's good President Donald Trump is working with North Korean leader, Kim Jong-un.

Pletcher reported for service in September of 1950, attending six weeks of basic training and three weeks of leadership training. He left for Korea Dec. 4, 1950, and returned in July of 1952. Shortly after, he married Jean.

Part of Pletcher's duties were to guard prisoners from North Korea, China and Russia.

Pletcher said the Russians were supplying guns, tanks, planes and ammunition to the North Koreans.

He was honorably discharged in August of 1952.

The Ambassador for Peace medals were created by the Republic of Korea's Ministry of Patriots and Veterans Affairs.

"I want all our state's veterans to know how much we appreciate them," Ricketts said. "While the Korean War is often referred to as 'The Forgotten War,' today's ceremony is a reminder Nebraskans have not forgotten our veterans or the sacrifices they have made in defending our republic."

Historical barn stones will help build blacksmith shop

A barn built in the early 1900s with stones was most likely made onsite, Bob Reinke of the Thayer County Historical Society, said Saturday morning as volunteers met to remove large cement blocks from a property near Davenport.

"There is natural sand here. They had all the sand they needed for

blocks," Reinke said.

Some of the blocks were 16 inches long and others, 24 inches long and 12 inches wide.

Reinke said he thinks the blocks were large so the barn would be quickly built. Volunteers were going to try and remove the mortar from the blocks to use for the

Thayer County Museum's new addition — a blacksmith shop.

Michael Zlab, who is overseeing the blacksmith shop, made a hydraulic device to slam the sides of the mortar and separate the blocks. Pins in the device were angled like

Hospital creating positive culture

There are three points Thayer County Health Services Chief Executive Officer, David Burd, has laid out to create a sound culture at the hospital — positivity, empowerment and accountability.

"Empowerment is important in order for an organization to be as successful as it can possibly be," Burd said. "We need high quality, compassionate health care."

The model was used by consultant, John Roberts, for a proposal to the National Rural Health Association for a conference in late September geared toward critical access hospitals like TCHS. Burd and Roberts will speak at the event on "Leading for Success — Creating a Committed Workforce."

"We've made a ton of progress," Burd said. He has been with the hospital for nearly two years.

Burd said the hospital is in the midst of recruiting providers and has hired two firms to fill positions.

"There is a lot of activity there. We've had interest in the MD and mid-level positions," he said.

But, TCHS is taking its time in selecting providers.

"We would certainly like to fill the positions sooner than later. We want to do it correctly. We're building a team to move forward and achieve what we can," Burd said.

Meanwhile, the hospital added physician assistant Wendy VanSkiver and behavioral health specialist, Kelsey Koranda. Both are from the area.

VanSkiver hit the ground running, Burd said. A meet and greet is scheduled for Aug. 23 at RW's in Davenport from 7:30 to 8:30 a.m., and at Bruning State Bank from 9 to 10 a.m.

A clinic schedule for VanSkiver will be posted soon. She will visit clinics in Davenport and Bruning.

Koranda, a Deshler High School graduate, has been with the hospital for several months. She provides counseling services.

Burd said the hospital has reached out to area schools to let them know about the service, which is scarce in rural areas.

"We were very fortunate to have found Kelsey," Burd said. "We've been focusing hard on bringing health services to Thayer County for patients to receive care locally and not have to travel for it."

In May, the new chemotherapy treatments began and an ear, nose and throat physician has been on hand twice a month since July.

Perhaps billing tops the list in regards to changes.

Burd said billing was back in the hospital Aug. 1. He believes customers will see the difference in the near future.

"There has been a significant concern for a period of time," he said. "We hired four billers."

Under the direction of Hayley Ridder, the revenue cycle director, the new employees completed an extensive training program developed by Ridder.

"We feel comfortable with that process. Bringing it back in house gives us more control over the process," Burd said. "We're excited about it. We hope the community recognizes we heard them, and spent time and effort addressing their concerns."

Another new addition to the hospital is the 3D mammography machine.

Burd said the machine will reduce the amount of false positives.

"It is state-of-the-art technology. It will be available in mid-September," he said.

1888

130 Years Ago

Wanted, manufactories. There are now four paupers at the county poor farm. The county commissioners have received 16 scrapers and six plows for road districts in the county. A band of gypsies is encamped near Alexandria, and is reaping a rich reward from the gullibles for fortune telling and horse trading, so Dame Rumor says. A stone has been placed in the jail front bearing this inscription: "Erected A.D. 1888. Geo. Holes, E. R. Garvin, J. W. Lamm, Co. Com'rs."

Nebergall & Abbott have a new Aultman-Taylor threshing machine.

Hebron society boasts of containing more distinct and defined social organizations than any city in southern Nebraska. With the "big four," the "superior six" and the "upper ten" it certainly has a right to all it claims.

When a young lady spends two hours in trying to raise a 200-pound ladder in order to save the object of her affection in the shape of an 8-ounce cat, we think there is something radically wrong in this leap year business.

A. E. Hunt of Belvidere returned last week from Deadwood, Dakota, where he attended to the sad duty of assisting in the burial of his father.

The county commissioners have contracted with the Milwaukee Bridge & Iron Company for two iron bridges of 40 and 60 foot span each, both to be placed across the Blue, one near Carleton and the other near the poor farm. They also contracted with C. D. Dundas for 11 others to be placed across the Big Sandy, Rose and Dry Creeks. This is a move in the right direction and is money wisely spent.

On Tuesday, Capt. C. M. Murdock, of Wymore, stopped here while returning home from Bruning where he had been summoned by a telegraph message to apply his madstone. The patient was Lura E. Donahue, a grandchild of William Wenner, living two and a half miles east of Bruning in this county. Last Saturday while returning from the well, a cat sprang at her and bit her on the ankle. The cat was captured and showed such unmistakable signs of hydrophobia, that they telegraphed immediately to Capt. Murdock. The cat was killed. On his arrival, the madstone was at once applied to the wound and adhered strongly until fully charged with virus, when it was taken off and boiled in milk. The milk was turned a greenish black. After four hours, the stone ceased to adhere, and the patient was pronounced out of danger. The stone represents petrified coral. We are unable to give any explanation of the wonderful qualities of this stone and Capt. Murdock himself says he knows nothing about it, but the use of the stone is generally considered efficacious.

1898

120 Years Ago

Although the rainfall has been unusually heavy this season, a little more would be acceptable just now in the corn fields.

Two dogs were shot by the city marshal this week. They were acting "queer" and hydrophobia was feared so the marshal was notified and did his duty.

A re-pressed brick pavement has been laid along the east side of the First National Bank property and a new high board fence is now being built to enclose the lot.

About a dozen young ladies repaired to Spring Creek recently and participated in a select "footwashing party," much to the surprise of the fish and a number of the sterner sex who were not even invited to partake of the sumptuous banquet served under the trees in the cool of the evening.

On Tuesday, the "Fats" and "Leans" played a thrilling game of baseball, resulting in the close score of 44 to 29, the fats claiming the victory. The fanning was good, the batting out of sight, the home runs exciting, and altogether, considering the weather, the participants enjoyed a

hot time. Lou Halfman was captain of the fats, S. B. Weil was captain of the leans. A game has been announced between the business men and the county officials in the near future.

Hebron is to have a local telephone exchange. It will be owned and managed by W. H. Frame, who is at present soliciting customers. A first-class electrical system will be put in. The charges will be \$2 per month for commercial use, and \$1 per month for residence. There will be no charge for putting the instruments in the buildings. This is a good enterprise, "Push it along."

James Knox, one of the oldest settlers in the county, died at his home in Hebron this afternoon.

The barber shop of Graves & Biehn is now located on the ground floor, first door north of Frame's store. A bathroom has been put in, and they are well fixed to accommodate customers.

Frank Pracher, whose house was burned southwest of Hebron, commenced the erection of a new \$1300 house Tuesday.

Mr. and Mrs. Jesse Starbuck issued about 100 invitations to a reception last Friday evening in honor of their son and his bride, Dr. and Mrs. A. W. Starbuck. She was formerly Miss Gertrude Durno of Springville, Iowa.

1908

110 Years Ago

E. Kugel is home from Iowa where he has sold his merchandise stock, and left for Dakota the first of the week to look up a location.

Wm. Wessel and Harry Moor purchased the stockyards of Fred Grone and will continue buying cattle and hogs, as Mr. Grone has accepted a position in St. Joe and will soon leave.

Halls Tent Show was well attended Tuesday evening. Owing to the bad roads the show did not arrive in time to give their afternoon performance.

The masons from Geneva arrived here Monday to commence the work on Herman Bruning's new brick building.

Charlotte May Douglas was born in Postville, Iowa, Nov. 26, 1874, and died at Hotel Navajo, Manitou, Colo., Aug. 10, 1918, at the age of 43 years, 7 months and 14 days. She became the wife of Harry J. Newell who was a student in Omaha at that time, on May 17, 1903, where the doctor began the practice of medicine and where they have since made their home. On June 1, 1904, their daughter Beth was born, who grew to be her mother's constant companion and chum. She was stricken with diabetes in 1916 and since that time has won the admiration of all for the brave fight she has made for her life. She was beloved by countless friends and neighbors and even by the strangers among whom she went in search for health. Her very frailty pulled on the heart strings, and she was spoken of in Manitou as "the little flower upstairs." But like the flowers, she dropped in the heat and on Aug. 10 went to sleep. She leaves a devoted husband and an only daughter, Beth; two aunts in Iowa and one aunt in Chicago. A large funeral service was held on the lawn of Dr. Newell's home Tuesday afternoon. A very large attendance filled the residence lawn to overflowing. The casket of the departed one was consigned to the last resting place in the Alexandria cemetery.





Talk with your children about bullying

With the start of a new school year, Thayer County Health Services wants to help raise awareness with parents, educators and all adults about bullying.

Bullying is a widespread and serious problem that can happen anywhere and to anyone. It is not a phase children have to go through, it is not "just messing around," and it is not something they will grow out of. Bullying can cause serious and lasting harm to a child.

There are many warning signs that may indicate that someone is affected by bullying; either being bullied or bullying others. Recognizing the warning signs is an important first step in taking action against bullying because not all children who are bullied or are bullying others ask for help.

It is important to not ignore, but to talk with children who show signs of being bullied or bullying others. Bullying often points to other issues or problems, such as depression or substance abuse. Talking to the child can help identify the root of the problem.

Although not all children who are bullied exhibit warning signs, here are some signs that may point to a bullying problem are:

- Unexplainable injuries;
- Lost or destroyed clothing, books, electronics, or jewelry;
- Frequent headaches or stomach aches, feeling sick or faking illness;
- Changes in eating habits, like suddenly skipping meals or binge eating. Kids may come home from school hungry because they did not eat lunch.
- Difficulty sleeping or frequent nightmares;
- Declining grades, loss of interest in schoolwork, or not wanting to go to school;
- Sudden loss of friends or avoidance of social situation;
- Feelings of helplessness or decreased self esteem;
- Self-destructive behaviors such as running away from home, harming themselves, or talking about

suicide.
The following are signs a child may be bullying others:

- Gets into physical or verbal fights;
- Has friends who bully others;
- Are becoming increasingly aggressive;
- They get sent to the principal's office or to detention frequently;
- Have unexplained extra money or new belongings;
- Blame others for their problems;
- Don't accept responsibility for their actions;
- Are competitive and worry about their reputation or popularity;

Bullying can take many forms. Examples include:

- Verbal: name-calling, teasing;
- Social: spreading rumors, leaving people out on purpose, breaking up friendships;
- Physical: hitting, punching, shoving; and
- Cyberbullying: using the internet, mobile phones or other digital technologies to harm others.

If you suspect a child is being bullied or is bullying others don't ignore it. Studies show that when adults respond quickly and consistently to bullying behavior, they send the message that it is not acceptable.

Parents, school staff, and other adults in the community can help prevent bullying by talking about it and creating a community-wide bullying prevention strategy.

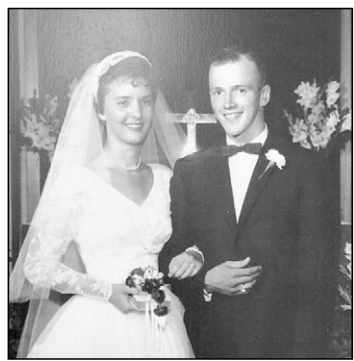

Titan football kicks season off Aug. 24

Nine seniors and 15 returning letter winners with five starters on both offense and defense will be the foundation for the Thayer Central Titan Football program this season.

Players to watch are senior Isaiah Keilwitz, who was the fourth string running back last year and started six games, rushed for 794 yards and nine touchdowns. Keilwitz was named Honorable Mention All-State.

Senior Jared Hergott (wide receiver and defensive back, racked up 73 tackles last year and was an Honorable Mention All-State. He caught 15 passes for 151 yards and three touchdowns.

Senior Keith Hergott, offensive and defensive lineman, and Honorable Mention All-State, stood out on the offensive line, adding 39 tackles, 6.5 tackles for a loss and one sack.

Senior Zach Koss, wide receiver and defensive back, led the team in receiving with 22 catches for 343 yards and four touchdowns. He was a kick and punt returner with a return kickoff for a touchdown in 2017.

Additional returning starters are senior Phillip Price, wide receiver, linebacker; senior Gabe Haase, defensive end; senior Kevin Burd, tight end, linebacker; senior Shevin Solomon, center; senior Logan Luehring, offensive and defensive line, returning letter winner; junior Jackson Feulner, quarterback, defensive back, started as running back and defensive back last year before injury in the second week; junior Carter Miller, offensive and defensive line; sophomore Brennan Harms, offensive and defensive line; sophomore Dominic Stewart, sophomore running back and linebacker; and sophomore Logan Wiedel, quarterback and defensive back.

Three new freshmen and two new sophomores will join the team, including a new player to the game of football.

"I am not sure any of the five will see time on varsity outside of special teams," Coach Jereme Jones said. Jones is now in his third season at Thayer Central. His overall record is 47-53 in 11 seasons; 6-11 in two seasons with Thayer Central. Jones coached a six-man team runner-up at two state contests in 2008 and 2015.

He will be assisted by Josh Lanik and Clint Havel.

The biggest plus for the Titans will be the experience of the 15 letter winners, not

to mention Feulner, who was an Honorable Mention All-State prior to his injury.

Jones sees an upcoming competition between Feulner and Wiedel for the quarterback position. Both played quarterback at the junior varsity level and spotted for varsity.

"They will give us more depth than we have had the past two seasons, and should help us get off to a faster start as our players will begin the season with a solid understanding of our schemes," Jones said of his returning players. "The depth will also create more competition in practice. The players will have to earn their playing time more so this season than the past two years."

The players are in their third season of eight-man football.

They are comfortable with the style of play as well, Jones added.

"As with all eight-man schools, we will need to stay healthy this season. Despite our experience, we only have 22 on the roster. This will make it important for us to get our young players acclimated to our culture and system, and get them some experience," Jones said.

He has built upon the "Carry Your Shield" culture that was established at Thayer Central.

Challenges for the team include replacing quarterback Max Madsen, who graduated holding all of the school passing records.

"We must find someone to step into the quarterback role and take control," Jones said. "Our offense relies heavily on the quarterback making good decisions both in the run game and the passing game."

The program goal is to become elite — a perennial playoff team. Last season was the first time the Titans qualified for the playoffs since 2013.

"This year, our goal is to return to the playoffs and try to become only the second Thayer Central team to advance past the first round. The 2005 Titans are the only team to have accomplished this so far," Jones said.

The first Titan game is a home game Aug. 24 at 7 p.m., as the Titans face Nebraska Christian for a special night of honoring the 25th anniversary for the 1993 Thayer Central runner-up team in Class C2 at state that year.

The 1993 has been invited to carry the Titan shield onto the field, and the players will wear the Titan "Throwback" uniform.

Lady Eagles return eight to the net

As Coach Kari Jo Alfs enters her fourth year as head coach for the Bruning-Davenport/Shickley Lady Eagles, she will look to senior Jady Kleinschmidt, senior Emilie Schardt, junior Regan Alfs and sophomore Macy Kamler to lead on the court this volleyball season.

"They have had a lot of experience throughout the spring and summer," Alfs said. Schardt is a two-year starter and one of the leading blockers in 2017.

The Lady Eagles took home the third place trophy from state competition last year and are hoping to improve on that mark this year, Alfs said.

Additional Eagle contributors are seniors, Caitlin Mosier and Sera Johnson.

"Look for these two girls to help us out in the back row," Alfs said.

Juniors, Jen Holtzen and Kaylee Noel are two strong players who may be stepping up to the net to play the front row.

Sophomore Jordan Bolte also had her hands on the ball over the summer and is looking to fill a setting position.

The Lady Eagles were set to play a quadrangular in Palmyra with Tri-County and Wilber Aug. 23.

Lady Dragon theme is leadership

The Deshler Lady Dragons will take the floor competitively Aug. 30 for a triangular with Johnson-Brock and Diller-Odell at Freeman High School with returning starters and seniors, Kayla Oakman and Sydney Roth.

Oakman is an outside hitter, who made the Twin Valley Conference Second Team last year, and Roth, a setter.

Oakman had an attack record of 410 attempts, 110 kills and 73 errors. She dug in 500 times. Roth had 293 serve attempts, 43 aces and 40 errors. She was 129 for attacks and 1,816 for attempts in assists. Roth also had 25 kills last season.

Sophomore Jenna Lemke had 393 attack attempts, 65 kills and 84 errors.

Letter winner and senior Leah Schmidt will return. Her record includes 237 digs. Juniors Tyra Schardt and Cadence Jacobs are expected to contribute as well.

The Deshler Volleyball program is coached by Audrey Parks. Parks is in her second year.

"Our theme this year is leadership," Parks said. "Last year, we lost three seniors that expressed this quality well."

Exhibit Opens with focus on dirt track racing in the 1950s and 1960s in Nebraska

The Nebraska History Museum is kicking up a little dirt with a look back on racing in Nebraska. "Start Your Engines", an exhibit that takes a look at dirt track racing in the 1950s and 1960s in Nebraska, opens August 25th. The exhibit features photographs taken by Plainview native Harold Mauck at races tracks across Nebraska and surrounding areas. Visitors will be able to see vintage race cars from the Museum of American Speed, engage with interactives that explore the history of racing, and learn more about the

science behind racing.

Mauck was a professional photographer, amateur race car driver, and pilot. After serving in World War II, he returned to Plainview where he opened a photography studio. He and his wife, Tina, ran the studio for 39 years, retiring in 1986. On weekends, Mauck raced stock cars, flew airplanes, and pursued adventure where he could find it. His love for racing blended with his passion for photography to create photos unlike anything in the Midwest. Mauck's photography collection came to History

Nebraska shortly after his death in 2010. Since then, the collection has been digitized and can be seen on the History Nebraska website, history.nebraska.gov.

Karen Kheer, photography curator and exhibitor for "Start Your Engines", says this project has been on her mind for years. "Ever since we received Harold Mauck's photograph collection I knew I wanted to put together an exhibit that highlighted his work. The excitement that Harold captured on the race track is fascinating and tells the amazing story of racing

in Nebraska unlike anything else in our collections."

The exhibit opens Saturday, August 25th, with a street party in front of the Nebraska History Museum, 131 Centennial Mall North, Lincoln, NE. The free event takes places from two to six with family activities, food vendors, and a special viewing of Harold Mauck's 7-11 stock car. More information is available at history.nebraska.gov.

ORDER BEFORE THE LITTLE BLUE NATURAL RESOURCES DISTRICT BOARD OF DIRECTORS

In the matter of adopting Rules and Regulations for the orderly enforcement of the Groundwater Management and Protection Act (§§46-701 - 46-753) and the District's Groundwater Management Plan.

THE BOARD FINDS: Protection of our water resources is of utmost importance in preserving our area's environmental, social and economic base;

An orderly process is needed to allocate groundwater in the event that groundwater levels continue to decline;

Water quality conditions continue to slowly deteriorate in the District;

Updated rules will provide the tools for addressing these water quality and quantity issues.

IT IS CONCLUDED THAT THE FOLLOWING CONTROLS SHOULD BE ADOPTED:

The allocation of groundwater will occur when spring water level readings fall below the 2016 spring groundwater level measurement by 1.0 feet, and remain below that level for two consecutive readings;

An immediate stay on new well permits and the expansion of irrigated acres will be imposed when in the first year, the spring water level measurements fall below the trigger level;

The first allocation will be 12" per certified acre per year (60" total), with an initial 1" per year (5" total) account balance granted for each certified irrigated acre, for a total allocation of 65" available over the first five-year allocation period;

The combining of allocations will be allowed for tracts which are adjacent to each other and where the irrigation systems(s) are in some way interconnected;

An operator may carry over up to 8" of unused allocation into the next allocation period;

The rules provide a mechanism for relocation of certified irrigated acres from one tract to another;

Allocations would be suspended when, in the last year of the allocation period, groundwater levels rise to a point three (3.00) feet above the allocation trigger level;

A soil sample is required from each 80 acres where corn, sorghum or forage sorghum will be planted in the ensuing crop year

No nitrogen fertilizers may be applied to sandy soils prior to March 1;

Requires the training and certification of landowners/operators in established water quality sub-areas for fertilizer and irrigation management practices and other matters prescribed by the NRD.

That the Rules and Regulations for the Enforcement of the Little Blue NRD Groundwater Management Area, as amended August 14, 2018 are hereby adopted by the majority vote of the Little Blue NRD Board of Directors and will become effective at 12:01 a.m. on September 15th, 2018.

Trafficking — Nebraska children not immune to dangers

A myth that continues to persist is that trafficking happens in cities and in other countries; we in rural areas need not be concerned.

Trafficking, a term for modern day slavery, happens in every state in the U.S. and is a global justice issue, and a major health issue.

The multi-billion dollar criminal industry is sustained by buyers who purchase men, women and children in a global market, as commodities, products to be bought, sold, traded or shared.

As I write this, a 20-year old woman is in the process of being trafficked from Concordia to Wichita to Seattle and to anywhere.

The red flags were there, but she did not have the background to know how she could be trafficked.

The impact of trafficking

causes trauma, psychological and physical problems for victims.

It affects families, law enforcement, health personnel and social service agencies. It weakens society and makes us far less than we could be as persons.

Children are special targets as they are most vulnerable and predators are quick to admit they focus on schools because of that vulnerability.

Sex and labor are the major tracks of trafficking, however, there are other kinds as well.

There is perhaps more publicity about sex trafficking for various reasons, one of which is that labor trafficking goes underreported and more statistics seem to be available for the former.

"There is a large and persistent demand for commercial sex across the state

of Nebraska, fueling a market of 900 individuals sold for sex multiple times each month" according to recent research by Creighton University in Omaha.

Fifteen percent of these individuals are at high risk.

"Human trafficking is like air. It moves and it doesn't stand still. We're on the ground floor and there's a lot of work to do," according to Dr. Terry Clark of Creighton.

Each year, the State Department publishes a TIP (Trafficking in Persons) report (google TIP REPORT), basically reporting on countries that are doing something about trafficking as well as those doing nothing.

It behooves all of us to educate ourselves and to be attentive because the difference we make can make all the difference in a life.

"It's a pioneering project. You don't get to do this often," Zlab, who also made a Roman crane to set the blocks on the blacksmith shop.

Zlab said the museum is going to recreate the barn's arches and sliding doors for the blacksmith shop, which will be on the southwest side of the museum property in Belvidere.

Once the shop is built, it will have a forge in the center and a triphammer that was first purchased in approximately 1907 for a blacksmith shop.

Eight to 10 volunteers showed Saturday morning for the historical chore. The museum was given the barn, which sits on a property of several stone buildings, years ago.

"The society is not only preserving the history of the stones used to build the barn, but will provide a working blacksmith shop for locals and others from around the state to come and share their blacksmithing talents with each other as well as the visiting public," Thayer County Museum Curator Jackie Williamson stated in her annual letter to the Thayer County Commissioners.

The second "Hammer-In" blacksmithing event was held in Belvidere on the museum grounds in June.

"It was very interesting to visit with those who came and to watch them teach the younger generation and others about the ancient art of blacksmithing," Williamson said.

The blacksmith shop may be finished by June of 2019.

"Plans are to have displays telling about the many Thayer County blacksmiths through the years and to have a place to show the many blacksmith items we have for display," Williamson stated in her letter.

Another large project of the society is the Hubbell United Methodist Church, previously owned by Linda Reid.

In her letter, Williamson reiterated the value of two stained glass windows in the church — a patriotic window sponsored by the Grand Army of the Republic (Union Army) and the second window from the Women's Relief Corps, the GAR auxiliary.

The windows were installed in 1905 when the church was built.

Williams said Architectural Glassarts of Lincoln bid \$19,000 to restore the windows.

The museum had received

\$5,000 in donations from former members, who were glad the church was being preserved.

A company out of Hastings will move the church from Hubbell to the museum grounds. The plan is to raise the building and let the foundation company, hired out of Milford, measure for pouring.

"There is lots to do, but the society is well on its way to saving those beautiful windows and preserving another piece of Thayer County history," Williamson said.

She first saw the windows in 1976.

"I visited every church in the county, took photos of each and gathered the history of each," she said.

Williamson developed a slide show out of her research and presented it to a variety of groups in the county as part of her contribution for the nation's 200th birthday.
