



## School board reaches agreement with college

The Thayer Central Board of Education has a three-year lease agreement on the primary building with Southeast Community College. The college will use the building as one of its Learning Centers.

Three years was as long as the school, a public entity, could extend the lease by law.

"They're just wanting to get in and get established," Superintendent Drew Harris said. "SCC will bear the renovation costs."

The college will pay \$400 per month and the utilities during renovations, which are scheduled to begin in January. The center is aiming to start classes in the spring.

After renovations, the rent will increase to \$1,200 per month with an annual increase of 2.5 percent.

For major repairs, such as heating, ventilation and air conditioning, the district would bear a portion of the cost and SCC, the first \$4,000.

Harris said the district would

pay half of the costs beyond the \$4,000 and SCC would meet the other half.

"Both parties would have to agree it's worth doing and the correct way to go," Harris said about major repairs. "We would have some say in what repairs would be affected."

In other business, the board opted for lettering on the new building's facade. "Thayer Central Elementary" will be illuminated.

Harris said at first, they discussed

a sign out front, but ultimately settled on the lettering for appearances.

Mike Prellwitz and Deb Craig served their final board meetings. Prellwitz was on the board for 16 years and Craig served eight years.

Harris said Prellwitz and Craig took on challenges such as personnel hearings, bond issues and construction, but have always maintained a positive attitude.

"They have always had a desire to provide the best for students in

the district in a fiscally responsible manner." Mike was also on the board

during the Hebron, Chester Hubbell Byron consolidation," Harris said.

"Their efforts to ensure a high quality education for students in Thayer County are greatly appreciated."

The new members to fill their seats are Rob Marsh and Tyler Tietjen.

## Survey places Hebron closer to leadership status

Community surveys were distributed to area residents and employees with a Dec. 30 deadline as the City of Hebron, the Hebron Chamber of Commerce, Thayer County Economic Development and Nebraska Public Power District work together to establish Hebron as a leadership community.

A Leadership Certified Community is sponsored by the Nebraska Department of Economic Development. Participating municipalities work on strategic planning to enhance their communities and provide a strong foundation for the future.

The City of Hebron had received 462 completed surveys by Dec. 22. A total of 800 surveys were mailed. Tietjen set a goal to receive 600 of them back.

City Administrator Chris Fangmeier and Chamber of Commerce Director Jana Tietjen worked from a template to develop the survey. They then submitted it to NPPD, which will analyze the data for free.

"Sometimes, these analyses can cost several thousand dollars," Tietjen said.

Questions in the survey covered basic demographics, why people live in Hebron, the city's current state compared to five years ago and which local goods and services people typically use.

It also covered goods and services used outside of Hebron, suggestions on where the city should focus its planning and resources and hourly

wages.

Tietjen said she communicated with local businesses on the survey and organizations, such as Blue Valley Community Action and the senior center.

"We want results from young to old, so we were trying to get as many as possible," she said. "It's not just for the people who live here, but also for those who work here."

The surveys were also distributed to the county offices, and the fire department.

"The fire department did a great job when asked by the mayor," Tietjen noted.

"If it's downtown revitalization and grants to look at, we just want to perform a strategic plan for the city," she said.

She hopes the information is useful to businesses.

"As we look toward new business opportunities or what people benefit from in Hebron, that will be interesting as we move forward," she added.

The idea was never to distribute a survey without following up on responses, she said.

"We want to see what's important to community members and do something beneficial for the community," Tietjen explained.

There are comment sections on the survey.

"The most important part are the comments because that's where we learn," Tietjen said.

In addition to the survey, the city is launching a new website, which will spotlight area organizations and feature county news.

To become a Leadership Certified Community, Hebron must satisfy community collaboration (a strong relationship with organizations and a strong volunteer-base); demonstrate community participation and engagement with strategic planning; demonstrate commitment to community planning efforts, like a comprehensive plan, building and housing codes and nuisance ordinances; have a business retention and expansion program; established website; and listings of business and entrepreneurial assistance programs, and available financing and incentive programs.

All applicants for the program are evaluated on community planning and zoning and business and technology, along with other factors.

Leadership Certified Communities are re-certified every five years with annual reviews.

Tietjen said the LCC program will open Hebron up to new opportunities to boost its visibility and future planning.


#### Area athletes to face off in tournaments

## 1886

### 130 Years Ago

All of the lumber, windows and doors for the depots at Deshler and Gilead have arrived.

Two dollars spent in your own town is a better investment than one dollar sent away. The former you may see again, but the latter, never.

The new dollar silver certificate is very artistically designed, and engraved thereon is the face of Martha Washington. Of all the various denominations of U.S. currency, this is the only one containing the photo of the "mother of our country" or any other lady's likeness.

Christmas has come and gone, and Old Santa, as usual, smiled upon the children in the Sunday schools of Hebron, and many little hearts were made glad by his presence.

Davenport Doings: H. Lambert has returned from his trip to the northwest part of the state. He was so well pleased with the country that he purchased a quarter section of land north of Chadron and will move there in the spring...Squire Kinner performed his first official act on Sunday last by uniting in wedlock Mr. J. L. Cumpsy and Miss Minnie Terril.

The Hebron Board of Trade should keep a sharp lookout for the Chicago & Northwestern railroad, one branch of which is projected in this direction.

Hubbell Hits: Mr. Kern, of Hubbell, and Miss Steele, of Rose Creek, Kan., have recently formed a partnership for life, and have gone to keeping house on the hill in Rev. Pond's house...Nelson & Co. have sold their stock of hardware to J. M. Curran and Dave Hanisay, who have taken possession...Mr. Smith of Diller, has recently opened up a new barber shop on the east side...The new bell for the Presbyterian Church has arrived, and been placed in the belfry. It is the first church bell in Hubbell, and the ladies of the church are proud of it, as they raised the money to buy it...Our efficient town marshal got after a band of Kansas toughs one night last week, who had filled up on Burk's firewater, and were noisy as a consequence.

Belvidere: We understand that we are to have two new lumber yards soon...The Swiss Bell ringers will give an entertainment here next Friday night.

## 1896

### 120 Years Ago

Care for the needy. Remember the poor. Remember the little ones.

A good time to bestow charity is during the holidays.

Make the children happy. Christmas comes but once a year. Childhood comes but once.

The county clerk gives notice in the Journal that sealed bids will be received for leasing the county poor farm.

Cash Gates knows how to grow fine white, crisp, fragrant celery, as we can testify from sampling.

The Western Library company have established a branch library at Hebron with 20 members. It is a circulating library consisting of 1000 books which are shipped in sections of 50 each. After being in a town three months, the books are shipped to another town and a new section sent in. The membership fee is \$3, and the quarterly dues are 10 cents. Headquarters have been established at the Journal office.

Mrs. R. H. Dimmick, who

had been in poor health for some time, died very suddenly about 3 o'clock Tuesday afternoon, Dec. 22, of heart failure. Mrs. Dimmick was one of the old residents of Hebron. She leaves a husband and five children to mourn her death.

The city scales are kept busy weighing the loads of corn and hay brought to market by the farmers.

Among the list of those recently receiving an increase of pension we notice the name of E. E. Garvin, of Chester.

It has been remarked that people are never ready for Christmas, that it comes a week to soon for the women and a year to soon to suit the men, but the children are always ready for it.

Bruning: On Monday, Philippi & Kugel shipped 2350 pounds of poultry, besides pigeons; J. F. Grone shipped on the same date 2650 pounds of chickens and turkeys...Dr. Dempster saved his library and surgical instruments, and has moved the remainder of his household goods into one of the Meyer's houses just across the street west of his late residence, where he will be found by anyone wishing his services.

## 1906

### 110 Years Ago

After five years of ranch life in Rock county, Ray Hendershot captured one of Rock county's fairly ladies, Miss Mary Ehrsam. They will make their home in thayer county where Ray is engaged in farming.

Married, on Dec. 17, Mr. J. Fred Pugh and Miss Edith Howlett, both of Byron.

The Fry quarter, known as the McLeod farm five miles northeast of Hebron, was sold recently to a Mr. Little for \$75 an acre and he will move onto it in the spring. This is the top notch paid for land around Hebron.

Geo. A. Galbraith and son, George Jr., of Evanston, Wyo., visited his mother, Mrs. Ellen Galbraith and other relatives this week. Mr. Galbraith brought down from the mountains 19 carloads, or 55 head of cattle which brought the top of the Omaha market, receiving \$20,000 for his shipment.

Byron: Hynes Grain Co. of Omaha are opening up their elevator at this place. Ed Reeves will probably be manager.

Belvidere: A baby was born to Geo. Smith and wife last Thursday. The little one lived but a few hours and was buried in the cemetery at this place...Floyd Harp has purchased the restaurant formerly owned by Joe Sarratt.

Liberty Ridge: Last Sunday dawned to be an ideal and beautiful day and a joyful one for the Lutheran Trinity Congregation of Friedensau, as they dedicated their new pipe organ that day.

Deshler: Since the transfer of John Panzeram's elevator to A. C. Bonawitz, M. H. VanBuren quit his position as overseer. J. Helget of Alexandria will take his place...The masons report only 10 days more work on the new Presbyterian Church and it will be ready for carpenters...The new St. Paul's Church built by the Ohio congregation was dedicated last Sunday and altho the weather was cold and unpleasant, yet the services were well attended.

Chester: Mrs. Ed Williams who lived south of Chester, died of consumption Wednesday morning...The

remains of Mrs. T. Baghan were brought here for burial Monday...The Holmes Bros. sold their restaurant last week to Herbert Kelso and Ernest Woodford who took possession at once.

Carleton: Ida Hessler from Dakota is home helping his father build on his tract of ground purchased from C. J. Lichty...W. W. Lichty, J. G. Miller and C. J. Lichty have lately installed a modern acetylene gas plant for their use in their pretty homes on "The Lichty Heights."

Byron: At a meeting of the Water Company Monday evening it was decided to put down another cistern, and the location will be in the street west of Paul Wurl's property...Fred Peters, our telephone man, finds, owing to the increase of business, that his house is not large enough, consequently is building an addition on the west side. This will give Fred more room for central, and the public are the gainers thereby...R. H. Kiene has purchased a hardware, furniture and implement business in Deshler and taken charge.

Byron: Harmon Koester has finished his new house and will soon be at home to his numerous friends...While Mr. and Mrs. Ernest Harms were in Byron Monday forenoon, a phone message told them their house, three miles northeast of town, was on fire. It did not take them long to unhitch their team and start for home, but alas, too late, when they arrived nothing but ashes were left to tell the tale. Everything in the house was consumed. There was some insurance. Mr. Harms will build a larger and more modern house just as soon as he can get carpenters.

The week old baby of Mr. and Mrs. Lawrence Bethscheider died Monday and was buried the following day in the Catholic cemetery.



# Vorderstrasses place in state sorghum yield contest

Lyle and Phil Vorderstrasse of Hebron recently won third and first place in the Irrigated Reduced-Till and Dryland Reduced Till division of the 2016 National Sorghum Producers (NSP) Yield Contest in Nebraska. The Vorderstrasses won with Pioneer(r) hybrid 84G62, which yielded 175.64 and 146.11 bushels per acre.

# Winter vehicle safety

The start of winter is a good time to make sure you are prepared for the cold weather. Thayer County Health Services wants everyone traveling this time of year to travel safely. With the low temperatures and even colder wind chills, it is very important to be prepared in case you become stranded. Here are some tips from the National Safety Council to help you prepare your vehicle for the winter weather.

**Prepare Your Car:** Is your car due for a tune-up? If so, get it ready for winter by checking the ignition, brakes, wiring, hoses, spark plugs, air and fuel filters, battery, tires, antifreeze level and fan belts.

**Necessary Equipment:** An emergency situation on the road can arise at any time and you must be prepared. Following the tune-up, a full tank of gas and fresh antifreeze, your trunk should have a properly inflated spare tire, wheel wrench, jack, cat litter, jumper cables, tool kit and even a shovel or something that can be used as one.

**Survival Kit:** During the winter you should keep the following items in your car as part of a survival kit in case you are stranded—working flashlight, reflective triangle, matches in a waterproof container, first aid kit, high energy foods, hard candy, ice scraper, flares, blankets, mittens, socks, and cap.

If you become stranded: Do not leave your car unless you know exactly where you are, how far it is to possible help, and you are certain it will improve your situation. Try to attract attention. Light flares if you have them and place one at each end of the car at a safe distance away. Hang a brightly colored cloth from your antenna. If you are sure the car's exhaust pipe is



not blocked, run the engine and heater for about 10 minutes every hour or so depending upon the amount of gas in the tank. To protect you from frostbite and hypothermia, use any blankets or other items you have to keep warm. Keep at least one window open slightly. Heavy snow and ice can seal a car shut. Eat a hard candy if you have it to help keep your mouth moist.

Hypothermia can happen very easily and quickly especially in: (1) elderly people with inadequate food, clothing, or heating; (2) babies sleeping in cold bedrooms; (3) people who remain outdoors for long periods—the homeless, hikers, hunters, etc.; and (4) people who drink alcohol or use illicit drugs.

The CDC provides us with warning signs of hypothermia: shivering, exhaustion, confusion, fumbling hands, memory loss, slurred speech and drowsiness. In infants, signs can be bright red, cold skin and very low energy.

If you notice these signs take the person's temperature. If it is below 95 degrees, get medical attention immediately. The CDC advises us to begin warming the person as follows: get them indoors, remove wet clothing, warm the center of the body first, give them warm beverages, keep them dry, wrap them in a warm blanket and get medical attention as soon as possible.

# DHHS Seeking Public Comment on Developmental Disability Waivers

The Nebraska Department of Health and Human Services is asking for feedback on its draft Medicaid Home and Community Based Waivers for people with developmental disabilities.

The public comment period runs from Dec. 23 to Jan. 24. Written comments must be postmarked or received by 5 p.m. on Jan. 24.

Currently the Division has three approved waivers (adult day, adult comprehensive, and children's) providing services to individuals with intellectual and developmental disabilities.

Courtney Miller, director of the Division of Developmental Disabilities at DHHS, said the current adult day and adult comprehensive waiver expired and have been granted extensions. The Division is seeking to renew the adult day waiver, and amending the children's waiver to combine the adult comprehensive with the children's to provide a waiver which covers both children and adults. This change was made based on consumer input, said Miller, and streamlines the process of service delivery throughout an individual's life.

"We've been across the state meeting with people we serve, their families, advocates and providers, and the waivers were written with their comments in mind," said Miller. "The waivers provide increased choice and flexibility to purchase the services and supports individuals need and want."

This official public comment period provides yet another important opportunity for input to Nebraska's Waiver services for people with developmental disabilities, said Miller. The next step after the 30-day comment period is submitting them to the federal Centers for Medicare and Medicaid Services (CMS) for approval.

## Nebraska Timeline

BY THE NEBRASKA STATE HISTORICAL SOCIETY

### Coal Thieves

The advent of winter at one time prompted many Nebraska householders to lay in a supply of coal. Those who lacked the money sometimes found creative ways to fill the family coal bin.

From Lincoln's Daily State Journal of January 27, 1878: "A successful raid was made upon the coal thieves frequenting the [Lincoln railroad] depot night before last. Ever since last fall our dealers have been missing from one to three tons per night taken from loaded cars standing upon the track.

"The loss was so heavy and the stealing becoming greater and greater, the coal dealers had a meeting a few evenings since and decided to employ three watchmen to watch their property for one night, if the scheme worked, put them on duty from night to night as the occasion demanded.

"Night before last was their first night on duty and before daylight the next morning four of the thieves were caught in the act with the coal on their backs and some three or four that had visited the cars and were in the act of helping themselves when they discovered the watchman.

"Mr. Gillespie, one of the watchmen, overhauled a Bohemian who was lugging off a chunk that did not weigh less than 200 pounds. Every one that was found with coal, declared that it was their first attempt at stealing. The dealers inform us that at least fifteen families living about the depot have not purchased a pound of coal since last summer, and yet nice little piles may be found in their houses and at the back doors.

"One man who had filled a sack, when stopped, said he had been purchasing his coal from Mr. Shaw. When that gentleman examined his books it was found that the thief had purchased a quarter of a ton last August, and no other dealer in the city had sold him a pound since that time.

"Those arrested were compelled to return the coal to the car, and their names taken. Yesterday morning they were sent for and all save one put in an appearance, declaring their innocence of habitual stealing and offering to compromise the matter.

"The coal dealers in a body, together with the special watchmen, were guarding their property last night, and we presume will gather in a few more [thieves]. An example, it is thought, will be made of the guilty ones to-morrow."

"There are so many immediate and long-term health benefits when someone stops using tobacco," said Dr. Tom Williams, Director of Public Health and Chief Medical Officer for the DHHS. "Within 20 minutes of smoking your last cigarette, your heart rate and blood pressure drop. Within two to three months, your lung function increases and after a year of living tobacco free, the

excess risk of coronary heart disease is half that of a continuing smoker, not to mention the long-term decreased risk of lung and other cancers. I hope all Nebraskans who want to quit will call the Nebraska Tobacco Quitline."

More than 2,100 Nebraskans registered for Quitline services in 2015. Here's what callers have said about the Quitline experience:

# Nebraska Timeline

## Christmas at Ft. Robinson, 1882

Fort Robinson provides the following holiday story of devotion and courage. It can be found in "A Frontier Army Christmas," a new book published by the Nebraska State Historical Society.

Martin J. Weber, an old soldier, remembered: "December 1882, then a corporal in Troop H, Fifth Cavalry, I was ordered to report to the quartermaster at Fort Sidney, the nearest railroad point, to get the Christmas goods for the Fort. A driver and a six mule team were detailed for the purpose."

Weber carried out his orders and headed back to Fort Robinson. "The weather had turned cold and frost began to fly through the air indicating a storm. The next morning the storm broke in all its fury, a regular blizzard raging. We had to head into the storm. We made Camp Clarke

where the Sidney-Black Hills Trail crossed the North Platte River.

"The bridge tender and his wife advised us to stay until the storm passed. As much as we disliked to leave the snug quarters and hot meals, we bid them goodbye and headed into the storm.

"We got to the Running Water stage station the night of the 23rd. Here we had hay for mules and horses and a warm place to cook our supper. How good that hot coffee tasted. It gave us new life and courage for the last twenty miles of our journey.

"The stage had broken the trail to the top of Breakneck Hill; the storm had passed, the fort only five miles away. We got safely down the Breakneck, crossed White Clay Creek, and broke trail across the valley, arriving at the fort on the 24th.

"When I passed the officers' quarters, the kiddies were all out running up and down the walks. When they saw me, they began to shout, 'The Christmas wagon has come!' Hearing them the officers and men came out. They could hardly believe it until the teamster drove his six weary mules up and we began to unload the Christmas goods. Even the officers were willing to help.

"So old Santa arrived, and there was a Merry Christmas after all had given up hope of seeing either. I was snow blind and had to wear dark glasses for some time after that. One year later I was promoted to first sergeant of Troop H."
