Public school test scores released

The Nebraska Department of Education has released information and statewide assessment scores on the Nebraska Education Profile (NEP).

Highlights include the performance of students by district and school in English language arts; mathematics; science; and the ACT as well as performance by groups of students, including race and ethnicity, poverty, special education and English Language Learners.

The NEP is intended to help inform the public and school officials about school district performance and to provide data needed for sound decision-making by education leaders.

The NEP includes results for the new English Language Arts (ELA) assessment, a more rigorous assessment with higher expectations for college and career readiness.

Over the next few years, Nebraska's Accountability for a Quality Education System, Today and Tomorrow (AQuESTT) will demonstrate progress toward state goals, increase college and career readiness, and improve the quality of educational opportunities for students across the state.

Furthermore, NDE will be announcing the Nebraska Student-Centered Assessment System (NSCAS) early next year, aimed at preparing students for success in postsecondary education, career, and civic life.

Parents received a report on their child's scores from their local school district earlier this fall.

LB840 discussed in meeting

The Hebron City Council encourages the public to ask questions when it comes to The Local Option Municipal Economic Development Act or LB840.

The council held a public hearing Nov. 29 to inform approximately 23 business owners and others about LB840 and its contingent plans for downtown Hebron.

The council has completed four steps needed for the Act — strategy for general community and economic development; prepare the proposed plan; hold a public hearing; and adopt the plan by resolution.

Respondents of a community-wide survey for 2016-2017 rallied strong for business development, incentives and revitalizing the downtown area.

Councilman Kurk Wiedel used a downtown city block in Belleville as an example of what can happen to empty buildings.

"The whole block was in bad shape and a lot of the building owners didn't live in Belleville," Wiedel said.

The city tore the entire block down at a cost of \$250,000.

"The city administrator said it was worth it," Wiedel said. "Towns everywhere are facing the same thing. Buildings are not taken care of."

Business start-ups, expansions, recruitment processes and successions are covered by LB840 that uses a portion of sales tax revenue for projects.

Taxes are not raised through LB840.

"This is not a new tax, rather, it is a way to utilize current sales tax to improve economic development," Councilman Tim Pickering said, as he walked those in attendance through LB840 via a slide show.

Complaint filed alleging negligence

The Estate of Verna Miller, who was once a resident of Blue Valley Lutheran Homes, is listed as the plaintiff in a complaint against the Homes and Prime Time Healthcare.

The complaint alleges Fuller, then 72, died from injuries because she was improperly positioned in the Hoyer lift in December of 2015, and dropped over four feet to the floor.

Fuller was admitted to Blue Valley in August of 2013 for multiple illnesses and was unable to care for herself. The plaintiffs believe Blue Valley contracted with Prime Time to provide nursing assistants, along with medication aides and other licensed and unlicensed medical caregivers.

From the fall, Fuller suffered an inoperable right displaced femur and hip fracture and closed head injury. Her trauma included contusions and abrasions and infections. She died in April of 2016.

Listed in the complaint is #330,952.93 in medical care and expenses and \$14,817 for Fuller's funeral and cemetery marker.

The estate is also asking special damages and loss of services, comfort and companionship to Fuller's next of kin, be incurred.

Snowball Drop a hit in Hebron



It was the second year for the Snowball Drop during Hebron's Christmas Stroll Sunday and it seemed the crowd waiting for the city to drop ping pong balls for prizes was larger this year. A total of 94 prizes, ranging from footballs to candy, miniature tractors to puzzles and books and basketballs, were donated by several businesses. Five more prizes of \$15 gift certificates to the Majestic Theater were also distributed. Three bicycles were donated by Norder Supply, Inc., Hebron Dental and Hebron Sports Shack. Winners were Kaya Howland of Chester and Aden Jacobe and Brynn Marsh of Hebron. At Blue Valley Bowl, where free bowling was an afternoon feature of the Stroll, about 50 children took advantage. The caroling as the Thayer County Courthouse lights were lit also drew people with representation from several Hebron churches.

Wenskes encourage trade school

Wenske Repair in Byron is one example of how a vocational education pays off.

Owner Tim Wenske received his training at Southeast Community College-Milford in the Chrysler Apprentice program and graduated in 1998. After working at a couple of Dodge dealerships, Wenske bought his first shop in 2001 in downtown Byron.

Thirteen years later, Wenske expanded from a three-bay shop to an 8,500 square foot building up the street on a patch of cornfield.

"I had more work than I could get done. We were limited to three cars in there and I could only have one employee," Wenske said. "We decided to go big."

Big meant four lifts with another going in soon and a semi lift that can hoist 53,000 pounds of steel.

Wenske Repair follows the farm

economy and stays busy before and after planting and the harvest. Parts are shipped in daily from Hebron, Deshler, Fairbury, Sutton and Blair. Tires come from Lincoln and Omaha.

Although Wenske trained in the Chrysler program, his shop offers all around repairs and service. Two of his employees also graduated from vocational programs in general automotive and diesel technology programs. Their training gives the shop flexibility.

"We work on every make and model," Wenske said.

The business also keeps as many parts as possible because it is in a rural area, Kara Wenske said. She came to work for her husband about six months after the new building was constructed.

"There isn't much we don't do," Wenske said, referring to their

ability to produce custom-made exhaust pipes.

The shop stocks new tires, services air conditioning systems and is in step with automotive technology, such as using a remote-controlled tire pressure monitor.

"It was a real learning curve to see what we needed. We want to make sure our guys have the equipment they need to do the job," Kara said.

And that goes for the high school students Wenske Repair hires in the summer. The Wenskes make it a point to give one or two students a summer automotive experience.

Since the expansion, the Wenskes have had the space to take students in who learn hands-on what it's like to work in an automotive environment.

120 Years Ago

Balm in Gilead: Mr. Erwin has moved his barn from the railroad right-of-way, and built it on a somewhat larger scale on a lot across the street from his residence... An infant son of John Bodtke was buried last week at the Lutheran cemetery east of Gilead... The German M.E. Brethren are to hold Thanksgiving services in their new rooms in the long building in Gilead.

Belvidere Blossoms: Revival meetings are in progress at the M. E. church... The infant son of Mr. and Mrs. Wm. Bartlett died last Tuesday... After the services last Sunday night at the M.E. church, John Barber and Miss Ora Lovercheck were married. Rev. Wilcox of Hebron tied the knot.

Davenport: Mr. Dutton informs us that he was out on his farm last Sunday and there learned that the rats had become so numerous that they were killing the young pigs... A train load, consisting of 25 double decked cars, of sheep, in all 6,600 head, passed through our city yesterday, enroute to Marysville, Kansas, where they will be fed. They were shipped from Oregon... D.W. Wonderly has sold his stock of hardware to H. Ritzen and will retire from business.

Hubbell: The matched race between Paddy Butler and Spiketail came off last Saturday as advertised. Quite a crowd was at the track to witness the race. There was no monkey business about the start, the horses getting off in the first trial. Spiketail took the lead at the start and kept it, coming down the stretch an easy winner... E. Brashear discovered a possum in his chicken house Sunday night. He caught the animal and Monday morning brought it to town. "Tobe" Welch bought it off him and that night several of the "boys" enjoyed a possum roast.

Chester: Henry Rieke is going to fly high in the future, as he has just completed a brand new house and received yesterday a brand new buggy. Prosperity seems to have struck him hard.

Alexandria: Died, Nov. 14, of diphtheria, Gertrude Anne, daughter of Mr. and Mrs. J. C. Pluss, aged 11 years, 8 months and 19 days... Died, Artie Weisel, son of Mr. and Ms. George Weisel, of diphtheria, Nov. 16th.

1907

110 Years Ago

This seems to be an era of unrest with many local changes imminent.

It is rumored that the Bell Telephone Co. are stringing extra wires to Hebron from Fairmont and that a bucket-shop will be established at this place.

J. L. Stafford, who has so successfully conducted the south side grocery and meat market, has sold his business to J. A. Simpson, trading for Mr. Simpson's farm northeast of town. Mr. Stafford has been a steady and systematic advertiser, and consequently has enjoyed remarkably fine trade.

Many Hebron friends were shocked to learn of the death of John Scoville, at Diller, Tuesday morning. He had been at Sycamore Springs, Kan., about a week for treatment. He returned Monday evening, feeling improved, but died during the night.

On Halloween night, a man at Hubbell became intoxicated and stabbed his wife three times, and then attempted suicide by cutting his own throat. Dr. Wilcox sewed up the wound in his throat and phoned for the sheriff. He is reported to be a capable and quiet citizen when not under the influence of liquor. Up to the time of going to press,

we have not learned of his wife's condition.

Dr. Charles F. Bunker recently took the rigid examination for assistant surgeon of the navy. Dr. Bunker received first place, which is a great honor for so young a man, and he now holds the appointment of assistant surgeon, first in line of promotion, and is assigned to naval hospital work at Washington, D.C.

Married: Mr. Clayton Wade, of Warwick, Kan., and Miss Avada Craig, of Hardy, Nebr., on Oct. 24, 1907, at Judge Skinner's office... On Oct. 30, 1907, Judge Skinner united Mr. Loren C. Christiansen and Miss Katie Nelson, of Ruskin... The marriage of Mr. Earl L. Kerns and Miss Gracie E. John occurred on Oct. 27 at the home of the bride's parents, Mr. and Mrs. S. John, three and one-half miles south of Hebron.

The gentleman members of the D.F. club at Gilead entertained their wives last Wednesday evening at the home of Dr. J. L. Magill, and demonstrated their ability in the culinary art by preparing the repast.

It is reported that a flowing well has been struck east of the electric-light plant, the water flowing from a pipe about three feet above ground.

Owing to the financial scare in the east, the attendance at both the cattle and horse sale of O. P. Hendershot's was poorly attended by breeders, throughout the state, although the inquiry for catalogues from breeders was very large. Considering the quality of this offering, both in cattle and mares, they certainly sold cheap, and O. P. says his loss is the other fellow's gain.

Judge Charles Lobingier, of the court of first instance, Philippine Islands, formerly of Hebron, departs next week for his station at Manila, after an extended visit with his wife, at the home of his parents, Judge and Mrs. Lobingier of Lincoln.

100 Years Ago

90 Years Ago

80 Years Ago

(The Alexandria Argus) A history of the First Baptist Church of Alexandria, also known as the First Baptist Church of Thayer County, is printed in this issue of The Alexandria Argus. The history was written by Max Griffin. The church record starts July 21, 1872.

(The Bruning Banner) While engaged at shelling corn at his farm Monday, Harry Dittmers got his mitten entangled in the belt and drew his hand into the machine and before the machine could be stopped, it had severed the little finger of his right hand and otherwise badly bruised the hand. The accident was caused by the wearing of a double thumb mitten, leaving the vacant stall protruding. Henry received medical aid at once and the wound is now healing minus one finger.

1947

70 Years Ago

(The Bruning Banner) A freezing rain which began falling last Wednesday evening brought about 1 1/2 inches of moisture to Bruning by Thursday afternoon. Freezing temperatures caused a sheeting of ice to form on everything exposed to the elements. Driving was brought to a near standstill by the treacherous condition of the roads. The worst ever seen by old-timers, the ice coating was two inches thick in many places. Telephone and electric lines and trees suffered great damage from the weight of the ice. Bruning was without power from 1:30 a.m. to 5:00 p.m. Snow began falling here Tuesday morning, and as we go to press about four inches covers the ground.

Irvin Slepicka was sworn into the regular Army Air Force at Omaha last Friday. Re-enlisting as a Staff Sergeant, he is now stationed at the Kearney Army Air Field, where he reported for duty on Monday.

According to the Fairbury Journal, the Meridian post office was discontinued in November, 1883.

1967


50 Years Ago

According to a study conducted by BusinessWeek.com in conjunction with national real estate researcher On Board, Davenport is one of the top 50 communities in the U.S. rated as great places to raise children.

Among several updates

and improvements to the local law enforcement center 911 system, probably the most anticipated improvement is the newly established cell phone tracking system. "We can now plot where callers with cell phones are calling from," said LEC dispatcher Kay Eickman. "Of all the updates, it's the best." Eickman says the system will also locate police cruisers due to a camera that reads longitude and latitude inside the vehicles. "It's basically a GPS system," she said. "The officer can tell us what their position is and we can bring it up on our maps and let them know if they are close to an emergency call or not." That makes it a pretty handy device, especially when emergency situations happen at night on unlit county roads.

Thayer County Sheriff David Lee was pleased with the low number of serious driving hazards during the Department's annual Click It or Ticket mobilization in November. Five officers, working 95 hours, issued 102 citations and 61 warnings during the overtime activity. "We only had one DWI and on MIP," he said. "I was glad those numbers weren't any higher." Traffic officers issued 13 citations and two warnings for seatbelt violations during the event. Speeding citations number 82, by far the most numer-

ous of all violations. Single citations were also issued for driving under suspension and violation of the child passenger safety law. One arrest on an outstanding warrant was also made.

A community meeting in Bruning spawned the idea for a new library for the local township. The current library is housed in the Bruning Opera House and is only open on Saturday mornings or by appointment with the librarian. According to a recent news release from longtime resident and chairman of the project, Frank Bruning, the "Life-long Learning Center" is hoped to offer a place to all ages for reference and inspirational reading, technology to keep up with a rapidly changing world, a place for youth who have an interest in reading and a place for adults to read and interact with each other.

Preliminary deer harvest higher than last year

Preliminary deer harvest in Nebraska is three percent ahead of last year's pace. From Sept. 1 through Nov. 30, there were 49,923 deer checked, compared to 48,633 in 2016.

Mule deer buck harvest has increased for the fourth consecutive year, with 8,609 taken, compared to 8,499 in 2016. "This bodes well for Nebraska, as mule deer buck harvest in 2016 was the highest on record," said Kit Hams, big game program manager for the Nebraska Game and Parks Commission. "The average age of bucks is also very good, with 49 percent of bucks estimated at age three or older."

Whitetail buck harvest is up four percent in 2017 with 26,489 adult whitetail bucks harvested compared to 25,314 in 2016. The average age of bucks declined slightly, with 33 percent of

whitetail bucks estimated at age three or older.

Biologists also collected lymph nodes for chronic wasting disease (CWD) testing from more than 1,200 deer in Panhandle and southwest units. Results should be available by the end of December. Game and Parks will only notify a hunter if his or her deer tested positive for CWD.

Archery and muzzleloader seasons close Dec. 31. The late antlerless season ends Jan. 15.

Hunters are reminded that mule deer does are protected in many management units and public lands across the state. Refer to the 2017 Big Game Guide for details.

Hunters who wish to donate venison can use the Hunters Helping the Hungry and Deer Exchange programs. Goto OutdoorNebraska.org for more details.

Roofs collapsing, vultures, debris, falling bricks and other issues plague downtown Hebron, which eventually impacts values and remains unattractive to new business owners.

"We're going to look at businesses," Wiedel said. "We do have the right to look at the city's responsibility, take care of those issues and make sure everyone is protected."

Wiedel is also concerned about fires in uninsured buildings and homes for rent that have mold.

"It is offensive to the senses, the boarded up and patched windows," Councilwoman Denese Sudbeck said.

Randy Hergott said the price goes up when someone might want to buy the properties.

"Why do people own properties and not do anything with them?" Hergott asked.

Sudbeck added the Cattleman's Ball is coming.

"Why do I feel bad about asking someone to clean up their mess?" she said.

"We are going to get pretty tough with it," Wiedel said.

Councilman Robert Dodes said he owns one of those boarded up buildings.

"We bought it five years ago with the intent we didn't want to see it become what it has become," Dodes said.

"We offered free rent to start a business. The offer still stands, but I am ashamed it is what it is."

Councilman Larry Fangmeier said the council would like input from the community on nuisance properties.

"What makes those decisions easier is how many people that property impacts," he said.

Blue Valley Bowl owner, Dale Klaumann, said he's glad the council is monitoring nuisances.

"I commend the city council for what they've done in Hebron," Klaumann said.

"The clean up is huge." Sales tax revenue was originally designated for capital improvements.

"We've done that," Wiedel said.

Sales tax has been used for infrastructure, parks, tax relief and community improvements in general. Sales tax was not used for the Stastny Community Center, however, the council was able to provide some relief in property taxes.

"Since sales tax, you've been able to do so many things — the ballfields and porch swing — we left the door open to do all these things," Wiedel said.

In the preliminary proposed annual budget for LB840 for Hebron, one-third of sales tax would be used each year. That amounts to approximately \$60,000. The proposed plan is for 15 years.

Sutton was used as an example of how successful LB840 can be. The city began the program in 2005 and since, it has assisted 19 businesses, impacted employees, either retained or new, influenced employee salaries estimated at a value of \$5.9 million and made \$6,000 a month in loan repayments.

One-third of the sales tax revenue is a direct ratio to the percentage of revenue, Fangmeier said.

"Please come and talk to us," Wiedel said. "I can't think of any reason why this is not positive for our community," Wiedel said.

A vote will most likely take place next year. If LB840 passes, the city will enact the program by law and appoint a citizen advisory review committee, which will have to periodically report to the council. No city council member is eligible for the committee.

The city will also need to establish an economic development fund and regulate meetings, public hearings and annual audits.



In the matter of Schneider v. United States, Civil Action No. 8.99-CV-0315, a federal court in Nebraska has ruled that the United States is liable, in some circumstances, for a taking of private property rights underlying, or adjacent to, certain railroad rights of way in the State of Nebraska, and this taking is compensable under the Fifth Amendment of the U.S. Constitution. The Court has recently determined that the class action should now be decertified, effective on January 16, 2018. The Court has also determined that affected property owners must decide whether to pursue a financial recovery as individual plaintiffs in the action.

Who Is Included?

A detailed notice, and other supporting documents, are available for review at the website www.NebraskaTrailSettlements.com, and they can help you determine if you are affected. Generally, you may be eligible if you or your predecessor in title owned property between 1993 - 1999, next to or over which a railroad company had a right of way that is now used as a recreational trail in the following counties in Nebraska: Douglas, Otoe, Nemaha, Dawes, Sioux, Saunders, Butler, Sarpy, Madison, Antelope, Holt, Rock, Brown, Cherry, Sheridan, Buffalo, Saline, Thayer, Clay, Fillmore, Nuckolls, Webster, Lancaster, Jefferson and Gage.

If You Are Included, What Can You Do?

The Court had previously certified a class of all persons who own an interest in land constituting a railroad corridor in the State of Nebraska, and which is now occupied or controlled for trail use

pursuant to the National Trails System Act, and who have been damaged in the amount of \$10,000 or less by being deprived of their rights to possession, control, and enjoyment of their land as a result of a Trail Use Order, or who waive claims exceeding \$10,000.

Now that the class is being decertified, if you wish to individually enforce your affected property rights, you must join the Schneider action (or file a separate case with your own counsel) and you must do so promptly. If you fail to join the Schneider case, your claim will be dismissed from that case and you will receive no financial compensation in that matter.

How Much Could You Get?

Payments will be based on the appraised value of the taking up to a limit of \$10,000 per claim. Payment will also include interest.

How Do You Get A Payment?

You must submit a joinder form to be included as a party in the case and potentially qualify for payment. The joinder form can be accessed via the website, or can be requested by contacting plaintiffs' counsel as noted below. The joinder form must be submitted by fax, e-mail or mail no later than January 11, 2018.
