## DeJong guilty of murder...

A 12-person jury found Susan DeJong, 55, guilty of first degree murder Monday afternoon in Jefferson County District Court. Judge Paul Korsland accepted the verdict and scheduled DeJong's sentencing for May 3 at 11 a.m. She faces life in prison.

DeJong is guilty of beating her husband Thomas DeJong to death. Evidence in the trial indicated the couple had a long history of domestic abuse - Susan DeJong often gave excuses for Thomas' injuries.

Thomas was found not breathing March 11, 2011, in the DeJong home located two miles east of the Jefferson County/Thayer County border. He was badly beaten. Rescue workers were able to revive him, but he died later at the Jefferson County Hospital. Susan DeJong, who called 911 and said Thomas was hurt and not breathing, was arrested the next morning.

#### Police arrest Thomas...

Thomas W. Charles, 57, Hebron, was arrested Friday night after threatening to kill another individual. Thayer County Deputy Sheriff John M. Hensel made the arrest after being dispatched to 1225 Lincoln Ave., in Hebron.

According to the arrest affidavit on file at the Thayer County Courthouse, Thomas threatened another man using a knife and verbally saying he wanted to kill him.

Hensen said Thomas became combative during the arrest and later at the jail and was transported to "Cornhusker Place," a detox center.

Thomas, who is currently in jail in Hebron on a \$250,000/10 percent bond is charged with three felonies including assault of a police officer, terroristic threats, and use of a deadly weapon to commit a felony.

# Leaping

As most Nebraskans know, tornadoes are some of the most deadly storms on earth. Known to form in every month of the year, here in the Heartland, springtime proves to be the most prevalent. As warm moist air from the Gulf of Mexico moves north across the Great Plains, cool dry air makes its way south from Canada. When and where the two meet and mix it up determines the potential

for a dangerous tempest. There's really no stopping the formation of twisters, but there is a way to warn people of impending danger. Nearly every town that sits in tornado alley, a swath that runs through the middle of the United States, has warning sirens and storm spotters to make the public aware of oncoming storms.

Recently, storm spotter training requirements became more refined with the passage of legislative bill #573. Part of the bill is requiring more complete training for storm spotters including online tests and proof of passage. Prior requirements generally meant attending an annual meeting sponsored through emergency management. The meeting is still required although spotters will only need to attend once every three years, but now they must complete two online classes and pass an assessment.

Thayer County Emergency Manager Bill McPherson said release of the change is a little early in that he

# It's Leap Day

It's Leap Day and as far as we can tell, we've only been able to publish on this day, Wednesday, Feb. 29, three times in the Hebron Journal-Register's 141 year history. There were years we think the newspaper was published on Thursdays, but if we stick with the Wednesday publication we were able hit the stands on Leap Day in the years 1928, 1956, and 1984. Now we can add 2012 for an even four times, which seems to be the magical number when it comes to Leap Day and Leap Year.

Ancient Egyptians were the first to figure out that the solar year and the man-made calendar year didn't always match up, but it was the Romans who, after taking the idea from the Egyptians, officially added the extra day to the Julian calendar. Rounding the calculation of the Earth's movement around the Sun to 365.25 days, Romans added the extra day to the month of February every four years.

That worked for about 1,500 years, until a more precise formula, which we use today, was adopted in the 16th century under the Gregorian calendar. Some countries did not leap to the Gregorian calendar as quickly as others and it would be another 200 years before everyone was indeed on the same page. Italy,

Portugal, Spain and Poland were the first to switch over and did so by dropping ten days from October in the year 1582. Great Britain, including the American colonies, did not switch to the Gregorian calendar until 1752, and by then, had to drop 11 days out of October to bring the calendar into sync with the astronomical year. Sweden, intending to switch in 1700, did not have a leap day for this year, which was correct, but they forgot to observe the leap days in 1704 and 1708 which put them out of sync with both the Julian and Gregorian calendars. In order to correct the mistake they had a double leap day in 1712, creating the unique day of Feb. 30. That put them back on track with the Julian calendar, but it would be another 40 years before the Swedes would complete the change over to the Gregorian calendar by dropping 10 days in February to get in sync.

Under Gregorian calendar rule, leap years are determined by adding an extra day to February in years that are divisible by four; however, a calculated stipulation stating that no year divisible by 100 would have a leap year, except if it was divisible by 400. Thus, the year 1600 was a leap year, but 1700, 1800, and 1900 were not. Under this rule, we can expect to have a leap year every four years until we make it to 2100, which will not include a February 29.

The additional day allows us to take a look at the importance of the body's most valuable muscle, the heart. Kylea Hintz, a 14year-old teen from Hebron, found out last year that her heart wasn't as strong as she thought. Through a twist of fate that started with a sore wrist, the young daughter of Rick and Ranae Hintz would soon come to know more than most teens the importance and value of a healthy heart. Following is her story, a story she wants to share in the hopes that it may bring comfort to anyone facing a broken heart.

# 'To Mend My Broken Heart'

For Kylea Hintz, an average junior high student who was getting ready for summer vacation, life can change at the drop of a hat. "If someone were to ask me what I was going to do for the summer of 2011," she explains, "I would have said I really don't know. I have no major plans. But, it is amazing how one day, or even 30 minutes, can change the rest of your life.'

Kylea, who was 13 years old at the time, found out two weeks before finishing the seventh grade that she had a coarctation of the aorta; not something most young teens would understand. "It means my aorta, which carries the main supply of blood to the body, was pinched," she said, "and my doctor told me I needed heart surgery right away.

genital heart defect that happens when there is a narrowing of the aorta as it makes the turn to supply blood to the lower part of the body. The narrowing is usually located just after the takeoff of the left subclavian

The left heart pump (ventricle) has to pump harder to force the blood to get through the narrowed area in order to supply the abdomen and legs with enough blood. With time the left ventricle muscle becomes thicker. The blood pressure gets higher, so has to push the blood across the narrowed area and as the blood squeezes through the obstructed area, it scatters under high pressure into strong jets; most of which move the blood forward, but others hit hard against the walls of the aorta. Since so much moving energy is wasted in trying to force the blood through, the pressure beyond the narrowed area itself will be low.

In youth, this action leads to high pressure in the arms and low pressure in the legs. High pressure in the arms transmits to high pressure to the arteries going to the brain and if

started. Kylea's journey to the cardiologist started eight months earlier in the fall of 2010 with a sore wrist, hardly a clue that would eventually lead to a congenital heart defect. She complained to her mother that her left wrist hurt when she played volleyball. "We taped it and gave her Tylenol," Ranae said, "and Kylea toughed it out until basketball started. Then she couldn't take the pain anymore.

An ensuing doctor's appointment led Kylea to physical therapy for a month, but little improvement there prompted a visit to an orthopedic specialist. There she was diagnosed with Kienbock's disease, a condition in which one of eight small carpal bones in the wrist loses its blood supply and begins to die. Interestingly enough, Kienbock's disease is most common in men between the ages of 20 and 40, not 13-year-old girls starting their junior high sports careers. "They put me in a cast for two months and a brace after that," Kylea said. "In March (2011) when we went back to the orthopedist, he said my case was strange and wanted

# **My Thoughts Exactly**

Waiting for that special beau to pop the question? Wait no longer, ladies, for this is a day you are officially "allowed" to do the asking yourself. February 29 only comes around every four years, so once it's gone, you'll have to wait until 2016.

The tradition started in 5th century Ireland when St. Bridget complained to St. Patrick about women having to wait for men to propose. St. Patrick finally relented and set aside Feb. 29 as the day allowing women the right to ask for a man's hand

The tradition continued in Scotland when in 1288, Queen Margaret declared that Feb. 29 was the official day for women to pop the question. Additionally, men who rejected a woman's proposal were faced with a fine in the form of a kiss, silk dress

In America, the leap day tradition is often confused with Sadie Hawkins Day; however, while Leap Day is Feb. 29, Sadie Hawkins Day is always in November.

Sadie Hawkins Day was created when, after waiting years for a suitor to come a-callin' with no luck, Sadie went out and, with the help of her father, got one. Sadie was the creation of Al Capp in the Li'l Abner comic strip and Sadie Hawkins Day was first introduced in the strip Nov. 15, 1937. She was the daughter of Hekzebiah Hawkins and considered the "homeliest gal in all them hills." When she reached the age of 35, Hekzebiah became concerned that she would never get married and would be living at home the rest of her life, so he called together all the unmarried men of Dogpatch and declared it "Sadie Hawkins Day."

'When ah fires [my gun], all o' yo' kin start a-runnin! When ah fires agin-after givin' yo' a fair start-Sadie starts a-runnin'. Th' one she ketches'll be her husbin.

The town spinsters decided this was such a good idea, they made Sadie Hawkins Day a mandatory yearly event. If a woman caught a bachelor and dragged him, kicking and screaming, across the finish line before sundown, by law he had to marry her.

Two years after Capp's introduction of the special day, which always occurred in November, Life Magazine issued a two-page spread proclaiming "On Sadie Hawkins Day, Girls Chase Boys in 201 Colleges." The annual event spread across the nation and by 1952, Sadie Hawkins Day was celebrated in over 40,000 known venues on the Saturday that followed November 9.

While the two days celebrate the same premise, women taking the aggressive role by asking men on dates, to dance, or to "git hitched," Leap Day, Feb. 29, remains the more accepted tradition around the world.

# **Priefert Angus Recognized**

Priefert Angus, Belvidere, has been recognized nationally by the American Angus Association for having five registered Angus cows included in the Association's 2012 Pathfinder Report.

Only 2,027 of the nearly 30,000 American Angus Association members are represented in this year's report, according to Bill Bowman, chief operating officer and director of performance programs of the Association with headquarters in Saint Joseph,

The Pathfinder program identifies superior Angus cows based upon recorded performance traits economically important to efficient beef production. These traits include early and regular calving and heavy weaning weights, Bowman says. Over 1.9 million eligible dams and more than 6.5 million weaning records were examined to determine Pathfinder status.

All registered Angus cows that meet the strict Pathfinder standards are listed, along with their owners, in the Pathfinder Report that is published annually by the Association.

The 2012 Pathfinder Report lists 8,761 individual cows and 231 Pathfinder sires. It is published online at www. angus.org, and printed copies are available from the Association. The largest number of Pathfinder cows from a single herd this year is 74.

Started in 1978, the Pathfinder Program continues to recognize outstanding breeders participating in the Angus Herd Improvement Records (AHIR) Program.



#### **Link Between Diet, Exercise** And Sleep

For years, we have been told to eat better and exercise more. Despite lifestyle changes, many of us still feel burned out, can't drop those extra pounds, and don't seem to have enough energy. This may be because the missing component is we need more sleep.

Sleep rejuvenates the body and mind and getting adequate sleep is necessary for the body to function properly. Sleep regulates mood and is related to learning and memory functions. It helps your mind perform better and may be a critical factor in your health, weight and energy level.

An estimated 18 million Americans have sleep apnea, a sleep-related breathing disorder that leads individuals to repeatedly stop breathing during sleep. Sleep apnea seriously affects one's quality of sleep, and can also lead to health risks such as stroke, heart attack, congestive heart failure and excessive daytime sleepiness.

Sleep apnea is associated with people overweight because excess weight often causes this compromised respiratory function. Unfortunately, losing weight in a healthy manner can take time, so it is important to treat sleep apnea first and then add exercise to your routine. People feel restored when they are effectively treated for sleep apnea and this allows them to be more successful when starting an exercise program.

Sleep deprivation may also inhibit one's ability to lose weight-even while exercising and eating well. A 1999 study at the University of Chicago showed that restricting sleep to just four hours per night for a week brought healthy young adults to the point where some had the glucose and insulin characteristics of diabetics. Such sleep restriction may have been a bit extreme, but it is not uncommon in our society and is a pattern the study also found often leads to obesity.

Research shows exercise is good for one's overall health, but properly timing exercise is necessary too. For example, a good workout makes you more alert, speeds up your metabolism and energizes you for the day ahead, but exercise right before bedtime can lead to a poor night's sleep.

Experts recommend exercising at least three hours **Thayer County Health News** 



before bedtime. Exercising earlier in the day is beneficial because body temperature is related to sleep. Body temperatures rise during exercise and may take up to six hours to drop. Because cooler body temperatures are associated with sleep onset, it's important to allow the body time to cool off before going to sleep.

If you need a cup of java in the morning or an afternoon cola, you may also be creating another vicious cycle. The more tired you are, the more caffeine you consume, but the more caffeine you consume, the harder it is to sleep at night. Food and drinks high in caffeine may keep you up at night and their sugar or artificial sugar has no health benefits. This means you are at a higher risk to put on weight and not sustain your energy level.

For individuals who suffer from acid reflux, diet and sleep go hand-in-hand. According to studies, these individuals often suffer from nighttime heartburn, which may lead to sleep problems such as insomnia, sleep apnea, daytime sleepiness and restless leg syndrome.

Food is also related to sleep by appetite and metabolism. Research shows that people who don't get enough sleep are more likely to have bigger appetites. This link between appetite and sleep provides further evidence that sleep and obesity are linked.

Understanding your health is very complex – but one thing we do know is that if one area of the body suffers, you will likely see consequences in other areas. Though diet and exercise are critical components, sleep is also inherently linked to how much we eat and how we function daily. Getting the proper amount of sleep will help you on the road to good fitness, good diet and good health.

educating parents, teachers and students on safe walking/ biking practices, and on the health benefits of increased physical activity.

The project began in January of this year with monthly challenges and events to encourage physical activity through the winter months.

During the month of February, elementary students have had opportunity to participate in three "Walk Wednesdays" events before school. Students were encouraged to bundle up and walk to school on these mornings or arrive 30 minutes prior to the start of the school day to walk.

Participating students received weekly incentives to encourage participation. Week one participants received heart tokens since February is National Heart Month; week two participants were awarded heart safety lights; week three participants received packages of silly bands for their efforts.

As we approach spring, the project will host a kick off event in cooperation with the local Parent Involvement Group (PIG) at Thayer Central. A walking map of the Hebron community will be developed over the course of the project and highlight safe routes to the school. From this pocket-sized tool, a parent,

child, or community member

could plan a number of safe 10,000 step walking routes in their communities. Childhood obesity rates

have more than tripled in the past 30 years while the number of children walking and biking to school has declined. According to the 2001 National Household Travel Survey, less than 16 percent of students between the ages of 5 and 15 walked or biked to or from school, compared to 42 percent in 1969.

The Safe Routes to School Nebraska program provides schools and community groups with the funding they need to address safety issues to and from school. These improvements include engineering solutions as well as safety training, awareness and strategies to encourage children to get the exercise they need to lead happy, healthy lives.

understands the assessment has not been made available "Right now all spotter duties in Thayer County are conducted by local law enforcement and fire department personnel; experienced people who have been trained," he said. "I have a lot of faith in

them.'

Passage of the bill is to allow for more accurate information. There have been times in the past when tornadoes were incorrectly identified, or locations were scrambled. More in-depth education is thought to bring more accurate information to the National Weather Service and emergency management thereby improving the ability to pass warnings on to the general public.

One class provides practice in relaying information properly and succinctly through multiple storm scenarios. It also teaches what constitutes a storm and how to maintain safety during spotting condi-

The second class teaches storm identification and each of the parts of a severe storm, in other words, the class goes into depth about the make-up of storms and what the spotter needs to look for in order to

storm. Lists of those filling the spotter requirements will be made available to emergency management and local law enforcement. Emergency responders, such as law enforcement and volunteer firefighters are currently considered to be storm spotters and will not

have to take the classes. The county saw a milder than usual winter with dry conditions and somewhat warm temperatures, which in no way indicates a potentially stormy spring. Unfortunately for some, the tornado season has already begun; two people were killed by separate twisters in Alabama in January. And although Thayer County continues to have severe weather each spring, there has not been a tornado touch down in the last three seasons.

Severe weather awareness is set to begin as usual in March. This year, McPherson said, the annual weather awareness presentation will be held Thursday, March 1 at the Bruning Opera House in Bruning, at 6:30 p.m. The public is invited to attend. Nebraska Severe Weather Week is March 19-23.



# **Byron Community Begins Foundation Fund**

Most of us who live in rural Nebraska have made a deliberate choice to stay in these small towns we call home. Despite the current trend of rural populations making their way to the city, we "smalltown folks" believe that our small communities will continue to offer the positive way of life for our children and grandchildren that we have enjoyed. The newly-formed Byron Community Foundation Fund is an illustration of that belief.

With considerable help from the Nebraska Community Foundation, this new fund was established in July 2011 as an affiliated fund under the Nebraska Community Foundation. An advisory committee was formed to manage the fund, and members include Tobe Duensing, Jeremy Heitmann, Layne Hoops, Eldon Kirchhoff, Melissa Kuhlmann, Jaye Moeller, and Laura Tuma.

The focus of the Byron Community Foundation Fund is to raise money for the betterment of the Byron community with money received through tax-deductible donations. The BCF Fund held its kickoff meeting at the Byron schoolhouse Nov. 19. Members of the community and surrounding areas were invited to attend the meeting to learn about the establishment of the fund and its purpose.

The first goal for the BCF Fund is to build a community center. Preliminary plans would place the facility where the current dilapidated Byron Community Building is located on the south end of main street.

The new community center would include an event room capable of handling community gathering and a smaller meeting room geared towards club and organization meetings and family functions. It would also include a kitchen and a library, and final plans may include a fitness room. The current fund-raising goal for the community building is set at \$1 million.

Along with the fund-raising goal for the building, the BCF Fund has set a goal to raise \$500,000 for an endowment which would support the new facility. This endowment would use interest earned off of principal funds to support operation and maintenance for the community center. Combining the building and the endowment, the total project goal is \$1.5 million.

The Byron Community Foundation Fund is off to a great start with more than \$410,000 already received

There will be a "Founders' Club" for all who donate \$1,000 or more within the next four years. And last, but certainly not least, there will be a donor wall where the names of every person who donates to the construction of the community center or the endowment, regardless of the amount, will be listed.

Fund-raising is currently underway, and individuals connected with Byron may be contacted in the near future by established fund-raising committees to consider gifting to the Byron Community Center project. The Byron Community Foundation Fund greatly appreciates the support they have already received with this endeavor and welcomes contributions of any size.





Thayer Central ends its season on a 10-12 record and will lose only one senior, Brayden Hergott, to graduation this year.









me to see another doctor." In the meantime, Rick and Ranae appealed to the Shriners Hospital in Minneapolis where a pediatrician found a heart murmur and thyroid dysfunction. From there Kylea was sent to cardiologist Ameeta B. Martin of Lincoln who, after conducting an echocardiogram, determined Kylea's pinched aorta. "Dr. Martin said it was a miracle that the pediatrician at Shriners Hospital even heard the murmur," added Kylea. "With my hypothyroidism (underactive thyroid), the murmur was

very quiet.' On the first day of summer vacation, May 20, Dr. James M. Hammel of Children's Hospital in Omaha, performed closed heart surgery on Kylea. "He told me closed heart surgery meant the place my heart needed to be fixed was on the outside and that he would go in through my back around my shoulder blade," she explained and added that this condition, not normally seen in teens, is often caught and corrected in infants at birth. Dr. Hammel told her she could have been one of those seemingly healthy athletes who just drop dead from a heart attack and that if her condition had gone undetected or untreated, she quite possibly may have not lived to see her 20th birthday.

Kylea said at that point she was scared, but that the nurses were very kind and her family and friends threw her a pre-surgery party at the hotel to ease her mind. There was also a special prayer service at the Methodist church in Hebron where several friends and family members gathered. Kylea said the prayers were definitely felt and answered.

"The surgery lasted seven hours," Kylea said, "but it felt like two seconds to me. My mom told me that watching me go down the hallway to surgery was the hardest thing

she ever had to do.' Kylea said her aorta had become completely blocked which Dr. Hammel discovered during surgery. "He said we were really lucky to have caught it when we did and that the only way blood was getting to the lower part of my body was through bypasses that my body had created on its own," she said. "It was amazing to me that my body could do that."

Dr. Hammel removed approximately two inches of her aorta and replaced it with artificial aorta. If the condition had been caught and corrected at birth, the surgeon would have cut out the obstruction and stretched the remaining aorta connecting it back together enabling the aorta to grow with the body. The artificial aorta cannot grow so at some point may need to be replaced if it cannot support the blood flow needed.

In all, Kylea stayed three days in ICU, one day on the recovery floor and one day in the Children's Rainbow House before heading home. Following a slight setback due to dehydration on her third day grow in the next four months, would need more testing,' Kylea explained.

And now that her heart and thyroid were stabilized, it was again time to concentrate on her wrist. "So we went back to Shriners Hospital where I had a great check-up," she said. "I had twice the movement in my wrist than before and the doctor's think that my problem was maybe tied to my heart and thyroid.'

A final echocardiogram on her heart a week after her visit to the Shriners Hospital showed minimal fluid on her heart and she was released to do as she pleased with some summer time limitations. "I couldn't play ball or ride my horse at the fair, but after twelve weeks I had a sweet scar and a fixed heart."

Today Kylea is nearing the end of a very productive and active eighth grade year and although she is well aware that her disease is genetic and may show its face again one day, she very much wants to be there for others who may suffer from the same problems. She shares her story "To Mend My Broken Heart," through a scrapbook journal as a way of showing her appreciation for the special people in her life that supported her and her family through their difficult summer. "I hope the rest of my

home, Kylea began to heal and in three weeks went back to Dr. Martin for a check-up. Also during that time, the young teen needed to get a handle on her hypothyroidism and was scheduled to see an endocrinologist. "She, Dr. Cabrera, said my numbers were looking good now that I was taking levothyroxine, but if I didn't
