#### Learning Center to hold family farm class

The Southeast Community College Learning Center in Hebron will hold "Passing the Farm to the Next Generation" Feb. 21 from 1 to 3 p.m.

The session may be interesting to those who have a farmstead in the family.

"Each passing generation is more removed from the farm than the previous one," Allan Vyhnalek, extension educator and instructor of the class, said. "Farmland is now passing to adults that either never lived on the farm or are 35 to 50 years removed from the farm. The structure of farming fundamentally changed over that period of time."

# Election season underway

Thayer County is gearing up for the 2018 mid-term season as election commissioner and county clerk, Marie Rauner, compiles the list for city and county offices, and school boards.

New candidates have until March 1 to file. Incumbents for village offices and Class II school boards have until July 15 — new candidates must file by Aug. 1. Class II school filings are for Bruning and Davenport.

Additional offices with the July 15 and Aug. 1 deadlines are the Public Power District and County Weed Control Authority.

The City of Hebron's May ballot will carry LB840, the Local Municipal Option Sales Tax that takes a portion of city sales tax and earmarks it for economic development. Voters will decide if LB840 is adopted with a yes or no vote

For contested races, there are two filings for Mayor of Hebron with incumbent Shane Day and new filer, Douglas Huber and there are four candidates, Tim Pickering, Larry Fangmeier, Robert Dodes and Kyle Timmerman, for Hebron City Council with three open seats.

As of Monday, no one had filed for Mayor of Deshler.

New candidate, Amy Peterson, is the only filer for the county assessor's position. Rauner, who said she wouldn't run again for county clerk, decided to file again. New terms for county offices begin in January of 2019.

# Bowman works the family farm

Lenny Bowman considers himself a lucky man.

The Bruning native is farming his grandparents' land near Belvidere.

"After college, I came back. I was lucky enough none of my uncles came back, so I was last one who had interest in it," Bowman said.

Bowman has 40 acres of the original farmstead and rents 600 acres of Dill family land. He averages around 50 fall cows (50 pair) and farms about 1,000 acres of corn, beans and alfalfa.

- Bowman raises or buys heifers to integrate them and become mothers. He also houses and feeds cows for friends.

He said his grandparents' home place was left to him because he promised to keep it as is, and that includes his grandfather's pinkpainted home.

"It's very important to keep it in the family," he said.

Bowman is set to be the 2018 th

"Our main objective is the promotion of beef, raising money for the local FFA and 4-H groups," he said.

Bowman said funds raised by the Feeders are divied up between the groups and scholarships, and other side projects.

# Ag society penalized

The Nebraska Liquor Control Commission suspended Thayer County Ag Society's liquor license for 10 days from March 25 until April 5 with the option to pay a \$500 fine in lieu of closing. A listing on the liquor commission's names March 26 until April 4, however, the order is from March 25 to April 5.

The liquor commission found the Ag Society responsible for permitting open containers of alcohol for the purpose of consumption after 2:15 a.m. July 22.

That was Saturday, the evening Abby Uecker, 25, performed at the Thayer County Fair with her band. Approximately two hours later than the time named by the liquor commission, Uecker died after being pinned underneath a UTV rollbar on the fair's racetrack.

Thayer County Attorney Dan Werner ruled her death an accident nearly three months later. He said alcohol couldn't be ruled as a factor in the accident because witnesses weren't tested for alcohol and there was a delay in the investigation immediately following Uecker's death.

"I actually wanted to prosecute," he said during a press conference on Uecker. He calves the first of September and brings in replacement heifers Thayer County Livestock Feeders President. It is his first time serving as president. He has been a member of the Feeders for 12 years and on the board for seven. He is a member of the Bruning

# Murray testifies in support of bill

In Hebron attorney Ben Murray's letter to the Nebraska Legislature judiciary committee on Legislative Bill 776, he wrote what happens when a person is arrested:


"Their lives screech to a halt. They are being prosecuted by the State of Nebraska, with all of its vast resources; they are dealing with prosecutors who overcharge them in order to pressure them into plea agreements; they are stuck in county jails that are, for the most part, disgusting; they are asked to post bonds that they cannot afford; so they are stuck in these jails for the entirety of their cases; and then after all of this has piled up, they are appointed an attorney, usually me, and asked to trust me with their lives as we take on the State. The least we can give them is access to an unrecorded telephone so I can help them try to make their way through the system."

It is the last line Murray summarized for the committee Jan. 18 as he recalled the 59 telephone calls recorded by the Hall County Department of Corrections between he and his client, Jerry Foster, who was charged with sexual assault of a child in Nuckolls County in December of 2014. Foster also violated a child in Clay County, for which he was eventually sentenced to 23 to 25 years in prison.

American Civil Liberties Union Attorney Amy Miller asked Murray to testify on the bill, introduced by Sen. John McCollister. The bill specifies calls between inmates and their attorneys would be free of charge and prohibits monitoring or recording those calls.

Murray discovered the recorded telephone calls, but not until after

## 1888 **130 Years Ago**

The infant son of Mr. and Mrs. J. M. Fitchpatrick, aged eight months, died about 2 o'clock a.m. Wednesday, Feb 1, after a short sickness.

Manager Malowney has received word from Chester that arrangements were being made to run a special train to Hebron and return, during the night of Feb. 7th, to enable from thirty-five to forty Chester people to attend the Mikado.

Ithamer Pugh is plowing today south of Hebron. He is the first farmer in these parts who has commenced farming in 1888.

Replying to a circular from the state superintendent relative to the heroism of school teachers during the recent blizzard, County Superintendent F. M. Gallanty writes as following concerning Thayer county teacher: None of our number perished during the storm. There were some teachers, however, that suffered very much in trying to help the children to a place of safety. Some of the noted instances are Williams Barnes, Reynolds, Neb.; Ira Beaver, Reynolds, Neb.; Ollie M. Moss and Anna Usher, Hubbell. This lady narrowly escaped freezing. Julia Ellison, Hebron; This lady also suffered greatly during the storm. There were other teachers who saved or aided in saving their pupils' lives, but I have no knowledge further than I have given you. No children perished.

She set the bucket down and turned to go in the house, when the boy slipped on some ice and fell backward into the bucket. At this time, the boy is in a dangerous condition... L. P. Luce was 70 years old yesterday and his wife perpetrated a surprise on him. He left the house in the morning and came down town, where he remained until nearly noon. When he went home, he found the house full of people, his children (with the exception of Mrs. Laura Roper, Oscar and Marie) and their children, were present.

Belvidere: On last Thursday night some unknown parties entered G. W. Avard's hardware store and stole a good supply of jewelry and pocket knives. From there they went to the office of the Belvidere Lumber Co., but they did not succeed in getting anything there. This is undoubtedly the work of home talent and our citizens should not cease until the guilty ones are brought to justice.

## 1928 90 Years Ago

Mrs. Herman Meyer of Hubbell passed away very suddenly on Jan. 3rd, aged 42 years, four months and 27 days. The remains were laid to rest in the Lutheran cemetery near Hubbell.

Deyo Bower of Fairbury, who found a tiny bronze relic on Rose Creek, south of Fairbury, last spring, has been informed by the State Historical Society and the Smithsonian Institution at Washington, D.C., that experts report that without a doubt it was a relic of the fifteenth century. It is believed by historians to have belonged to the Coronado expedition, which explored Nebraska territory in 1541. It can also identify behaviors or conditions which increase your risk for certain diseases and may determine if you need to modify behaviors. Your doctor can help you be proactive about your health.

During an annual exam, your doctor may order blood tests and other tests to help in determining if you have any unforeseen health issues, such as vitamin deficiencies, hormonal imbalances, neurological issues, etc. These exams are important to maintain good health and identify any issues early.

The cost for annual physicals and lab tests are covered under wellness on most insurance policies. However, if they aren't covered, the cost may end up being very expense. To help patients with the cost, many hospitals offer reduced price lab events. These events are held as a benefit to the community and as a way to improve the overall health of the communities they serve.

The following are a list of lab tests that may be part of a reduced priced lab event:

A complete blood count (CBC) is a test that gives important information about the kinds and numbers of cells in the blood, especially red blood cells, white blood cells and platelets. A CBC helps your doctor check any symptoms, such as weakness, fatigue, or bruising, you may have. A CBC also helps in diagnosing conditions, such as anemia, infection and many other disorders.

A comprehensive metabolic panel (CMP) is a blood test that measures your sugar (glucose) level, electrolyte and fluid balance, kidney function and liver function. A lipid panel is a blood



test that measures lipids-fats and fatty substances used as a source of energy by your body. Lipids include cholesterol, triglycerides, highdensity lipoprotein (HDL), and low-density lipoprotein (LDL). The different kinds of cholesterol and other fats in your blood are together called lipids. Doctors measure and diagnose lipid problems with this simple blood test.

A thyroid-stimulating hormone (TSH) blood test is used to check for thyroid gland problems. TSH is produced when the hypothalamus releases a substance called thyrotropin-releasing hormone (TRH). TRH then triggers the pituitary gland to release TSH. TSH causes the thyroid gland to make two hormones: triiodothyronine (T3) and thyroxine (T4). T3 and T4 help control your body's metabolism.

A lab test called HgbA1C, also called glycated hemoglobin, is used in monitoring a patient with Diabetes or it may help in diagnosing Diabetes. This test is an indicator of how well a person has been managing their glucose level over the last two to three months.

For men, a PSA screening will help in determining their prostate health. This test is used to screen for prostate cancer.

AVitamin D test measures the level of a specific form of vitamin D in your blood. Abnormal levels of vitamin D can indicate bone disorder, nutrition problems, organ damage or other medical conditions.



# Influenza activity still widespread in Nebraska

Although Nebraska continues to have widespread flu activity, both the number of positive tests and the number of people hospitalized with flu were decreased last week. In addition, according to Public Health Solutions, the number of cases caused by influenza A viruses is decreasing, while the number of cases caused by influenza B is rising. Influenza B usually causes milder illness.

While some states and big cities have experienced shortages of the anti-viral medication Tamiflu, overall, this has not been a problem within the PHS district. While a handful of pharmacies reported some delays in getting the generic, liquid form of Tamiflu, (oseltamivir), all reported having an adequate supply of either generic or name-brand Tamiflu capsules on their shelves.

According to disease surveillance nurse, Kate Lange,



#### "It's still a good idea to call your pharmacy to make sure they have your prescribed anti-viral medication available before you drive to the store, and if your pharmacy doesn't have what you need, you may need to contact other area pharmacies in the area to get your prescription filled.'

Tamiflu is most effective when started within 48 hours of getting flu symptoms. It may be used to treat flu in people two weeks of age and older. It's also used to prevent flu in people age one year and older, who are at increased risk for death from flu and who have been exposed to the virus.

Tamiflu's most common side effects are nausea, vomiting, diarrhea, and headache. As with any prescription medication, it is important to take Tamiflu as prescribed until it is all gone.



#### Notice to All Great Plains Communications Customers

Assistance for Qualifying Low-Income Customers: The Nebraska Telecommunications Assistance Program (NTAP) can provide reduced rates on monthly charges for basic telephone or Internet service to qualified low-income subscribers. To be eligible, you must participate in one of the following: Medicaid, Food Stamps, Supplemental Security Income (SSI), Federal Housing Assistance, Low Income Home Energy Assistance Program, or the Kids Connection (SAM, MAC or EMAC).



Assistance for Qualifying Customers on Tribal Land: The FCC can also provide assistance to low income customers on tribal lands for federal telephone assistance. This assistance provides a discounted amount per primary connection for qualifying tribal residents. The FCC requires that all qualifying low-income individuals living on tribal land pay a minimum monthly rate of \$1.00 for basic local telephone service or a discount on your Internet service. This program also allows for assistance on service connection charges.

Qualifying Great Plains Communications customers living on tribal land would receive a discount on their telephone bill that would reduce the basic local service rate to \$1.00 per month or a discount on their Internet service. The connection charge would be waived up to \$70. If you believe that you gualify, please call Great Plains Communications toll free at 1-888-343-8014 to request an enrollment form or contact your local Bureau of Indian Affairs office.
