Tournament to help takes place Saturday

Good news — Bridgette Baden is planning to attend a fundraiser scheduled for her this weekend.

"When I first found out, I was in complete shock. It just really helps bring me up and get out of here sooner," Baden, 21, said from her hospital room last week, where she is recovering from a July 9 collision involving a suspected drunk driver.

Saturday at 9 a.m., sand volleyball competitors will descend on Hebron Sports and Rec Complex for pool play before filling out a bracket.

"We're also going to have a hamburger and brat feed," Megan Bulin, one of the organizers, said. "You don't have to play. You can come and eat."

There is a fee to play in the coed tournament of four to six players per team. The tournament will raise funds for Baden's medical expenses.

Bulin and Baden haven't hung out much since graduating from Thayer Central High School. They went their separate ways through education with Baden at the University of Nebraska-Lincoln and Bulin in the Bryan College of Health Sciences.

But Bulin sprung into action when she heard about the midnight accident on Highway 81.

And Rhiannon Svitek set up a gofundme page to raise \$5,000. As of Monday, the fund totaled \$5,125 after it was posted 15 days earlier.

Michaela Marsh pitched in, too, to set the pool play and bracket.

NuStar Energy will take the heat to grill for the meal funded by a \$500 NuStar grant.

"My goal is to be out by then to watch them play," Baden said. "It's really cool and shows how supportive a small town is."

Baden was in the back seat of the vehicle. Brittany Walburn, 24, was driving and Jordan Bragg, 29, was Walburn's passenger.

The three were together that day, spending time in Davenport, Walburn's hometown. Walburn and

Baden are best friends and Walburn is dating Bragg.

"From Jordan's and my perspective, there were no front lights on," Walburn said of the other vehicle, driven by Louis Sanna, 26, of Geneva. "It was almost like hitting a wall because it was dark. There was no way we could have seen it."

Walburn said Baden was flown to Lincoln via a rescue helicopter. She was supposed to go, but inclement weather prevented the trip.

While Bragg was bruised with a cut and bump on his head, the accident caused Walburn to break her humerus bone, fracture a couple of fingers and sustain a concussion.

Two plates and 20 screws later, Walburn said everyday tasks, such

as opening a shampoo bottle, are difficult.

"It's been a rocky road. With the hand, it makes it really hard," she said. Her hand could take up to a year to heal, she added.

Last week, Baden was in rehabilitation at Bryan Medical Center West in Lincoln.

Her sister, Chelsea said she was in a wheelchair and a cast.

"It's hard for us to see what she's going through, seeing her in that much pain," she said.

Baden was in the intensive care unit for a week, on a breathing tube for three days, but after the fourth day, she was eating whole foods.

"She is doing amazing," Bulin said of her friend, who had two plates

and 14 screws in her left arm and couldn't operate crutches because of it. Baden also had road rash on most of her body.

She was ejected from the vehicle as it spun three times into the median and then rolled several times.

"She was in shape and very athletic. It didn't stop her a whole lot," Bulin said.

Chelsea said Baden participated in all four sports as a high school student.

"So far, it's gone tremendous. I am young and in good shape and shocked to see some of my wounds heal as quick as they have," Baden said.

Walburn said she is also planning on watching the tournament, an event Bulin calls, "small town love."

College asks taxpayers to vote \$369 million in

The Southeast Community College Board voted 10-1 to place a \$369 million bond issue on the Nov. 8 ballot for 15 counties, including Thayer.

Replacement, renovation and addition of facilities is planned for the Lincoln, Milford and Beatrice campuses, plus the addition of a campus near downtown Lincoln and the construction and acquisition of facilities for Learning Centers in various sites.

Hebron was selected by SCC as a Learning Center site and officials are

planning to use the former Thayer Central Public Schools primary building.

The official ballot question is as follows:

"Shall the Southeast Community College Area, in the State of Nebraska, issue its general obligation bonds in an aggregate state principal amount not to exceed Three Hundred Sixty-nine Million Dollars (\$369,000,000), for the purpose of providing funds for the purchase, construction, reconstruction, equipping, demolition, and alternation

of various properties, building facilities and other capital assets for the College Area, which may include the following: 1. Replacement, renovation, and addition of facilities on the Beatrice Campus; 2. Replacement, renovation and addition of facilities on the Milford Campus; 3. Replacement, renovation and addition of facilities on the 8800 O Street Lincoln Campus; 4. Establishment of a campus in or near downtown Lincoln; and 5. Construction and acquisition of facilities for use as Learning Centers on various

sites within the College Area; with such bonds to be issued from time to time, to bear interest at such rate or rates, to be sold at such prices and to become due at such time or times as may be fixed by, or determined at the direction of, the Board of Governors of Southeast Community College Area cause to be levied and collected annually a special levy of taxes against all the taxable property in the College Area sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"

Benefit for Meridian student coming in August

A benefit is planned for Jasmine Daniels, a sophomore at Meridian Public School.

Daniels was diagnosed with Ewing's Sarcoma in early June.

Ewing's Sarcoma is a rare cancer and less than 1,000 cases are diagnosed each year. It usually affects children and young adults.

The "Never Lose Hope - Team Jasmine" benefit is scheduled for

Aug. 7 in the Meridian School commons and gymnasium areas.

A meal will be served from 4:30 to 7 p.m. The silent auction begins at 4:30 p.m. and runs until 7 p.m. when the live auction commences.

Freewill donations are welcome and proceeds will assist the family with medical bills.

The school and Jefferson County Bank in Daykin is accepting mon-

etary donations.

Daniels began chemotherapy treatments June 17 after two months of visits to the doctor because of pain and swelling in the upper area of her left calf. Daniels was in track when the swelling began.

At first, she was told the swelling was a pulled muscle. She was instructed to ice and elevate the calf, but the pain and swelling increased as the month wore on.

On May 16, Daniels returned to the doctor, who thought she might have a blood clot.

She started antibiotics and steroids for an infection, and on May 28, Daniels went to an emergency room in Lincoln because she was running a fever and in uncontrollable pain.

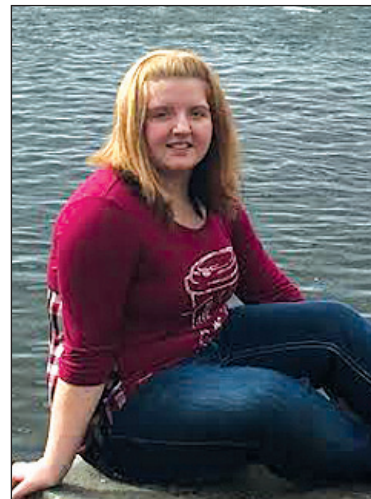
There, she underwent a CT scan and was referred to an orthopedic surgeon, who sent Daniels to the University of Nebraska Medical Center in Omaha, where she met with an orthopedic cancer surgeon June 2.

The surgeon advised Daniels the CT scan had revealed a mass that looked like bone cancer.

The next day, Daniels had a biopsy and by June 9, she was diagnosed with Ewing's.

The cancer was in her left leg and affected her fibula bone, and possibly lymph nodes in her groin area.

The family then had a bone marrow biopsy, and an infusaport was put in

Daniels to begin chemotherapy. She returned to UNMC June 17 for her first treatment.

The family reported the first few weeks of June were overwhelming and scary with trips to Omaha for appointments, lab draws and intravenous antibiotics at Fillmore County Hospital in Geneva.

Daniels goes to the hospital twice a week for draws and Omaha every two weeks for three to five days at a time while she undergoes chemotherapy treatments with five different drugs and other drugs to protect her heart, kidneys and bladder.

Drugs used to treat Ewing's have

1886

130 Years Ago

Belvidere is booming. Scrapers for the Rock Island work in Jefferson County were unloaded at Endicott last week.

W. D. Church is building a livery barn in Chester to be occupied by Wilkinson & Lindsey who were burned out two weeks ago.

S. H. Coon has sold his jewelry store to J. A. Crook of North Bend, this state, who is occupying a portion of the drug store.

We caution our readers to be on the lookout for traveling frauds. Support home institutions and then if wronged, you can obtain redress.

As will be seen by his new advertisement in this issue, A. E. Hunt of Belvidere has commenced business as a land, loan and insurance agent.

An irate brother pursued his sister's beau the other night and beat him over the head with a club.

Wild grapes are beginning to ripen.

Work has revived upon the brick buildings which had been suspended for a few days on account of a want of brick.

It is said the surveyors of the Kansas City, Wyandotte & Northwestern Railroad reached Hubbell last Saturday.

D. G. Ruby is putting an addition on the south side of his livery barn, which will accommodate about 18 horse.

J. L. Lopping, of Gilead precinct, harvested this year 285 bushels of oats from six acres or an average of 47 1/2 bushels to the acre.

J. D. Dodge has bought the book and newspaper business of Headington & Green and the latter has purchased the cigar business of the former.

The hope of the Nebraska farmer is in stock raising. Send your corn to market on foot in the shape of fat hogs and cattle and the Nebraska farmer will realize handsome profits for his labor.

We understand that arrangements are being made to start a paper at Belvidere. This will make seven papers in the county. Several parties are rather looking to that point, and it is not known yet who the future editor is to be.

Albert Huntsman, of Chicago, has contracted for the purchase of S. H. Coon's drug stock. The trade is not yet consummated, but will probably be closed up during the week. Mr. Coon will enjoy a rest after his 12 years constant application to business.

The Prohibition convention convened at the courthouse as per announcement on Saturday. There was a small attendance, only three precincts being represented: Hebron, Chester and Alexandria.

The musical and elocutionary entertainment given by the Fairfield College troupe Monday evening was attended by an appreciative audience.

Hon. C. H. Willard, State Treasurer, has been here for several days attending to business matters and visiting old friends.

During a recent visit to the farm of Otis T. Johnson near Belvidere, we were much impressed with its pleasant appearance and the many improvements he has made within the short space of seven years.

On Wednesday morning about a quarter past 12 as Dr. Bristol was returning home from the opera house, he observed a bright light in the lodge room of the building

jointly owned by Masons and the Odd Fellows' lodges here. At first he supposed the light was part of the ceremonies of one of the secret orders occupying the building, but he finally concluded to go nearer and listen as it impressed him strongly something was wrong. On getting closed to the building he distinctly heard the crackling of the flames, and at once gave the alarm by calling out "fire," as loud as he could. The cry was taken up at once from different parts of the town and in a short time a crowd appeared on the scene with buckets and hose, and the fire company came with their engine and ladder truck. After the crowd had gathered, the fire bell on the engine house was rung. On entering the lodge room it was found to be full of smoke and a desk and the organ was found very hot, and lath was discovered on fire in one place. Had the alarm been given a few moments later, the upper story would have been wrapped in flames. If the old ball-game maxim, "three times and out," applies in such cases, the next time this building catches on fire it will go, as this is the second time.

1896

120 Years Ago

O. P. Hendershot, the alfalfa grower is already harvesting his second crop for this season.

W. E. Benjamin has started a canvas for students to organize an academy in the City of Hebron, which will open about Sept. 7. Location will be announced later. Mr. Benjamin is a graduate of the Fremont normal school, and is thoroughly qualified to give instruction in the ranches which may be taken up in the academy.

Mr. and Mrs. Wm. Griffin entertained about 40 young people last evening in honor of their niece, Miss Bertha Taylor of Blair. The lawn was decorated with Chinese lanterns and the house and photograph gallery were beautifully decorated. Dancing was the order of the evening. At a late hour, refreshments were served, each guest receiving a dainty bouquet souvenir.

Last Tuesday Hebron received the heaviest rain in the history of the city, 3.17 inches of rain falling during the night. The streets were flooded, and the Sixth Street where grading has been done, was a torrent of water. On Sixth Street, between Olive and Lincoln avenues, an immense hole was washed out which will require much labor and expense to fill. On Wednesday morning Glenn Latta was wading in the hole and not realizing the depth of the water he went under. Not being a swimmer, he came very near meeting his death and had already gone under twice before he was finally rescued by Earl Smith and Roy Lockwood. Such a thing as a person near being drowned in one of the main streets of our city is rather astonishing, but in these days of demo-pop craze one need not be surprised at anything.

Balm in Gilead: The Gilead precinct convention was held in Belvidere precinct on Sunday. The program was good, but water was scarce...

S. R. Moss is having his elevator prepared for use. The job seems almost useless, as the building has been surrendered wholly to the rats and the weather for the past three years.

Deshler: The Deshler Manufacturing Co. sent another middlings purifier and separator to the Hebron mill Monday evening. The one for Alexandria will be the next one shipped. Machine repair work has been keeping them busy lately.

Alexandria: The Alexandria drum Corps is at Fairbury today and will take part in the Republican rally this evening.

110 Years Ago

(The Bruning Banner) F. O. Steward erected a 32-foot Dempster mill for Martin Garrels this week on his farm adjoining town.

The Bruning Band has been reorganized and will furnish part of the music for the Home Fair and Market Festival.

1916

100 Years Ago

A. J. Barlow, an aged resident of Belvidere, was struck and mortally injured at 1:30 Wednesday afternoon of last week by a freight train while walking along the tracks of the St. Joseph & Grand Island Railroad near the station in Belvidere.

(The Alexandria Argus) On July 16, some 250 automobiles carrying more than 1,000 people made the first trip up Pikes Peak over the new automobile highway. The Weisel sisters were in the parade. Of the 250 motors which made the trip, about 150 were Studebakers of all sizes and types.

USSEC announces EU approval of three soy events

The U.S. Soybean Export Council (USSEC) is pleased to announce the long awaited European Union approval of three biotech soy traits for import and processing. The three stacked events are:

- Monsanto's Xtend (dicamba x glyphosate MON87708 x MON89788)

- Monsanto's Vistive Gold (high oleic x glyphosate MON87705 x MON89788)

- Bayer CropScience's Balance GT (glyphosate x HPPD inhibitor FG72)

"The EU's approval of these events is welcome news for U.S. soybean farmers," said USSEC chairman Laura Foell, a soybean grower from Schaller, Iowa. "We're happy that we can supply our European customers with a reliable supply of safe food."

Europe is one of the largest customers of U.S. soybean farmers with over 165 million bushels of soybeans in exports already this year.

In 1996, U.S. growers began to adopt biotechnology on their farms. Today, twenty years later, growers are expected to plant 94 percent of their soybean acres with biotech soybeans.

The technology allows U.S. soybean farmers to produce a healthy, affordable protein source sustainably with in-

creased yields on less land, which helps to feed a growing world population.

Biotech seeds allow farmers to limit their impact on the land as they apply fewer pesticides and herbicides, along with employing sustainable practices such as no-till that helps them to achieve a better moisture content in the soil in addition to reducing erosion and cutting carbon dioxide emissions and also helps to reduce energy consumption.

Biotech also reduces the amount of crops that are lost due to variables such as insects or drought, which helps keep food prices more affordable.

About the U.S. Soybean Export Council (USSEC): The U.S. Soybean Export Council aims to maximize the use of U.S. Soy internationally by meeting the needs of global customers that use U.S. Soy in human food and feed for poultry, livestock and fish.

Back-to School Safety

August is designated as Back-to-School Safety Month. Thayer County Health Services along with the American Academy of Pediatrics (AAP) want to remind you that with the start of school just around the corner, we all need to be extra cautious and do our part to keep kids safe.

The following health and safety tips are from the American Academy of Pediatrics (AAP).

Backpack Safety:

- Choose a backpack with wide, padded shoulder straps and a padded back.

- Pack light. The backpack should never weigh more than 10 to 20 percent of your child's body weight.

- Always use both shoulder straps. Slings a backpack over one shoulder can strain muscles.

- If your school allows, consider a rolling backpack. This type of backpack may be a good choice for students who must tote a heavy load.

Car:

- All passengers should wear a seat belt or use an age/size appropriate car safety.

- All children younger than 13 years of age should ride in the rear seat of vehicles.

- Many accidents involve teen drivers. Therefore, you should require seat belt use, limit the number of passengers and not allow eating, drinking, cell phones or other mobile devices.

School Bus Safety:

- Wait for the bus to stop before approaching it from the curb.

- Do not move around on the bus.

- Check to see that no other traffic is coming before crossing the street.

- Make sure to always remain in clear view of the



bus driver.

- Children should always board and exit the bus at locations that provide safe access to the bus or to the school building.

- If your child's school bus has lap/shoulder seat belts, make sure your child uses it.

Bike Safety:

- Always wear a bicycle helmet, no matter how short or long the ride.

- Ride on the right, in the same direction as auto traffic.

- Use appropriate hand signals.

- Respect traffic lights and stop signs.

- Wear bright color clothing to increase visibility.

- Know the "rules of the road."

Walking Safety:

- Make sure your child's walk to a school is a safe route with well-trained adult crossing guards at every intersection.

- Be realistic about your child's pedestrian skills. Because small children are impulsive and less cautious around traffic, carefully consider if your child is ready to walk to school alone.

- Bright colored clothing will make your child more visible to drivers.

- In neighborhoods with higher levels of traffic, consider starting a "walking school bus," in which an adult accompanies a group of neighborhood children walking to school.

At the events, there will be field tours and presentation tents, university presenters and industry consultants. Participants will learn research-based information on marketing and financial outlooks, soybean production, weed management and irrigation management. Attendees may also bring irrigation pressure regulators for testing.

Registration for the events begins at 9 a.m. each day. CCA credits are available for participants.

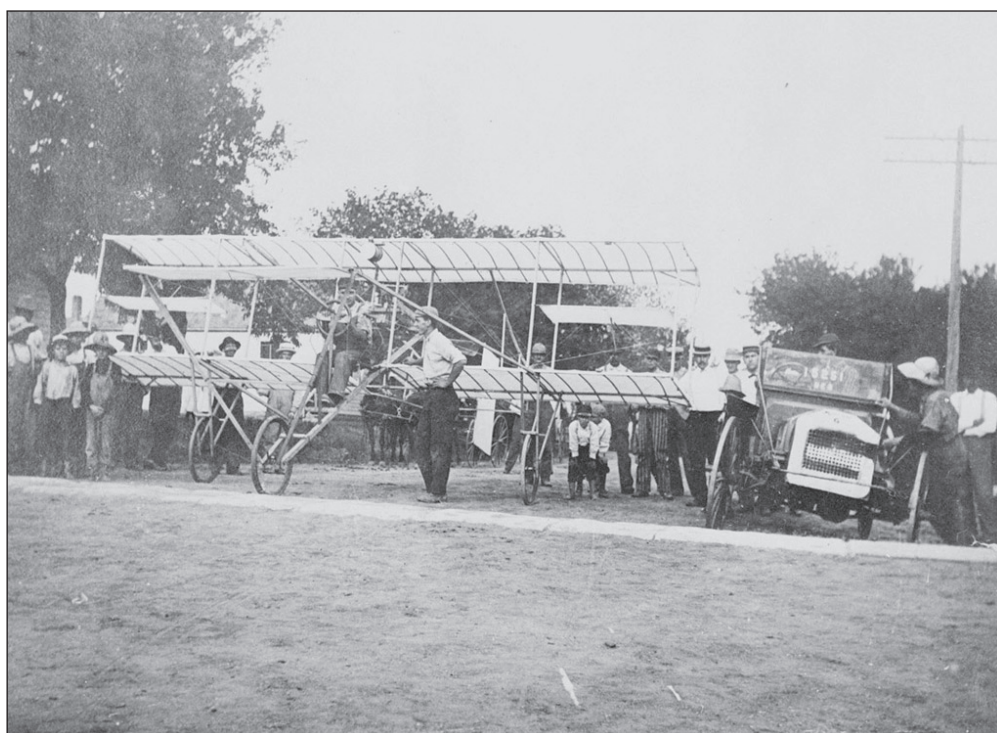

Nebraska Timeline

Flying machines, 1912 and 1964



The Morrow airplane, probably about 1912. NSHS RG 2929PHO-6.

In the summer of 1911, J. A. Morrow and his sons, Everett and Edward, began building an airplane in their Carleton blacksmith shop. Before the craft was finished, the Morrrows moved to Burwell to ply their trade. It was there that the plane first took flight in the fall of 1912. It was a "pusher prop" bi-plane patterned after one developed by Glenn Curtiss in 1910.

As with many early planes, the Morrow craft often crashed during demonstration flights in towns around the state, but it was quickly repaired in time for the next exhibition. The Burwell Tribune recorded many of these episodes in the fall of 1912. While the full story of the Morrrows and their flying machine has not been written, Wings Over Nebraska: Historic Aviation Photographs by Vince Goeres with Kylie Kinley includes a photo of the Morrow plane taken in Opelika, Alabama, in 1913. The book was published by the Nebraska State Historical Society in 2010.

In 1964 Burwell physician

Dr. Ben Meckel, who was also an aviation enthusiast, decided to re-create the Morrow airplane as a tribute to the early fliers. The plane, a copy of the 1910 Curtiss pusher and approximating the aircraft built by the Morrrows, was constructed by John Thurman in Tucson, Arizona. It was delivered in Burwell in early August 1964 and Meckel made his first flight on August 5, after christening the "Spirit of Burwell" with a bottle of champagne. Perhaps more than he expected, Meckel not only duplicated the Morrow's plane but some of their experiences. On its first flight "Spirit of Burwell" barely rose from the runway before losing power and coming down. Meckel was not injured and there was only minor damage to the plane.

In order to get full certification from the Federal Aviation Administration to fly the plane without restrictions, fifty flying hours were required. Meckel began the process by receiving FAA authorization to fly the pusher from Bur-

well to Omaha. Although he arrived safely at Eppley Airfield on November 17, 1964, the trip was not uneventful. After taking off from Burwell November 8, a bent axle forced a two-day stopover in Columbus. On November 10 carburetor icing forced a crash landing near Boys Town. It took several days to make repairs. When Meckel finally landed at Eppley Airfield, the Curtiss pusher was taxied to a stop alongside a Boeing 727 airliner. Meckel's craft weighed 640 pounds with a wingspan of 27 feet and a top speed of 35 miles an hour. By contrast, the passenger jet weighed 142,000 pounds with a cruising speed of 550 to 600 miles an hour.

According to Meckel, as quoted in the Omaha World-Herald, Nov. 18, 1964, "I'm scared every time I take it up." He also noted that he did not wear the traditional long white scarf of the early aviators because he was worried that it might get tangled in the engine or propeller located directly behind the pilot's seat.

Because the single front wheel did not turn, Meckel simply planted his feet and lifted the craft's nose to change direction on the ground. A few years later, according to the 1967 Garfield County centennial history, Meckel sold his plane to Hollywood stunt man Frank Tallman. On Dec. 25, 1977, the Lincoln Star noted that the "Spirit of Burwell" was then on exhibit at the Orange County Airplane Museum in Los Angeles.

Aug. 1 deadline to enroll in ag risk and price loss coverage programs

U.S. Department of Agriculture (USDA) Nebraska Farm Service Agency (FSA) Executive Director Dan Steinkruger reminds farmers and ranchers they have until Aug. 1 to enroll in Agriculture Risk Coverage (ARC) and/or Price Loss Coverage (PLC) programs for the 2016 crop year.

"Producers have already elected ARC or PLC, but they must enroll for the 2016 crop year by signing a contract before the Aug. 1 deadline to receive program benefits," said Steinkruger. "Producers are encouraged to contact their local FSA office to schedule an appointment to enroll."

The programs trigger financial protections for participating agricultural producers when market forces cause substantial drops in crop prices or revenues. Nationwide, more than 1.76 million farmers and ranchers are expected to sign contracts to enroll in ARC or PLC.

Covered commodities under the programs include barley, canola, large and small chickpeas, corn, cranberry, flaxseed, grain sorghum, lentils, mustard seed, oats, peanuts, dry peas, rapeseed, long grain rice, medium grain rice (which includes short grain and sweet rice), safflower seed, sesame, soybeans, sunflower seed and wheat.

side effects that cause hair loss, mouth sores, little appetite, nausea, vomiting, easy bruising and fatigue, and tingling in the hands and feet, along with diarrhea.

Daniels is currently experiencing hair loss, nausea, fatigue and tingling.

She is also due in Omaha once a month for an injection to protect her ovaries. But, Daniels must also have daily injections at home to keep her platelets up and prevent infection.

Ewing's often occurs in the pelvis bones, chest wall and legs.

The cancer is not hereditary.

Symptoms are pain and swelling in the arms or legs,

chest back and pelvis. Fevers, limited range of motion and breaking bones are other effects of Ewing's.

If the cancer is localized and treated, the tumor may shrink before surgery or radiation is needed.

The chemotherapy for Daniels will last eight to 12 weeks before imaging tests will show if the tumor is removable via surgery.

More chemotherapy and radiation would follow the surgery for several more months to kill any remaining cancer cells. Amputation may be necessary.

Her platelet levels will determine if Daniels may start her sophomore year on schedule.



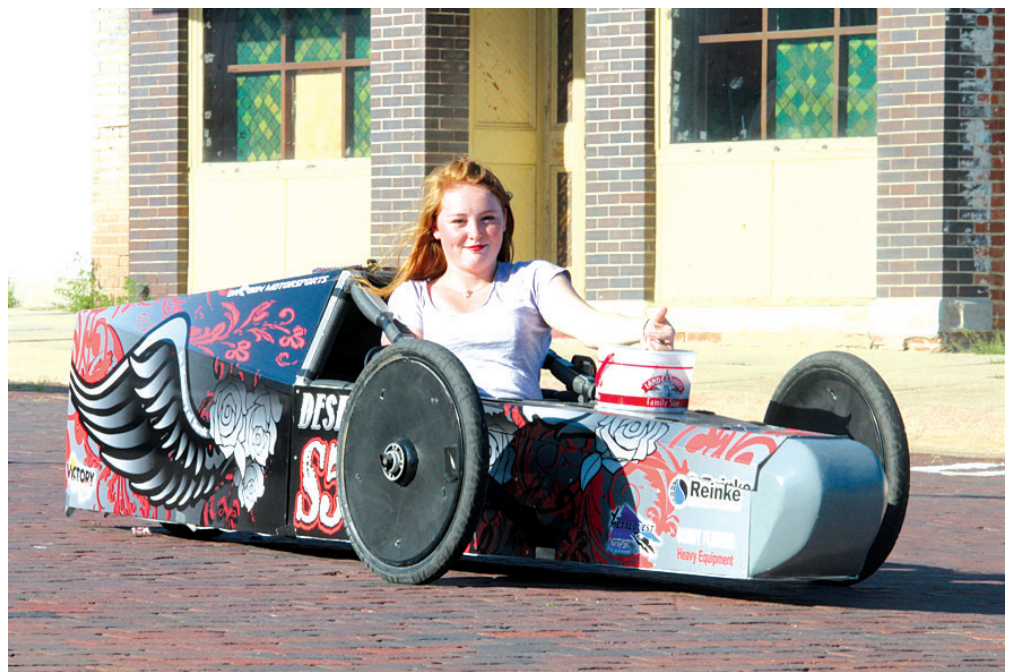
