Sales Tax...

Thayer County collected \$228,187.79 in sales tax for the month of December 2012 after showing a 20.1 percent increase in net taxable sales over December 2011. For December 2012, the county had \$4,148,859 in net taxable sales - up from \$3,455,118 in 2011.

According to Hebron Clerk Jean Nagey, the City of Hebron collected \$19,396.11 in motor vehicle and sales taxes on net taxable sales of \$2.162,250 for the month of December. That shows an increase of 11.3 percent in net taxable sales over December 2011. The motor vehicle tax (\$2,412.03) goes into the street fund, while the remainder tax fund.

The Department of Revenue releases figures approximately three months later than the actual month being profiled. January 2013 figures will be released at the beginning of April.

Area communities will be participating in the annual statewide tornado drill on Wednesday, March 27, as part of 2013 Nebraska Severe Weather Awareness Week activities.

The week-long observance, which runs March 25 to 29, includes the Wednesday drill as a time for residents, businesses and industries to test their severe weather emergency preparedness plans.

The morning drill will begin around 10 a.m. with the issuance of a mock tornado warning and activation of outdoor warning devices (sirens) about 10 to 15 minutes later.

# Commissioners, TCHS board move forward

St. Elizabeth, Catholic Health Initiatives assist in search for new CEO

Strategic planning, increased communication, on-hand leadership, a real concentration on rebuilding trust; these are just some of the issues needing addressed as the Thayer County Health Services Board of Trustees tackle replacing the administrator of the hospital.

Joyce Beck, who had served as CEO since 2004, was relieved of her duties Feb. 20, and now the Board of Trustees is faced with finding a new administrator.

Regional Director of Rural Health through Catholic Health Initiatives, Janelle Ali-Dinar, laid out the list of tasks to Thayer County Commissioners Wednesday morning, Feb. 27. "We also want to find someone to facilitate dialogue," she said during the conference, suggesting a mediator to create synergy among the trustees, commissioners, staff and administrative factions of the hospital and clinic. "We want to find someone (an administrator) who has the specific skills set to fulfill the needs of the hospital. There's a lot to be done."

Ali-Dinar said the process would likely take two months, but a temporary administrator will fill in until a replacement is found adding the temporary CEO would be present at the facility two days a week.

The commissioners also face replacing two hospital board members after Phil Johnson and Reuben Schleifer ended their respective appointments. "Phil's term ended," commission president Dave Bruning said, "and Reuben resigned." Schleifer, who has served on the board for 19 years, jovially said he just turned 92 years old and it was time for him to move in a different, perhaps slower direction.

Commissioner Dean Krueger asked Ali-Dinar what strengths should be noted when looking for someone to fill the trustee positions. She said President Obama's Health Care Reform is currently pushing hospitals in a new direction and suggested someone who is very much up on current events. "Someone who is engaged in the local community, someone who listens and communicates," she said.

The commission also moved to set term limits for trustees. Appointees, serving six year terms, will serve no more than two consecutive terms. The decision takes effect immediately.

The commission asked Schleifer to maintain his position until they found a replacement to which he agreed, but Johnson has vacated his seat. Chris Roth is currently serving as president of the board following Johnson's retreat.

Johnson, before he resigned his position, was included in the vote to dismiss Beck, a vote that was not unanimous. Johnson and Schleifer voted against the measure to dismiss her, while Roth, Harriet Easton and Nancy Hofts voted for the dismissal.

According to minutes from the Feb. 20 meeting, a motion was made by Roth and seconded by Easton that "St. Elizabeth Regional Medical Center shall be notified that the Administrator of Thayer County Health Services shall be replaced in accordance with Section 6.0 of the Administrative Services agreement effective July 1, 2012, by and between St. Elizabeth Regional Medical Center and Thayer County Health Services." Johnson, who was not present at the meeting, stated in an email to Roth that was presented at the meeting, "As it is difficult for me to participate in actions taken, if a proxy vote is possible, please cast my vote for me as not in favor of removing our CEO..." Johnson's vote was accepted by the board and

cast as such. On Feb. 21, Roth communicated to TCHS staff through an email that "the Board of Trustees has met several times over the past several months to discuss the future direction of Thayer County Health Services." He added that the Board sought input from personnel during the process and contracted with an outside independent person "to help us un-

# City struggles with irresponsible dog owners

# Looks to professionals for July firework display

Although there is no real verbiage on what defines an irresponsible dog owner in Hebron, the unwritten understanding among council members is anyone who does not license or vaccinate, pen or leash, clean up waste, or generally care for their pets. Complaints of negligent animal owners continue to flood into the local law enforcement center. Even after hiring a dog catcher and creating a vicious animal ordinance, the City's issue with dogs and their owners continues to escalate.

"Our biggest problem is enforcement," said councilman Robert Dodes. "The rules are good rules, but if they aren't going to be enforced

Mayor Shane Day, speaking on behalf of the LEC, said they receive complaints and immediately call contracted dog catcher Stephanie Willhite, but can never get through. So they leave a message, but by the time she receives it, the dog issue is over especially in the case of stray or loose animals. Aggressive animals are handled by the sheriff's department.

Also at issue is how many animals owners should be allowed to have at one residence inside the city limits. When the city created its vicious dog ordinance members discussed creating a kennel law, but neglected to do so. On Monday night during the regular March council meeting, the issue was re-visited after people from a neighborhood near Seventh St. and Eads Ave., complained about an animal owner harboring several dogs at a neighboring residence. Complaints were that the animals get loose (one even attacked the pet of one of the people representing the neighborhood) and that the owner does not clean up the yard so the odor of dog feces in the neighborhood is rather intense. The animals also bark for several hours a day.

Other residences inside the city limits where several dogs are presearmarked at the meeting as well.

City attorney Joe Murray said the City should have no problem creating a kennel ordinance once they decide how many dogs it takes before an owner would be required to have a kennel license. The council is considering setting a limit of two animals per residence. An ordinance will be drawn up and presented at the April council meeting.

**Fireworks** 

The council's only action item

Monday night was approval to hire Midwest Pyrotechnics, LLC, of Stromsburg, to run the fireworks show at the annual Fourth of July celebration. Company owner Ryan Peterson presented copies of various costs to the council stating his fireworks displays run anywhere from \$3,000-\$8,000 per show. Hebron Fire Department Chief B.J.

Linton said although the department has been in charge of the fireworks display for 25 years, the issue of safety and expense is forcing them to suggest hiring professionals. "Shipping the fireworks alone is costing you nearly \$800," he told the council Monday night. "Also, safety regulations are becoming more stringent and costly."

Linton said he met with Peterson to discuss the professional display outlining what the department has done for the last several years. Peterson, who has been in business since 2008, told the council he thought his company could put on a better show for less money due to his ability to spread his costs over several shows. We went from one show in 2008 to 21 shows last year," he said.

The council voted to contract the pyrotechnic company at a cost of \$5,000, or approximately \$600 under last year's event.







### **March is National Brain Injury Awareness Month**

The purpose of National Brain Injury Awareness Month in March is to help those who suffer from brain injuries tell their stories and raise awareness of the different types of brain injuries. The hope is that with this event more people suffering from brain injury will find help.

Currently there are three categories for brain injuries:

• Traumatic Brain Injury (TBI) - TBI is defined as an alteration in brain function caused by an external force. A traumatic brain injury is when a blow or jolt hits the head hard enough it causes the brain to move within the skull or the skull breaks and the brain is directly hurt. When this happens, the injury disrupts the normal functioning of the brain. Not all head injuries result in brain dysfunction. A traumatic brain injury can result in both short-term and long-term problems that involve impairment.

· Acquired Brain Injury - An acquired brain injury is an injury to the brain, which is not hereditary, congenital, degenerative, or induced by birth trauma. An acquired brain injury is an injury to the brain that has occurred after birth. By definition, any traumatic brain injury is an injury that is non-traumatic (eg, from a motor vehicle accident, stroke, near drowning, or assault).

• Mild Brain Injury - The term "mild brain injury" can be misleading. The term "mild" is used in reference to the severity of the initial physical trauma that caused the injury. It does not indicate the severity of the consequences of the injury. Brain injuries are very com-

plex because no two injuries are the same. How each person will react to the same type of trauma is unknown. The cause, location and severity also are factors in how a person will react to a brain injury. According to the Brain Injury Association of America, approximately 1.4 traumatic brain injuries occur each year. Every 23 seconds someone will suffer from a traumatic brain injury. Out of those injuries, 50,000 people die, 235,000 are hospitalized, and over 1 million are treated and released from the emergency room. It is unknown how many others do not receive medical

assistance.

Men seem to be at a higher risk of receiving a traumatic brain injury than women. African-American males have the highest death rate from traumatic brain injury. Age groups at the highest risk are from newborn to four years old and 15 to 19 years old. For those in the military, certain military duties can increase the risk of traumatic brain injury. Traumatic brain injuries can increase the risk for other medical conditions including Parkinson's disease, epilepsy, Alzheimer's and other brain disorders. Other problems traumatic brain injury can cause include changes that affect thinking, sensation, and emotions.

The Nebraska Brain Injury Advisory Council is cosponsor two events being held in recognition of Brain Injury Awareness Month.

• The seventh annual Brain Injury Conference in Kearney on April 4 and 5 will offer sessions to help individuals and their families address adjustment, coping, acceptance and expressing themselves through journaling. Sessions for professionals will explore substance abuse, behavioral changes and bridging the gap between concussion and the classroom. Scholarships are available for individuals that may require assistance in covering the cost of registration. Registration for the confer-

ence closes March 27. • A webinar on March 27 titled, "A Brain in the Palm of Your Hand: Handheld Devices as Cognitive Aids for Veterans." The free webinar will be presented by Tony Gentry, an associate professor in the Occupational Therapy Department, Virginia Commonwealth University in Richmond, Va. The webinar will examine current devices as well as apps designed to

# Hispanic and women farmers and ranchers claims deadline approaches

Agriculture Secretary Tom Vilsack today reminded Hispanic and women farmers and ranchers who allege discrimination by the USDA in past decades that there are fewer than 30 days remaining in the filing period closing March 25.

"Hispanic and women farmers who believe they have faced discriminatory practices in the past from the USDA have fewer than 30 days left to file a claim in order to have a chance to receive a cash payment or loan forgiveness," said Secretary Vilsack. "USDA urges potential claimants to contact the Claims Administrator for information and mail their claim packages on or before March 25.'

The process offers a voluntary alternative to litigation for each Hispanic or female farmer and rancher who can prove that USDA denied his or her application for loan or loan servicing assistance for discriminatory reasons for certain time periods between 1981 and 2000

As announced in February 2011, the voluntary claims process will make available at least \$1.33 billion for cash awards and tax relief payments, plus up to \$160 million in farm debt relief, to eligible Hispanic and women farmers and ranchers. There are no filing fees to participate in the program.

The Department will continue reaching out to potential Hispanic and female claimants around the country to get the word out to individuals who may be eligible for this program so they have the opportunity to participate.

Call center representatives can be reached at 1-888-508-4429. Claimants may register for a claims package (by calling the number or visiting the website) or may download the forms from the website. All those interested in learning more or receiving information about the claims process and claims packages are encouraged to attend meetings in your communities about the claims process and contact the website at http://www. farmerclaims.gov/ any time, or the call center at 1-888-508-4429, Monday through Friday 9 a.m. to 8 p.m. EST.

Independent legal services companies will administer the claims process and adjudicate the claims. Although there are no filing fees to participate and a lawyer is not required to participate in the claims process, persons seeking legal advice may contact a lawyer or other legal services provider.

Under Secretary Vilsack's leadership, USDA has instituted a comprehensive plan to strengthen the Department as a model service provider and to ensure that every farmer and rancher is treated equally and fairly as part of "a new era of civil rights" at USDA.

In February 2010, the Secretary announced the Pigford II settlement with African American farmers, and in October 2010, he announced the Keepseagle settlement with Native American farmers. Both of those settlements have since received court approval.

Unlike the cases brought by African American and Native American farmers, the cases filed by Hispanic and women farmers over a decade ago were not certified as class actions. The claims process provides a voluntary alternative to continuing litigation for Hispanic and female farmers and ranchers who want to
