## Trafficking children for sex global

Human Trafficking 101 was the setting for the Bonham Theater in Fairbury Nov. 14 with guest speaker Sara Eliason of the Women's Center for Advancement out of Omaha.

Eliason is a prevention and education manager, who gives presentations to increase awareness of domestic violence and sexual assault.

Through a grant from components of the US Department of Justice, the center is actively identifying and assisting victims of sex trafficking.

According to its website, sex trafficking "spiked" at the College World Series as it often does at national events, such as the Olympic Swim Trials in Omaha, set for 2020.

The issue is rampant throughout the country and around the globe — the DOJ is logging arrests and convictions, almost on a daily basis.

On Nov. 14, a teacher was sentenced to 21 years in prison for molesting kindergarten students. Also on Nov. 14, USA Today ran a piece on a soldier who went missing on his post and was arrested for human trafficking near the California border.

There is strong evidence the federal government is attacking trafficking and child sexual assault. In addition to DOJ activities, Immigration and Custom Enforcement is consistently snagging traffickers, and in the "Trafficking in Persons Report 2018," the US State Department covered the world.

News releases from countries suggest plans to remedy the problem from within, but the problem is sometimes seeded in the very governments of those countries — a former police chief in Peru was arrested Nov. 7 in an alleged baby trafficking ring.

The 2,232-page Omnibus bill passed in March has hundreds of pages on trafficking and firm language for countries around the world to work on solutions.

A trafficking ratline from Venezuela to the Dominican Republic and Haiti involving government officials has been reported by the media in those countries.

Trafficking is also a staple at the southern border of the United States. In 2016, the senate permanent subcommittee on investigations released a report, "Protecting Unaccompanied Alien Children from

Trafficking and Other Abuses: The Role of the Office of Refugee Resettlement" led by senators, Rob Portman and Claire McCaskill.

The report was horrific in detail, showing the department of health and human services didn't vet, to any degree, who the children were traveling with and where they were placed once in the US. What's more, "sponsors" of the children were often connected to trafficking rings.

One child told HHS after he was rescued from a trafficking ring, that his sponsor, described as a family friend, was only there to help the child out from underneath the clutches of HHS. Another approved sponsor turned out to be a stranger. The report found no background checks on "non-sponsor adult household members" were completed while the responsibility of HHS was ensure placed children were safe.

In Nebraska, the Court of Appeals upheld in part and reversed in part, a 25-year sentence given to former acting HHS Cyber Security Director Timothy DeFoggi, who was under Kathleen Sebelius at the time, involving a computer server in Bellevue hosting child pornography websites, like "Pedobook," which operated for most of 2012.

In addition to multiple arrests because of child pornography, crimes against children across the state were also detailed in a September 2017 report by the Office of the Inspector General of Nebraska Child Welfare.

The report on sexual abuse of state wards, youth in adoptive or guardian homes and youth in residential placement, showed adults had "problematic attitudes" toward children who said they were sexually assaulted.

Claims of sexual abuse by the children were sometimes dismissed and went unreported; some children were left in the environment, where they continued to be abused; others were blamed for being sexually abused; and the DHHS Child Abuse and Neglect Hotline was in fact cold to allegations of sexual abuse because calls were screened to determine if they were about sexual abuse.

In one case, two children in state care said their step-brothers, ages 17 and 20, were sexually abus-

## Lewis in court Dec. 4

Michael Lewis, the 21-year-old who shot the two Elting brothers at his Hebron residence Oct. 27 will be arraigned Dec. 4 at 9:30 a.m., in Thayer County District Court.

Remington Elting died from his injuries. Reuben Elting was critically wounded and flown to a Lincoln hospital.

Lewis is charged with using a deadly weapon to commit a felony and first degree assault, both of which could bring up to 50 years in prison each. For using the deadly weapon to commit a felony, Lewis would have to serve a mandatory minimum of five years.

He was in court Nov. 9 for a bond hearing. His bond was lowered from 10 percent of \$250,000 to 10 percent of \$150,000, and he bonded out. Lewis listed his address as Jansen on the bond form and his Hebron residence as a former address.

Thayer County Attorney Dan Werner filed for a special deputy county attorney from the Nebraska Attorney General's Office and it was granted by district Judge Vicky Johnson.

A pretrial hearing was scheduled for Feb. 5 at 9:45 a.m.

## Farmers hold out for trade solution

Crop watchers were worried about yields this year as the drought matured plants faster, but wet weather in August through early September allowed the crop to fill and add depth to kernels.

"It put on more weight for better yields," UNL Extension Educator, Jenny Rees said.

She said irrigated fields produced very good yields on corn and beans. Non-irrigated fields had timely rains to reduce stress from dry spells.

"Some of the corn is excellent from the irrigated yields, but later into the harvest, stocks were breaking over from the weather," Larry Seaman of Norder's Supply Inc.

Rain at September's end and a subsequent snowstorm slowed the harvest, which began early this year, for quite a while, Seaman said.

Rees said grain quality issues were also a factor.

"We had some different fungal diseases and mold issues," she said.

Throughout the harvest, Rees said farmers were encouraged to know if there were quality issues with their grain, so they would have a better idea for the storage side of the harvest.

"It is important for them as they have grain in storage," Rees said.

Stored grain on the ground should be going into the plastic bags at no more than 15 percent moisture and away or fenced off from grazing cattle.

"They're storing both corn and beans. Key things are we want to keep them cool, watch the moisture and make sure we're not getting hot spots," she said.

Seaman said bean storage was taking up more space this year. Farmers are holding out for the trade situation with China to be solved.

Rees said they haven't heard too much on milo, although yields looked favorable. She said the

## 1888

### 130 Years Ago

Grand Celebration: The grandest parade and celebration ever in Southern Nebraska will be had in Hebron, Monday, Nov. 12, afternoon and night. Hundreds of dollars for fireworks, banners, etc. The state artillery will be shipped to Hebron for the occasion. Barrels of tar for the bonfire, and bushels of powder for the cannon. Every Republican in Thayer and adjoining counties will join the bedlam of rejoicing over the greatest victory in history of the Republican party. Come and spend one grand holiday. By order of the committee.

D. A. Powell departed for Omaha Tuesday where we understand he has located permanently.

The new town of Oak, in Nuckolls County, claims 40 inhabitants.

The Hebron Library Association has recently added a number of late works by standard authors of the day, to its list of interesting books. This institution is well worthy of popular support. A life membership costs only one dollar, and everybody is invited to become a member. Five cents gives parties who are not members the privilege to get a book for two weeks. Mrs. S. E. Ferguson is secretary and librarian.

The many friends of Mrs. Chas. Stewart (late Miss Dell Minnier, of this place) will be saddened to learn of her recent death, and the death also of her infant.

The new Central House addition is nearly completed. It has been pushed ahead with great rapidity by its energetic proprietor, Mr. J. W. Hughes.

A large red rooster covers the local news page of this after-election issue of The Hebron Journal and the type is blue. In a big two column headline is the word "Victory!" followed by the following smaller headlines: "The Second Appomattox Has Been Won, And Now, As In 1865, Let the News Be Carried To The Solid South and Tell them that in 1891 there will be a Reapportionment under the Census of 1890, and the Republican Party will see to it that thereafter one vote in the Solida South shall count as much as one vote in the North AND NO MORE! With a President, Vice President and a Majority in both Houses of Congress, we feel pretty well, Thank You! With our Grand Old War Government, the entire State Ticket, a Republican Legislature that will re-elect Gen. Manderson and Our Entire District and County Ticket, We Will Try to Get Along without Friedensau Precinct. Oh, Where are Our Foes, who so Vauntingly swore, that Republicans Defeated should be Evermore? Eh? Benjamin F. Harrison was elected president; John M. Thayer, governor; F. M. Wetherald, senator, 23d Sen. Dist.

Nothing occurred to mar the good order on election day here, although the largest vote (449) ever polled in Hebron was recorded, and the contest was a hard one. Both parties endeavored to poll their full party strength.

Died, at her home near Hebron, Nov. 7, Amelia, beloved wife of Albert E. Gates, aged 36 years and 11 months. The deceased was widely known as one of the early settlers of Thayer county, having with her husband resided here since 1869. She leaves a husband and three children to mourn her untimely death.

J. M. Wilbur, who has been stopping for some weeks in Hebron investing money in real estate loans, departed via the Rock Island for Sandy Hill, N.Y.

## 1898

### 120 Years Ago

Mrs. M. R. Peery desires music scholars for the piano.

County Superintendent Rhodes this week received notice from the Trans-Mississippi Exposition that Thayer county ranked second in the Nebraska school exhibit, and had accordingly been awarded the silver medal.

Mrs. T. S. Stewart gave a very pleasant whist party in honor of her sisters, the Misses Coddington, Tuesday evening.

Mr. Albert Degner and Miss Maggie Degner with their mother returned Wednesday from Milwaukee, Wis., where they had been to observe the placing of a monument at the grave of Arthur Degner, who suddenly died several months ago at Milwaukee while attending school.

S. L. Sperry sold three acetylene gas plants this week.

Last Tuesday night Mrs. Foster Church of Alexandria was asphyxiated from coal gas, and her grandson, Harry Burham, was rendered unconscious, but was later resuscitated. Mrs. Church and Harry slept in that part of the house where the hard coal stove was burning. The rest of the family slept upstairs and knew nothing of the terrible accident until morning when they discovered Mrs. Church dead and Harry nearly so.

Died, at Omaha, 1898, Ella Rudd Devine, at the age of 28 years. Ella Rudd was a native of Hebron, her father, Richard Rudd, being one of the pioneers of Thayer County. At the age of five years she was left an orphan and at the age of seven years was stricken with scarlet fever, from the effects of which she lost her hearing. At the age of 10 years she was thrown on the county and application was about to be made to send her to the poor farm, but through the efforts of W. H. Barger, then county judge, she was sent to the Deaf and Dumb Institute at Omaha, where she received all the instruction and benefits of that institution, after which she spent two years at the National college for the Deaf and Dumb at Washington, D.C., then became a teacher at the Omaha institution. While Ella Rudd was in a manner a dependent on Thayer county--county having paid a part of the expense of her education--she developed a womanhood any citizen of Thayer county may well be proud of. In June, 1897, Ella Rudd married Mr. Divine, a brilliant young man from Ord, who lost his hearing at the age of 17 years by scarlet fever and finished his education at the Omaha and Washington institutions for the deaf. She leaves a loving husband and an infant son to mourn her departure. No relatives of hers were present at the funeral. Mr. and Mrs. Barger attended the services.

## 1908

### 110 Years Ago

The Bachelor's Bunch dined together Sunday in honor of Rob Lindsey--that is, in honor of his convalescence, not his nuptials although the boys would delight to do honor to that event!

In appreciation of their efforts in extinguishing the fire on the railroad bridge and preventing a disastrous wreck south of Hebron recently, the Burlington route presented \$10 to W. M. Sharp and to his son, M. A., and \$5 each to L. R. Goodhue and son and John Quate.

Ex County Supt. G. W. Allen was over from Belvidere, Tuesday, whispering confidences to his friends concerning his approaching marriage. The Bachelor's Bunch, of which organization Mr. Allen has heretofore been a consistent member, tearfully gave their consent to the bans, and the license was issued by the county judge in due and ancient form. George is the second one of the Bunch to kick over the traces and land with his neck in the halter, or to be led to the altar, or words to that effect. We almost forgot to mention the name of the bride, but as Miss Zelle Dimorier expects to change her's to Allen, it will doubtless be all right. The happy couple were united in marriage at 8:30 o'clock on Thanksgiving morning, Nov. 26, at the home of the bride's mother, Mrs. Melissa Dimorier, in the presence of the immediate relatives.

Dr. Boyes' hospital record for the first 10 months of 1908 shows that there have

been 47 cases at the hospital, 28 surgical and 19 medical; two deaths and 45 recoveries; one death surgical and one medical. These patients came from 17 different town and from four different states.

Guy Averill has been appointed special military police... A Thayer county boy in France, son of Henry R. Naiman of Gilead, was one among 56 citations for bravery announced by the war department.

### 80 Years Ago

Dr. H. W. Saylor, city health officer, Wednesday morning, received a report on Bruning's water from the Public Health Laboratory at Lincoln, which stated that it is bacteriologically satisfactory for human use. An unsatisfactory condition of the water in Bruning was reported a few weeks ago following the installation of the new pump which necessitated in adding a chlorine mixture to purify it. This treatment caused a taste and odor that was all but pleasant to users.

By a margin of .01 bushel, Leonard Kuhlma of Chester won the Thayer county corn husking contest held Saturday on the Luther Walls farm just south of Alexandria. Kuhlmann, in the allotted 80 minutes, husked 15.96 bushels of corn, while Harry Walters of Davenport was close second with 15.95 bushels. Nearly 3,000 persons braved the cold wind to witness the contest. This was the first corn husking contest in Thayer county since 1933, when Albert Hulse of Bruning won the event.

Examination will be given Saturday to 44 high school students representing every high school in Thayer county, for the purpose of selecting the most outstanding young citizens of 1938 in the county.

# Know Diabetes by Heart -Diabetes Awareness Month-

Cardiovascular disease-disease of the heart and blood vessels (arteries, veins and capillaries) is the leading cause of death and a major cause of heart attacks, strokes and disability for people living with type 2 diabetes, a condition characterized by high blood glucose levels caused by either a lack of insulin or the body's inability to use insulin efficiently. Type 2 diabetes develops most often in middle-aged and older adults but can appear in young people. Only half recognize their risk.

November is Diabetes Awareness Month. The American Heart Association (AHA) and the American Diabetes Association (ADA) launched their new, multi-year awareness and education initiative, Know Diabetes by Heart™, to reduce cardiovascular deaths, heart attacks and strokes in people living with type 2 diabetes.

People living with diabetes are two times more likely to develop and die from cardiovascular disease. Yet in a recent survey of people age 45 and older with type 2 diabetes conducted online by The Harris Poll, only about half recognize their risk or have discussed their risk for heart attacks or strokes with their health care providers.

"The public health impact and growing threat of diabetes and cardiovascular disease are too significant for any one organization to tackle alone," said Nancy A. Brown, chief executive officer of the American Heart Association. "Our collaboration with the American Diabetes Association and industry supporters is crucial for developing meaningful solutions and offering practical tools and information that can help those living with type 2 diabetes find inspiration and take action toward improving their health and decreasing their risk of heart disease."

Participants in focus groups conducted by the ADA and the AHA in September revealed that many people living with type 2 diabetes experience distress related to the day-to-day management of this chronic disease, something that is long-lasting. They also reported feelings of hopelessness, which can make them less likely to take ac-



tion to reduce the long-term complications of diabetes. More in-depth research is underway to better understand the populations at highest risk.

"As someone living with type 2 diabetes, I empathize with the denial, worry, fear and even frustration that can accompany a diabetes diagnosis and the daily management of the disease," said Tracey D. Brown, chief executive officer of the American Diabetes Association. "It's critical that we wake people up to the realities and deadly complications of diabetes, especially heart disease. Reducing the risk of cardiovascular disease is vital to improving the quality and length of life for every individual living with type 2 diabetes. We are proud to collaborate with the American Heart Association and our industry partners to bring this initiative to life through every avenue possible. This is an incredible moment for our organizations."

For people over age 60 living with type 2 diabetes, cardiovascular disease shortens life expectancy by an average of 12 years. Focus group participants said they are motivated to make behavioral changes by their desire to fulfill family responsibilities and through strong support and connections to family, friends and a community of people who understand what they are going through.

Know Diabetes by Heart is designed to educate, empower and motivate people with type 2 diabetes to make practical, step-by-step changes to improve their health and decrease their risks of cardiovascular disease, heart attacks and strokes. The initiative also leverages the latest evidence-based guidelines to support health care providers regarding the link between diabetes and cardiovascular disease, and includes quality improvement efforts across clinics, practices and hospitals caring for people with type 2 diabetes.

# Obituaries

## Irma Marquart

Irma Dora (Doering) Marquart was born on May 30, 1916, the only child of Margaretha Doering in Deshler, and passed away on November 14, 2018, at the age of 102 years, five months and 14 days at the Blue Valley Lutheran Skilled Care Facility in Hebron.

She was raised by her grandparents John C. Doering and Sophia (Schlammann) Doering on the family farm rural Ruskin. Irma was baptized on June 30, 1916, at Zion Evangelical Lutheran Church, rural Deshler, by Pastor Lentz. She attended school District 92, rural Deshler until eighth grade. She was confirmed in German on June 22, 1930, also at Zion by Pastor J. A. Grueber.

Since her mother was the oldest Doering daughter, she always considered her uncles and aunts, her brothers and sisters. She talked often how she would get to help her Grandpa John, even going to Beatrice with him once and they ate in a restaurant. She could tell you what Grandpa ordered for dinner. She said it was the best food she ever ate. She helped Grandma by baby sitting and loved to go to Ruskin on Saturdays and watch free movies.

Irma was united in marriage to William J. B. Marquart on May 30, 1935, at Zion Evangelical Lutheran Church by Pastor J. A. Grueber, and celebrated their 40th wedding anniversary in 1975. They lived on a farm near Ruskin until 1949, when they moved to the Ernst Marquart family farm rural Byron.

While Bill farmed, Irma took care of her in-laws until their passing. Bill and Irma were blessed with daughters, Merna, Janet, Alice and Nancy. Irma raised a lot of chickens. They also had milk cows in the early years of their marriage and sold the milk. As the girls grew, Irma became Bill's helper in the fields, and continued that until Bill had a farm auction.

In 1936, they attended a farm auction near Cadams and purchased a Singer Treadle sewing machine for \$7.50. She had saved her egg money to buy it. There wasn't much money left for groceries that week. Over the years she made crazy quilts and nine patch tied quilts for her daughters, grandchildren and great grandchildren. She made baby quilts, name quilts, college quilts and wedding quilts for her grandchildren. Many other family and friends received her baby quilts.

Irma continued to live on the farm; her dog, Mopsy, became her best bud, waking her in the night to shoot some animal he had up a tree. She loved her "kitties" and the kids or grandkids "Poochies," never calling them by the pet's name. She was always the pitcher for the family ball games. She taught her family how to play cards. She had homemade bread, candy bars and pop waiting when the grandchildren came to visit.

She had a homemade wagon that she attached to the riding lawn mower to give the little ones rides. She was a very

hard worker all of her life. She painted the outside of many houses, barns, and other outbuildings in the area. She also wallpapered and painted interiors of homes, churches and the Thayer County Courthouse just to name a few. She was not afraid of heights and taught several women the proper way to paint, as well as her daughters. She drove to Lincoln to teach Nancy and Ken how to shingle their house.

The Christmas sleep overs at her house were 20 or more people sleeping on the floor telling stories and giggling. Not much sleeping took place but precious memories were made. Irma traveled on many bus tours. She watched the KC Royals baseball team and even attended a game or two. She went to visit her grandsons in Germany twice, and even went to Hawaii. Irma took up bowling on Wednesday afternoons and bowled for over 25 years. She belonged to the Byron Senior Center, WELCA, and helped with world relief sewing days. She played ten-point pitch cards with several groups; everyone wanted Irma as a partner, as she would usually win.

In 2002 Irma purchased a home in Hebron. In 2011 she moved to Courtyard Terrace. She liked the fact she no longer had to cook, clean or do laundry and could continue to make quilts. She moved to Blue Valley Lutheran Skilled Care Facility on December 12, 2014. She enjoyed the activities there, but loved cards the most. She was the fastest at word search puzzles, fixed jig saw puzzles and always won at cards against her daughters.

She is preceded in death by her husband, Bill, on March 4, 1976; mother, Margaretha; stepfather, Henry Steinman; grandparents; infant half-brother; sons-in-law, Warren Kennel and Jerry Vieselmeyer; and infant great granddaughter.

She is survived by her daughters, Merna Yoder of Aurora, Janet Kennel of Geneva, Alice Vieselmeyer of Friend, and Nancy Vogel and husband Ken of Hebron; grandchildren, Michael (Bridget) Yoder of Henderson, Monte (Kelly) Yoder of Aurora, Randy Kennel of Geneva, Joni (Ron) Nuss of rural Aurora, Karl (Angela) Vogel of Lincoln, Jack (Karen) Vogel of Lincoln, Rena (Lynn) Scheets of Fairbury, Ray Vieselmeyer of Orem, Utah, and Darren Vogel of Hebron; 20 great grandchildren; one great great grandson; nieces, nephews and other relatives.





Honorary bearers were Finn Kristalyn, Ezra Kristalyn and the staff and residents of Region V.


Cremation followed the service and family inurnment was in St. Peter Lutheran Cemetery, Deshler.
