

## Letter To The Editor

Dear Editor:

I was drafted into the service in May of 1944. I decided to take the Navy, because I didn't want to dig fox holes in the frozen ground in Germany while the Germans were shooting at you.

Paul Hergott and Paul Brettman were in my group going to Idaho boot camp. The problem I had was I could not swim.

After boot camp I was picked to go to Seattle, Wash., to radar school. Radar was new at the time. It gives you pictures of ships around you and what they're doing.

Our ship had 26 landing boats on it to haul Marines to the islands so the Japanese could shoot at them.

I arrived at Iwo Jima on my 22nd birthday. The Marines were shooting flames into the caves. This was about the third week of this battle. There was a flag on Mountain Suribachi.

I just read where there were 1700 killed on Iwo Jima. The story is in "Reader's Digest" July-August—"The Cost of Freedom."

Our ship then went to Tokyo, after the U.S. dropped an atomic bomb on Japan and they surrendered. We hauled some Marines to occupy some land in Japan after the signing of the treaty.

Our ship went to Nagasaki, Japan, to pick up our mail and to view what the bomb did. It killed around 80,000 people. I viewed a few steel beams standing up where the damage site was.

Guess who the mailman was? Paul Hergott brought the mail in a little boat. We were two sailors from Gilead, Nebraska.

Our ship returned to the USA. It took 18 days and nights to cross the Pacific Ocean at 18 knots.

County and that number is expected to dip.

Bauhard said in general, veterans don't return to the area after they leave.

Thayer County has veterans from the Persian Gulf, Iraq and Afghanistan, however, most have moved on to larger cities for their careers.

The ones that do are receiving good care at the Lincoln and Grand Island Veterans Affairs medical facilities.

"Just about every veteran who uses the VA has no

complaints in Nebraska," Bauhard said.

But he has a big gripe with the Nebraska Department of Veterans Affairs.

"Three or four years ago, they had \$40 million. Now, it's \$53 million," Bauhard said about the Nebraska VA budget. "They're taking more in than they're giving out."

He said veterans need to be in the poverty zone before they receive help.

"Your annual income has to be below \$12,000," he said.

He said the federal VA is trying to improve medical care via the Veterans Choice program and reaching out to veterans with disabilities.

For example, older veterans have hearing issues and younger veterans are plagued with post traumatic stress syndrome and muscular skeletal problems.

"They continue to try and refine the care to make it easier on the veterans," Bauhard said. "We have had fairly good success out of this county," Bauhard said.

## Man arrested for sexual assault

Bradley Upton, 18, is scheduled for arraignment Nov. 13 at 10 a.m., for three charges of first degree sexual assault.

His bond, originally set for 10 percent of \$500,000 was reduced to 10 percent of \$350,000 in Thayer County Court Nov. 2.

Upton is accused of sexually assaulting a minor child on three occasions, Aug. 19, Sept. 9 and Sept. 24.

Each charge is a class 2 felony.

Gross went to Iraq in 2007 and was in Baghdad for eight months. As a Lieutenant Colonel, she was assigned to be a medical advisor to the Iraqi Minister of War.

"The army sends in advisors for different areas," she said of rebuilding infrastructure in Iraq. "We built several medical clinics for the national police."

On Easter in 2008, the helipad where Gross had just taken off, was bombed.

"You can't be afraid. You can't stop what you're doing," she said. "We had people who were having a difficult time with the bombings. Someone has to be strong," she said.

She was told more than once women couldn't do the job men can.

"It didn't matter. We were going to do the job," she said.

She said everyone has life issues. The key is their reaction.

"One way to deal with it was humor. We would eat meals together and joke about how old Col. Gross was," she said.

Gross was recently awarded the 2017 American Academy of Physician Assistants for Military Service.

"It is not easy for me to be the center of attention. I like the other folks to shine," she said. "You have to lead by example."

Her awards and deco-

rations include, Defense Meritorious Service; The Meritorious Service; Army Commendation; Army Achievement; National Defense Service; Armed Forces Reserve; Armed Forces Expeditionary; Global War on Terrorism; Joint Meritorious Unit, Superior Unit; Good Conduct; Combat Action; Order of Military Medical Merit; and the Surgeon General's 9A Proficiency designator.

Her mother wanted her to retire and come back to Nebraska, but each time she thought about retirement, she wanted to try one more thing.

"It was, 'Let me go do this first,'" Gross said.

On Veteran's Day, Gross thinks of her dad, brothers, sisters, cousins and the soldiers she has served with.

"People coming in the military, they think they have an idea of what they're getting into. They really don't, but they come in. I just have to be grateful I am a part of that and able to help them," she said.

Gross does think those who served should wear their uniforms from time to time.

"Reserves and National Guard have the distinction. Our communities don't know that much about them. They don't know they're ready to move at a moment's notice," she said.

Coach Chris Ardissono said the front defensive lineman, Dickson, Kamron Dickson, Weber, Jacob


Schoenholz and Glen Meyer, were rotated.

## Kluck nominated for award

Bruning-Davenport Shickley head basketball coach, Fred Kluck, has been nominated for a national award by the Nebraska Coaches Association.

He was entered as Nebraska's representative for the National Boys Basketball Coach of the Year for the National Coaches Association for all high school sports coaches.

Kluck, who reached his 500th win during the 2016-2017 season, has a record of 512-177 for his career.

He was the assistant girls Coach for Bruning High School 1986-89, Head Girls Coach, Bruning High School 1989-98, Head Boys Coach, Bruning 1998-2000, Bruning-Davenport, 2000-2010, and BDS 2010-2017.

In the 28 years he's been a head coach, Kluck's teams have won 12 conference regular season titles, 11 conference tournament titles, 12 district tournament titles and qualified for the state tournament 13 times, including his final season where they finished 20-5.

His teams were semifinalists five times and as an assistant coach, his girls' team won the state championship in 1988.

Prior to his arrival, neither the Bruning boys or girls basketball teams had

ever qualified for the state tournament.

Kluck was recognized last summer by the Nebraska Coaches Association as the Nebraska Boys Basketball Coach of the Year for all classes for 2017.

He has coached many area All-Star games and was selected by his peers to be a Head Coach for the Nebraska Coaches Association 2008 All-Star Game.

He was recognized as the State Farm Insurance Nebraska Girls Coach of the year in 1997.

His players were named first or second team all-state 21 times and first team all-conference 35 times.

Kluck has also been a head track coach for all three schools, starting with Bruning in 1986 and remaining for 30 years.

His boys and girls teams recorded 51-meet championships along with 53-meet runners up, which includes three state championship runners up with the BDS girls team.

During his career, he coached 38 gold and silver medalists at the Nebraska State Track and Field Championships held in Omaha.

During his tenure at the three schools, Kluck also served as the athletic director (25 years) and coached at

the junior high level for over 30 years including both JH girls and boys basketball and track, girls volleyball and boys football.

At one point in his career, Kluck was the head coach for seven of the 12 teams Bruning and Bruning-Davenport fielded at the same time.

While Kluck was serving as AD, in addition to the teams he has coached to state appearances, the football team was in every state playoff since 2001, winning two state titles and finishing as a state runner up once as well.

The volleyball team was a state runner-up in 2013. In 2015, BDS won the Sportsmanship award at the boys' state basketball tournament and in the 2016 Bruning-Davenport was named the winner of the NSAA's Cellular Cup award for Class D, which recognizes each class's most successful program for all activities for that year.

Kluck is a graduate of Lincoln High and Doane College, and has been happily married to his wife Myra for 28 years.

Their only child, daughter Johanna, is currently a junior in college in Iowa.

**Current or former owners of property adjacent to or underlying certain Rails-to-Trails corridors could receive payment for the taking of private property rights.**

In the matter of Schneider v. United States, Civil Action No. 8:99-CV-0315, a federal court in Nebraska has ruled that the United States is liable, in some circumstances, for a taking of private property rights underlying, or adjacent to, certain railroad rights of way in the State of Nebraska, and this taking is compensable under the Fifth Amendment of the U.S. Constitution. The Court has recently determined that the class action should now be decertified, effective on January 16, 2018. The Court has also determined that affected property owners must decide whether to pursue a financial recovery as individual plaintiffs in the action.

#### Who is Included?

A detailed notice, and others supporting documents, are available for review at the website [www.NebraskaTrailSettlements.com](http://www.NebraskaTrailSettlements.com), and they can help you determine if you are affected. Generally, you may be eligible if you or your predecessor in title owned property between 1993 - 1999, next to or over which a railroad company had a right of way that is now used as a recreational trail in the following counties in Nebraska: Douglas, Otoe, Nemaha, Dawes, Sioux, Saunders, Butler, Sarpy, Madison, Antelope, Holt, Rock, Brown, Cherry, Sheridan, Buffalo, Saline, Thayer, Clay, Fillmore, Nuckolls, Webster, Lancaster, Jefferson and Gage.

#### If You Are Included, What Can You Do?

The Court had previously certified a class of all persons who own an interest in land constituting a railroad corridor in the State of Nebraska, and which is now occupied or controlled for trail use

pursuant to the National Trails System Act, and who have been damaged in the amount of \$10,000 or less by being deprived of their rights to possession, control, and enjoyment of their land as a result of a Trail Use Order, or who waive claims exceeding \$10,000.

Now that the class is being decertified, **if you wish to individually enforce your affected property rights, you must join the Schneider action (or file a separate case with your own counsel) and you must do so promptly. If you fail to join the Schneider case, your claim will be dismissed from that case and you will receive no financial compensation in that matter.**

#### How Much Could You Get?

Payments will be based on the appraised value of the taking up to a limit of \$10,000 per claim. Payment will also include interest.

#### How Do You Get A Payment?

You must submit a joinder form to be included as a party in the case and potentially qualify for payment. The joinder form can be accessed via the website, or can be requested by contacting plaintiffs' counsel as noted below.
