Council rules on zoning

The Hebron City Council voted to amend the comprehensive plan, which dictates zoning and sub-division regulations, in order to zone an area at 1st Street and Dove Road industrial with the other half of the property to the east as residential high density to make way for new grain storage managed by Norder Supply during the council's regular meeting Monday evening.

After approving the resolution, the council voted to allow a

Man dies following accident

Edward Guinn, 57, of Wichita, Kan., was pronounced deceased after an accident on Highway 81 near Road V Sept. 29 at 7:43 p.m.

Guinn was driving a 2013 Harley Davidson north on the highway when he struck a deer. He was thrown from his motorcycle, which continued into the median before coming to a rest.

Guinn was lying in the path of a vehicle driven by Michelle Clift, 45, of Geneva. She was headed north on Highway 81 in a 2003 Ford mini van.

According to the Thayer County Sheriff's report, Clift struck Guinn.

Another driver, Ralph Martin, stopped at the scene because he was unsure if he had struck the driver or parts from the motorcycle. Martin, 54, of Plano, Texas, was in a 2014 Kenworth semi-truck.

Officials quiet on Uecker case

On Sept. 27, the Nebraska State Patrol met with Thayer County Attorney Dan Werner and turned in its findings of the accident surrounding the death of 25-year-old Abby Uecker in the early morning hours of July 23 at the Thayer County Fairgrounds in Deshler.

Uecker was the singer in the band that had played at the fairgrounds the evening before she was pronounced deceased at Thayer County Hospital at 5:30 a.m., after a UTV accident inside the racetrack area.

She grew up in Norfolk and attended the University of Nebraska-Lincoln, where she pursued a degree in theater performance. After college, she traveled to Nashville, Tenn., and recorded her first single, "Cool."

Cody Thomas, public relations director for the state patrol, said investigators reconstructed the accident and such reconstructions can take up to two months or longer.

"I've been on our folks asking for updates and they say it takes time," Thomas said. "There may still be more meetings. We have worked closely with the county attorney."

Werner will make the final call on the accident and determine whether any charges will be filed.

The Big Green 4-H Club is forever in the state fair history log for the community service project the club entered this year. Club members worked on giving the horse stalls at the Thayer County Fairgrounds a fresh coat of paint and in return, received a Special Recognition ribbon and kudos from University of Nebraska-Extension for "making the best better."

As part of the project, several club members contributed their own views in a booklet. Excerpts from the booklet are below.

Kaylan Anderson — "We had to pressure wash the walls and that took an evening of work. Then, we bought paint in five gallon buckets. We used rollers on the doors. It was a lot of work, but worth it."

Makinna Peterson — "The Community Service project for 2017 was the biggest project we have ever done and all the hard work paid off. I learned from this service project that the more work a project takes, the more it means to you at the end."

Riley Farnstrom — "We spent several nights scraping paint with scrapers. I had never done

that before, so I thought it was kind of fun. We painted for days! Things I've learned: Volunteering is important for our communities; Painting is hard work, especially when it is hot outside; The kind of paint we used is hard to get off of your skin and out of your hair; I got to spend a lot of time with our club members, so it was fun to get to know my new friends; and I'm thankful for all the moms, dads and 4-H club leaders."

Trevon Anderson — "It was a lot of work. It was really hot, so we worked in the evenings. We had fun doing that and got paint on our face sometimes. Our parents brought pizza and drinks and one time, Subway sandwiches. I think it looks really good now."

Jacilyne Peterson — "From this Community Service project, I learned that it doesn't matter how little you are if you try hard enough. I got to run the power washer and paint gun. Every time I look at the horse barns, the memories of all the nights we spent there make me smile. I will always remember this project and hope that for years, it is enjoyed by everyone."

Cooper Laaker — "Some of

the other projects we did with our club was planted flowers in our planter boxes, worked at the concession stands at the fair and showed sheep. There are several other projects that could be done at the fairgrounds. One of them is repainting all the rest of the animal barns. I enjoy 4-H because I have learned a lot of lessons that will stay with me forever."

Colt Laaker — "It took our group about three to five different days to paint the stalls. Our group had fun working together and is ready to enjoy the work we did when we visit the horse barn at the fair. I enjoy 4-H and all the friendships I have been able to make through 4-H!"

Alex Wright — "We painted the inside and outside of all 36 stalls and the bottom half of the outside. It took a whole week! It was a lot of work, but we are happy it is done because it looks very nice now."

Brenton Laaker — "My 4-H group bought a ton of white paint and began repainting the horse barn. I had a blast working with my friends and other group members."

1887

130 Years Ago

Alexandria: T. A. Morrison has returned to Alexandria and expects to engage in the windmill and pump business...J.E. Burger has secured the position of miller and general manager of the Meridian mill...Quite an enthusiastic meeting was held Saturday evening for the purpose of organizing a brass band. Wenzel Landkamer was selected as leader and a membership of 13 was organized. The boys have sent for their music and expect to commence work at once...We will wager a new hat there will be a wedding in this town inside of three weeks. We will not give away the parties now, for they are keeping it very quiet, but we will furnish you full particulars in due time.

Railroad No. 3: The Kansas City, Lawrence & Western railroad surveyors reached Hubbell this week, and a meeting between officials of the company and the citizens of that place was held Tuesday night. At the meeting the citizens told the railroad men they would extend liberal aid to the company if the road would be built through Hubbell to Hebron and on northwest, but if it should go through Hubbell and then west parallel to the B&M, they would not care to extend aid. The officials replied that they desired to build an almost direct line from Kansas City to Hastings and that Hubbell and Hebron were on the line, and if proper aid was given by the two towns the road would be built through them. Such is the report we received. The surveyors are now running their line between Hubbell and this place and will soon be here and talk with our citizens.

We publish this week a proclamation by the county commissioners in which the people of Thayer County will be granted the privilege of voting to allow the platting and sale of such an amount of the county land as shall be necessary to obtain \$8,000, with which to erect a county jail and jailor's residence. This is a prudent measure, and one which might have been favorably considered long before this had it been properly presented. The great need of a jail is generally conceded. Every reasonable man will, we believe, see the force of this argument and speak with his vote on Nov. 8 in favor of the sale of this land.

1897

120 Years Ago

Davenport: M. Jennings of Jewell County, Kan., visited with W. H. Jennings and family the first of the week...The attention of our readers is called to a notice from the officers of the State Bank of Davenport which appears in another column, in regard to closing up the business of the bank. It is with regret that this firm has decided to quit business. This bank was established in 1883 and incorporated in 1890, and through all these years has held the confidence of its patrons. At the close of business last night, the deposits amounted to over \$20,000 and they had over \$21,000 cash on hand to pay the depositors. The reasons for closing are a surplus of money and no borrowers and they have decided that they could use their money to a better advantage in some other line of business. The members of this firm, Messrs. Bolton, Vanderveer and Bearnes have been identified with the business interests of Davenport for many years and the Journal wishes them success in their future undertakings.

Friedensau: The celebration of the German day at Deshler on Sept. 2d was quite an interesting affair for those who witnessed the fine marching of the white and gray heads of ex-German veterans that had partly at least seen actual service in a cruel war on the battlefields of their enemy's country. Mr. Hauck from Omaha was the orator of the day and he reviewed especially that part of history that was in connection with and culminated at Sedan.

Carleton: We are pleased to see the familiar figure of F. D. Lichty on our streets again. He arrived from Pennsylvania yesterday... We are informed that A. M. Dyer has accepted a position at Kansas City with a Live Stock Commission firm.

Byron: H. H. Kimball is taking the roof off his dwelling and store, and will lower the same to a one-story building...We understand that Nathan Stafford and Miss Neva Slocum were married at Belleville, Sept. 22...C. W. Guile is expected in Byron Saturday, with his stock of goods from Elvaston, Ill.

1907

110 Years Ago

Mr. Harve Hutson and Miss Mary McDonald went to Fairbury last Saturday. Returning they used two railroad tickets, although they came back as one, the county judge of Jefferson County having tied the knot.

Mrs. J. G. Burruss, at one time a resident of Thayer County, was frightfully burned to death at her home in Lincoln this week. As Miss Phelps, she resided at Belvidere in the early days, where she married Joe Burruss, moving from there to Alexandria, later to Geneva, and from there to Lincoln.

S. S. Hoyt left town Wednesday with a grip and announced with a wink that he was starting for New York City to return Saturday night. Figure it out for yourselves.

The county this week had erected a brick chimney to replace the smokestack over the heating plant at the courthouse. The chimney is 40 feet high.

Gollmar Bros. show here on Tuesday pleased the big crowd in attendance. The management puts up a good clean show, with many novel and unusual features. This was their second appearance at Hebron, and they will be warmly greeted if they come this way again.

A company of orphan children under the auspices of the Children's Aid Society of New York will arrive in Hebron, Thursday, Sept. 19, to find homes in this vicinity and surrounding country.

Butler, the shoe man, who some months ago purchased the O. E. Hazard stock, has closed his doors.

1917

100 Years Ago

H. S. Yost of Hebron had his Ford automobile stolen at Deshler while attending the county fair last Thursday.

Dr. Baker, who has made many friends during his residence in Hebron, has decided to move to Mayberry where he will go into the general merchandise business.

Blackleg is attacking cattle in Friedensau precinct.

Mrs. Carl Blanchard has canned over 250 tin cans of corn, 40 cans of tomatoes and 40 cans of string beans this season, some of this being for neighbors. One thousand cans were bought early at 3c each and with the sodder cost about 4c each.

Several letters from soldiers appear in this issue: Til Lane of Hebron and H. J. Luct of Bruning write from Camp Funston, Kan.; Ralph Bushong, formerly of the U.S. Navy, but recently enlisted in the Army, has been stationed at the state fair grounds at Pueblo, Colo., and Bob Johnson, of the U.S. Navy, writes from the USS Von Steuben at the Navy yard in Philadelphia, Pa., grateful for the comfort kit sent from Hebron.

While David Burgess was cranking a Ford the first of the week, the now David carries his arm in a sling—but it isn't the same sling that the other David used in slaying Goliath!

A. J. DeWald of Belvidere shows good judgment by adding his name to the Journal list. For about 20 years he was in the photograph business at Friend, but his heart longed for boyhood scenes and he returned to good old Thayer County and is working the old home place.

While renewing Journal subscription, E. E. Butler talked interestingly of "side

issues." These help amazingly in the financial side of farming. This spring his receipts averaged \$100 per month from the cattle and chickens. They milked eight cows and the chickens did as well as the cows. When he was married, Mr. Butler sold chickens for \$1.50 a dozen—and now two fowls bring that much!

I. C. Gray and W. D. Gray have rented the Palacine Hotel and will run it on the European plan, in connection with their cafe across the street.

1927

90 Years Ago

A shocking auto fatality occurred at the bottom of the hill near Wm. Schroeder's on the county highway, 3 1/2 miles east of Hebron, last Saturday night. C. W. Smith of Fairbury was killed when his Ford coach, going east, collided with the Robertson poultry truck going west, driven by Mr. Johnson from Hebron.

The laying of the cornerstone of the new Methodist church building last Friday afternoon was witnessed by a good crowd. The officers of the Nebraska Grand Lodge were present and officiated at the impressive ceremonies. Music was rendered by the Methodist choir and orchestra. Mrs. Mary Hohensee was introduced as the only living member who had witnessed the laying of the cornerstone when the first Methodist Church was built at Hebron. Fifteen young ladies layed floral wreaths upon the stone. Dr. Charles M. Shepherd gave the address. Rev. E. E. Carter, pastor of the local church, has worked indefatigably to consummate the improvements on the church, which will be a notable addition to Hebron's fine structures.

Sam Meyer Jr. and Herman Hoeting, both of Gilead, are in the Blue Valley Hospital in this city as the result of injuries received when the Ford coupe in which they were riding, overturned in the ditch on the No. 3 highway about six miles west of Hebron.

1937

80 Years Ago

One of the largest freshman classes in the school's history was enrolled the first two days of registration at Hebron College.

Mrs. P. I. Harrison and daughter, Bonny Jean, of Hebron, were seriously but not critically injured in an automobile accident at the highway turn just north of Milford last Friday evening while en route home from a trip to Lincoln. They met in a collision with a car belonging to the Beatrice Creamery Co.

Martin Duensing, the 17-year-old son of Mr. and Mrs. Fred Duensing, was taken to the orthopedic hospital at Lincoln last Monday where he underwent an operation in which his right leg was amputated above the knee.

1947

70 Years Ago

Benny F., a western-bred three-year-old son of O.K. Mullen-Mighty Miss, owned by the partnership of F. H. Bruning and L. H. Snyder and under the guidance of apprentice Jimmy Barnes, raced the fastest six furlongs of the current season at Dade Park, Henderson, Ky., when he easily defeated a capacity field of maidens in the second race.

(The Bruning Banner) The Building boom continues! This week it was announced after a meeting of the Board of Education of School District 94, Bruning, Monday evening that the Home Lumber Co. would be building a new classroom addition to the schoolhouse and excavation began Wednesday on the lot owned by Mr. and Mrs. Robert Muir, between the drug store and the cafe, in preparation for the construction of their new grocery store building.

(The Alexandria Argus) A fire that started about 10 o'clock Monday morning in a stubble field northwest of the Wilber Harrold farm home caused the fire departments from Alexandria, Bruning and Hebron to rush to the scene of the blaze to combat the fast spreading flames. More than 100 acres of pasture land was burned over on the Harrold farm and several acres of sweet clover were destroyed belonging to Albert Johnson just north of the Harrold place. The fire boys fought the blaze more than three hours before it was completely subdued and several trips were made into town to replenish the fire truck's water supply which is carried on the truck in a tank of 300 gallons capacity.

Flu season

Each year, there are outbreaks of the seasonal flu. This time of year is called "flu season." In the United States, flu viruses are most common during the fall and winter months. Influenza activity often begins to increase in October and November. Most of the time flu activity peaks between December and March and can last as late as May.

The flu is a contagious respiratory illness caused by influenza viruses that infect the nose, throat, and lungs. It can cause mild to severe illness, and possibly death. The CDC monitors certain key flu indicators and when they see the indicators rise and remain elevated for a number of consecutive weeks, the flu season is said to have begun.

Getting an annual flu vaccine is the first and best way to protect yourself and your family from the flu. Flu vaccination can reduce flu illnesses, doctors' visits, and missed work and school due to flu, as well as prevent flu-related hospitalizations.

The more people who get vaccinated, the more people will be protected from flu, including older people, very young children, pregnant women and people with certain health conditions who are more vulnerable to serious flu complications.

Influenza is a serious disease that can lead to hospitalization and sometimes even death. Every flu season is different, and influenza infection can affect people differently, but millions of people get the flu every year, hundreds of thousands of people are hospitalized and thousands or tens of thousands of people die from the flu-related causes every year. Even healthy people can get very sick from the flu and spread it to others.

The CDC estimates there are more than 140,000 hospitalizations each year and more than 12,000 flu-related deaths. An annual seasonal flu vaccine is the best way to reduce your risk of getting sick with seasonal flu and spreading it to others. When more people get vaccinated against the flu, less

flu can spread through that community.

Flu vaccines work by causing antibodies to develop in the body about two weeks after vaccination. These antibodies provide protection against infection with the viruses that are in the vaccine.

The seasonal flu vaccine protects against the influenza viruses that research indicates will be most common during the upcoming season. The flu vaccine is made to protect against three flu viruses; an influenza A (H1N1) virus, an influenza A (H3N2) virus, and an influenza B virus.

To avoid spreading the flu, you should stay home if sick. It is also important to wash your hands often with soap and water. If soap and water are not available, use an alcohol-based hand rub. Linens, eating utensils, and dishes should not be shared without washing thoroughly first. Eating utensils can be washed either in a dishwasher or by hand with water and soap. Frequently touched surfaces should be cleaned and disinfected at home, work and school.

Most healthy adults can infect others beginning one day before symptoms develop and up to five to seven days after becoming sick. Children may pass the virus for up to seven days.

Symptoms start one to four days after the virus enters the body. That means you may be able to pass on the flu to someone else before you even know you are sick. Sometimes people can be infected with the flu virus without any symptoms.

Nov. 15 acreage reporting deadline for pastures, fall-seeded crops

Thayer County USDA Farm Service Agency (FSA) Executive Director Jay A. VanWesten announced today that producers who file accurate and timely acreage reports for all crops and land uses, including pastures, can prevent the potential loss of FSA program benefits.

"In order to comply with FSA program eligibility requirements, all producers are encouraged to visit the Thayer County FSA office to file an accurate crop certification report by the applicable deadline," said Mr. VanWesten.

The next acreage reporting deadline for Thayer County producers is Nov. 15, 2017, for coverage in 2018 for fall-seeded crops and perennial forage crops such as pastures.

The following exceptions apply to the above acreage reporting date:

- If the crop has not been planted by the above acreage reporting date, then the acreage must be reported no later than 15 calendar days after planting is completed.
- If a producer acquires additional acreage after the above acreage reporting date, then the acreage must be reported no later than 30 calendar days after purchase or acquiring the lease. Appropriate documentation must be provided to the county office.
- If a perennial forage crop is reported with the intended use of "cover only," "green manure," "left standing," or "seed," then the acreage must be reported by July 15.

According to Mr. VanWesten, Noninsured Crop Disaster Assistance Program (NAP) policy holders should note the acreage reporting date for NAP covered crops is the earlier of the date listed above or 15 calendar days before grazing or harvesting of the crop begins.

"Filing acreage certifications now, by the deadline, establishes producer eligibility for a variety of FSA

risk management programs, and it positions our office to expedite service to our producers next year, should a disaster occur," said VanWesten.

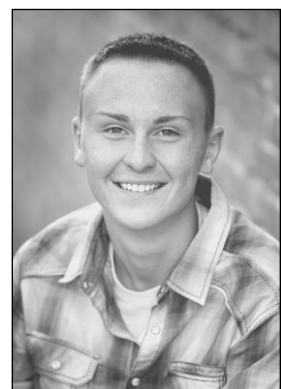

The funding trail leads back to Things & Stuff, and guild bake sales and quilt raffles. Inside the brick

building on Lincoln Avenue, about 30 guild volunteers are busy, handling purchases in the front and pricing items in the back.

The shop, which plans to be open for the Nov. 19 Christmas Fair, is stuffed with gently used clothing, shoes, novelty items, jewelry, antiques, dishes, toys, appliances and more, even Barbie Dolls smiling from their original packages.

The guild would like to expand into an acquired building. The seams on the Things & Stuff building are bursting with goods.

By 1967, the guild, formed

in 1953, had zeroed in on financially supporting the new hospital. Guild members held a county-wide sale, called "Things & Stuff." The sale never ended. It was held in a donated shop and in 1988, the guild purchased its present location. The shop is open Wednesday through Friday, 9 a.m. to 4 p.m., and Saturday, 9 a.m. to 12 p.m.

Ever since its inception, the guild, now boasting 443 members, has went to work for the hospital, providing 75 hemmed towels that first year, visiting and reading to patients and canning garden products for winter use.

special use permit for grain storage facilities, including the existing bunker for outdoor storage. Under the permit, Norder's cannot expand its outdoor grain storage.

The council also rolled back on the city's infrastructure easement for the property to allow for a driveway.

In other business, the council held nuisance discussions on five properties located on 13th Street, including two motels, Wayfarer and Budget Host Inn. Letters were sent to the motels, but no one showed to represent them. The council will consider a formal nuisance process for the motels at its November meeting.

On the other three properties, 249 S. 13th St.; 212 S. 13th St.; and 250 S. 13th St., the council decided to keep the discussion going and tabled those nuisances, partly because owners were at the council meeting to give updates.

Plans and specifications were presented for new playground equipment at Roosevelt Park. The council will examine bids at its November meeting.

Jana Tietjen of the Hebron Chamber of Commerce announced the Hebron Hidden Treasure event Oct. 5-7. She said Gilead is also holding its garage sales to coordinate. The sales are in line with Highway 136 Trail of Treasures annual fare.

Tietjen gave last year's numbers — more than 700 people came through Hebron.

Tietjen also gave updates on the archery range, Wednesday morning coffee sessions and discussion on a new gun range.

Volunteers have been working on the range, assembling the framework and skids. Grants have been received from several organizations, including Little Blue NRD.

Wednesday morning chamber coffee talks are held at Daylight Donuts weekly. Upcoming speakers are City Councilman Larry Fangmeier and Game Warden Matt Taylor.

The gun range is an interest of 10-12 people looking for land near Hebron.

Tietjen's update included speaking about the Trunk or Treat Oct. 31 in downtown Hebron and the Christmas Fair Nov. 19. Vendors will be housed at the Southeast Community College Learning Center.

Jeff Friesen updated the council on the Oregon Trail Run of Nebraska Oct. 21, now in its second year. He

said 72 runners are registered for the full and half marathons. Four to five adult teams are registered for the Pony Express Half Marathon Relay, including three teams from Thayer County Health Services.

The evening before the marathon events, runners

will pick up their packets at Roosevelt Park and a one-mile Fun Run will be sponsored from Thayer Central to downtown, where the marathon committee will hold a spaghetti feed.

The city has agreed to provide safety barricades for the Fun Run.

In digs, Oakman made 27; Schoof, 22; and Roth, 17. Schmidt had 11.

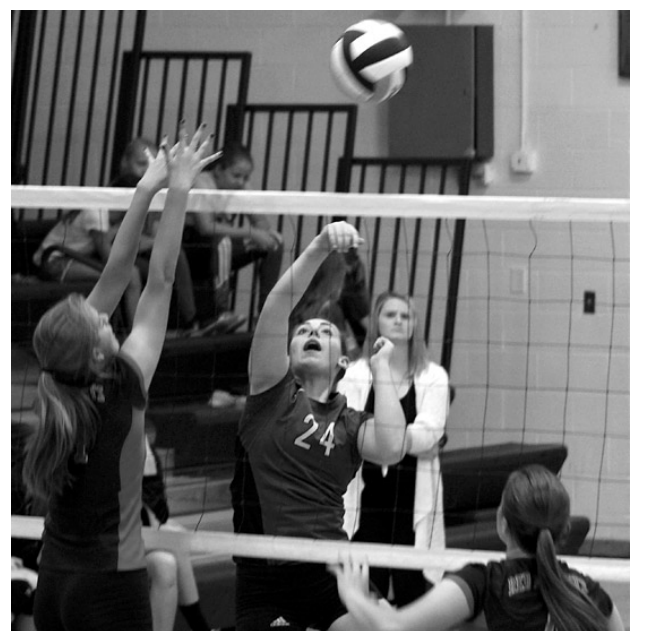
"The girls hustled and our passing won the game for us. We need to keep this momentum up for our game against Sandy Creek."
