Deshler takes next step in charitable gaming

The Deshler City Council was expected to take the next step in the charitable gaming process at its Sept. 5 meeting after a special mail-in election in August on Keno passed in a vote of 166-44.

The city and owner Steve Moore of Fourth Street Tavern will enter into an agreement with Moore being the official lottery operator, who will oversee daily Keno operations, including hiring and training the lottery worker or workers at the tavern.

Mayor Naomi Grupe was surprised local voters approved the game. In the November election, voters threw out LB840, which allows a municipality to use a portion of sales tax for economic development.

Relatives sought for honored officer

Two American flags will fly in honor of Hebron native, Virgil Hall, Sept. 11. Mike Hesse, president of the Denver Police Museum is arranging the tribute to Hall, a Denver police officer who was killed July 5, 1945.

One of the flags will fly in Denver and the other over the US Capitol building in Washington D.C. Hesse is on the lookout for relatives of Hall's who might still be living in the Hebron area. He would like to present a flag to the family.

Hall was born in Hebron Aug. 16, 1909, according to an account of the shooting written by Bill Finch in 2016. The record saw Hall moving to Denver in 1936 and marrying Mary Yarde of Garrett, Ind., three years later.

Prior to working as a police officer, Hall drove a fuel truck for Gates Rubber Company. He became a police officer April 21, 1942, in a class of 13.

At 1:10 a.m., July 4, 1945, Hall and his partner, Robert LaVernway, were patrolling when LaVernway spotted a possible stolen vehicle. Indeed, the vehicle, a 1940 black Ford sedan had been broadcasted as stolen. As Lavernway shined the spotlight on the two individuals in the sedan, they ducked and sped away.

Early in the chase, Hall unsuccessfully fired a round at the car's tires. Seconds later, the chase ended as the driver crashed into a warehouse door. The driver and

Nursing career sees many changes

In her 50 years of nursing, Roseann Wehrbein witnessed health care transition to pro-health care.

"Everything is pro-health. The field is focused on prevention - exercise, teaching - people are learning prevention," she said, noting she thinks fewer people smoke than in the past.

Wehrbein is a registered nurse for Heartland Home Health at Thayer County Health Services, where she has worked for 20 years.

She started her career path as a nursing assistant at Bergan Mercy Hospital in Omaha and then went to the Lincoln School of Practical Nursing, now Southeast Community College, to earn her licensed practical nursing degree. Wehrbein worked as a pediatric nurse and went back to school in the 1990's, passing the state boards to become a registered nurse.

She was an RN for Blue Valley Lutheran Homes before Courtyard Terrace and worked for the Women's Infants and Children program that stretched across multiple counties.

Wehrbein also taught Lamaze and certified nursing assistant classes.

Wolfe deployed to Texas

Joy and Eldon Wolfe were tossed around a bit before they settled in Port Arthur, Texas, at a shelter in the aftermath of Hurricane Harvey.

They were first sent to Austin, Texas, to volunteer for the American Red Cross at a convention center turned shelter. But the shelter could only be used for five days, so the Wolfes went to Houston, where Joy said there was an influx of new volunteers.

"We finally went to Beaumont, where there was major flooding and from there, Port Arthur," she said.

She and Eldon are working with the elderly and families.

"We just got a family of six in last night and another family of two," Joy said.

While she and Eldon are providing information and items people need, they are also listening.

"There are a lot of stories and lot of tears," she said. "They have

to tell the whole thing, the boats coming to rescue them and the water getting higher and higher in their homes."

Joy said a lot of people are elderly and it seems as if they don't have family to help them.

Staffing the shelter is the National Guard, police officers, emergency medical technicians and volunteers, who could be anyone, including the victims themselves.

"We have clients that sign up to volunteer," Joy said. "A lot of them are just teenagers."

She noted people were adapting well and helping each other. The EMT's keep children busy with games and a team of mental health workers come through and work with clients and volunteers, who are also affected by Harvey.

"Everyone wants to help everyone," she said, although hurricane victims are living day-to-day and

have uncertain futures.

Joy said there are many who rent and believe they have to wait until their homes are repaired.

"They don't have to move back. I don't think they realize that," she said.

School hasn't started yet and triage has been set up for medical needs. People are treated on site and don't have to leave, except for surgeries.

For the first time, families were able to shower after days as the shelter just received a portable shower. The women shower during the odd hours of the day — the men take the even hours.

Joy and Eldon are on their first official deployment from Hebron. Eldon has never been a Red Cross volunteer and took the class when it was offered at the Thayer County courthouse. Joy used to volunteer, and said she is starting over. They will be home next week.

Pages of the Past...

1887

130 Years Ago

Monday evening, the Christian Church was filled to witness an entertainment given by Miss Ella Rudd, of this place, a graduate and teacher in the Deaf and Dumb Institute, Omaha. The audience was much pleased with the graceful and appropriate interpretations in sign language given by Miss Rudd.

Our readers will remember the article in these columns two weeks ago, giving a partial account of the severe injury sustained by our townsman, W. R. Livesay. The account given was as then understood—Mr. Livesay went to the Hendershot slaughter house the morning of Aug. 4 and in cutting a rope with a skinning knife, the knife slipped, cutting a gash about four inches in length, on the inside of the left leg about three inches below the groin. Being alone he made an effort to go home but soon became so weak from loss of blood that he could not stand. He lay upon his right side and dragged himself to the railroad track by the time the northbound train passed, was seen by the conductor, who, instead of stopping the train, went on to Belvidere and telegraphed back to Agent Hayes that there was a dead man by the track near Hebron. A boy was sent to find him, who, at the second attempt found him just as he had succeeded in getting upon the grade, fully two hours after the accident. Help was called and he was taken home and Drs. Sutherland and Easton called, who proceeded to an examination and dressed the wound. He had been recovering as fast as possible up to the night of the 18th, being unusually cheerful during the evening. Mrs. Livesay retired as usual in an adjoining room, but awakened about 3 o'clock in the morning and found her husband at death's door from the effects of a severe hemorrhage, he being so far gone as not to recognize her. She called help and sent for Dr. Sutherland who upon examining the wound found that the bleeding had stopped, the wound being filled with clotted blood. It is supposed movement of the muscles may have caused the bleeding. Little hope was entertained of his recovery from that time on, and at 10 minutes past three in the afternoon he died. This is a severe blow for his bereaved wife and two little girls.

120 Years Ago

90 Years Ago

Miss Ambel S. Heller, daughter of Mr. and Mrs. E. E. Heller of Hebron, was married at Idaho Falls, Idaho, on June 26, to Mr. Cloyd LeRoy Iden of Rigby, Idaho, at the Presbyterian Church, the bride's pastor, the Methodist minister, being out of town.

The Lincoln Tel. & Tel. Co. have a double force at work--two cable gangs, three switchboard men and nine construction men, besides the local gang--20 in all, preparatory to moving into their new building on Fourth Street.

The Hebron golf club won permanent possession of the Jay-Husker golf trophy by placing both finalists in the annual tournament here Tuesday. L. E. Thomas and W. H. Roselius will meet in the finals, and since both represent the Hebron club, it will be the third time Hebron has won the Jay-Husker tourney.

Everybody and his cousins and his uncles and his aunts came to the M.W.A. picnic last Friday. The deluge the night before instead of ruining the celebration, increased the crowd, for farmers "couldn't do anything but come to town." There was something doing every minute. The person who couldn't find amusement and entertainment, ought to be buried--and he will be, some day, too! The parade was beautiful and elicited applause all along the line.

The most successful fair in the history of Thayer County closed Friday with an estimated attendance of 20,000. Three hundred and twenty-five head of hogs, representing eight breeds were shown and one hundred and twenty-five head of cattle, selections from seven breeds were shown. The boys and girls clubs showed baby beeves and dairy heifers, poultry, cooking and clothing. Forty little girls took part in a style show. The education exhibit was up to the usual high standard, as was the agricultural exhibit and the fancy work in the woman's department. --Deshler Rustler

1937

80 Years Ago

A very large crowd of friends, including many from various parts of the county, gathered to pay solemn respects to the late Thomas Lahners last Friday afternoon. Funeral services were held at the residence and at the Lutheran Church in Bruning. The floral tributes were beautiful and numerous. After the death of Thos. Lahners, his son, Oltman, found in a drawer at the residence the following life history in Mr. Lahners' own writing, and a memoranda to "Please hand to the Hebron Journal." The life history then follows, which is quite lengthy. Mr. Lahners served as senator from Thayer County in the Nebraska Legislature for several years and introduced the first good roads dragging bill, which brought about the movement for good roads in Nebraska. The storm Tuesday night was apparently much more violent south of Hebron. Frank Easton, who has a pasture about five mile south of the golf course, found 32 head of his feeder cattle had died in the bed of Dry Creek Wednesday. They were apparently killed by lightning.

Ohiowa man sentenced for drugs

An Ohioa man will spend three to five years in prison for selling drugs in Fillmore County.

Lyle S. Lee, 54, of Ohioa, was sentenced by Fillmore County District Court Judge Vicky Johnson to not less than three years nor more than five years with the Nebraska Department of Corrections for the Class 2 felony charge of Unlawful distribution of an exceptionally hazardous drug.

Lee was given credit for seven days time served and his court costs of \$227.22 were deemed satisfied.

At his Aug. 15 sentencing, Johnson noted the pre-sentence investigation

indicated Lee had numerous convictions from 1978 through 1989 including 11 misdemeanors, 10 infractions and one felony.

In an earlier plea agreement, Lee pleaded guilty to the charge, which stems from the sale of methamphetamine to a confidential informant on Main street in Strang in January of this year.

"He and his wife are selling methamphetamine in this county," Johnson said prior to sentencing. "The defendant also minimizes his actions."

Lee's wife, Tamara S. Lee, will be sentenced Sept. 12.

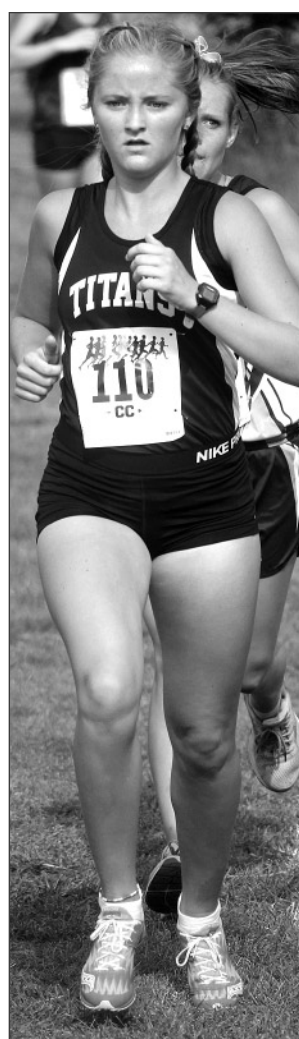

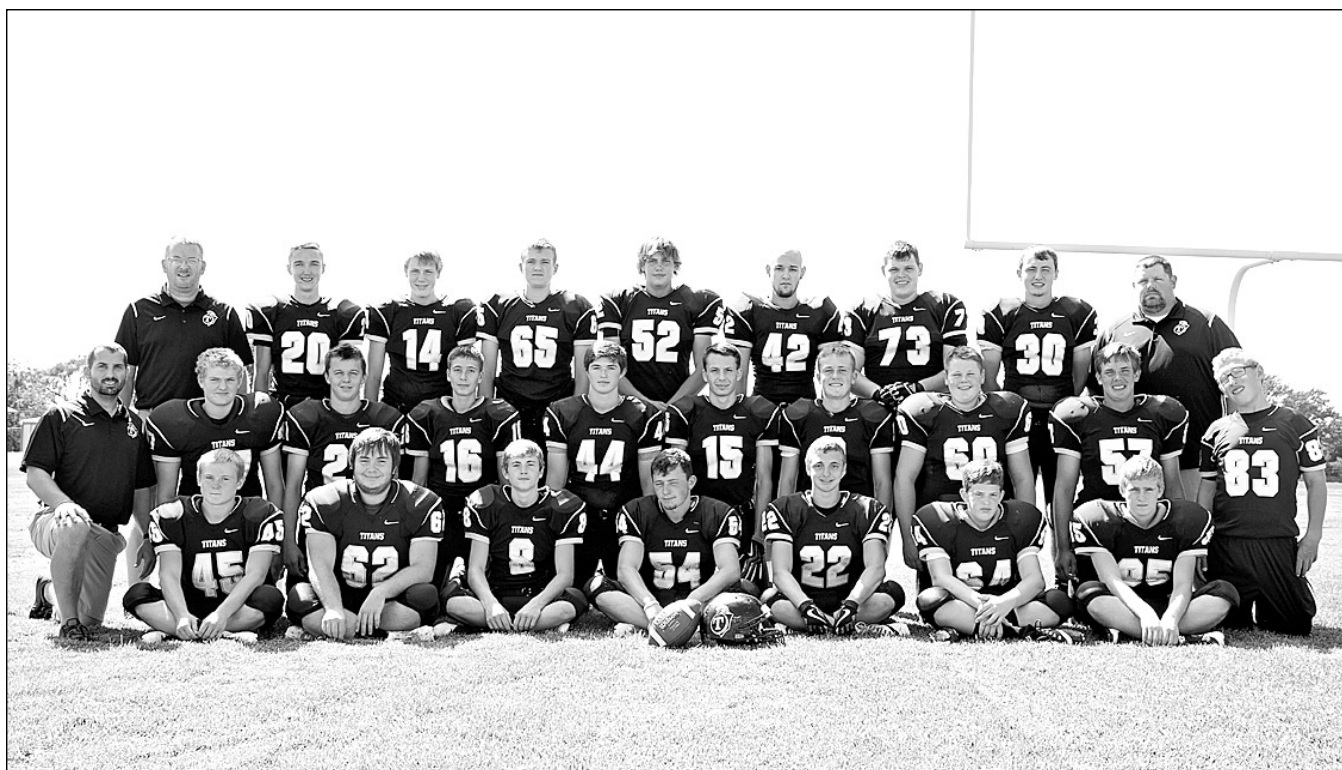

If you were unable to stop by during the open house, give Amber a call, she would love to show off the accomplishments that have been made at her childcare facility.

Since Amber opened she has had no problem with filling her spots with children, and is currently full with 12 children. TCEDA is very happy with the success she and her family have had with Mama Am's. As anyone knows, the time you put into starting a business is not all glory, but the end achievement is outstanding.

Wade and Amber have put in long hours to meet state requirements in order to have the facility licensed for Home II certification. The facility showcases the love that Amber gives to the children she takes care of. Each day time is scheduled to work on age appropriate curriculum, along with fine motor skills, and just down right fun. Step inside and you will see that Dr. Seuss is the main theme throughout the learning center. Most of the artwork was painted by Amber along with friends, and prior teachers and mentors. Alice in Wonderland lines the eating/craft area.

Amber has her Associates degree in Early Childcare Learning and has been providing childcare for over nine years. A bulk of the recent page updates have been for Nebraska Shrimp Company. Dietrich gave me a tour the last two times I have been out to the site, and I cannot believe the changes that are happening so quickly now. Last time I swung by, the electrical for the lighting was being installed, the tin was being finished up on the building, and the color for the gutters and trim is picked out, thanks in large part to Grandma Brinegar. Dietrich is hoping to be able to have shrimp in by harvest time. Let's keep our fingers crossed.

TCEDA Vice President Heather Ramsey and myself attended a webinar hosted by Nebraska Community Foundation along with Red Cloud Community Foundation to better understand just how Red Cloud was able to put together a plan and a fund for a new community center/daycare learning facility. This facility will be completed in December of 2017, and it will host a preschool, daycare, and community events area.

When looking at working on a daycare center in the northern part of the county, something that we deal with is that time does not move quickly when working on such a large project. Red Cloud spent five years in making their dream of a

quality early childcare and learning facility come true. Even though their facility is a lot more than what we are hoping to accomplish, it still takes the same amount of time, devotion, and volunteers to see the dream come true. I can speak for myself and Heather that we have been diligently working on the daycare for the past five months and remain dedicated to the goal at hand of having a quality early childcare facility in the northern part of Thayer County which includes Davenport, Bruning and Carleton and anyone in and around those communities.

At this time, we have explored several site locations, and had many conversations with persons interested in working at a quality childcare facility. With any childcare location, the Fire Marshall is at the top of the list to contact in determining whether a site is viable and if so what may need to be added or corrected to meet state codes.

The Fire Marshall is just one of many steps to get started on the foundation of a daycare. Money is also a large portion of the planning process. Where are the funds going to come from? What can be donated? Who will operate the daycare? How many staff will be needed? These are the questions that pop up time and time again to be asked and often we just don't have the answers to give out yet. Just remember we are still in the early stages of determining site and going from there. The first stage was the easiest, an idea, from there on all we can do is grow the idea and make it happen.

We have had several meetings to present the data that Heather Ramsey has gathered and the numbers that are affected currently by lack of daycare in the area to interested parties. With that being said, we are not limiting our venture to just one site location. You always need a backup plan to continue to strive to see a project accomplished. I know personally how many hours Heather has put in and why she is determined to get this done. When you are in need of daycare in your area and there just isn't enough, it makes it hard to keep your children together at the same location. TCEDA and supporters want to see this project succeed and believe that it can be done, but it does take time.

Update on the Bruning Fire Department's new hall: The station at the site that will be used for the new facility has been leveled and cleaned up, tanks unearthed and removed from the ground, any contaminated dirt has been removed, and new fill dirt laid. It does make a change to that corner from seeing the old station that was a special landmark to many, to now having an empty lot waiting for a new venture. Fundraising is in the process to help reach monetary goals and information on how you can donate will soon be coming out.

The Cattlemen's Ball of Nebraska coming to Thayer County in June 2018 is the biggest news I know in the county. What an honor for this area to be able to help make an impact on finding a cure for cancer! Randy and Becky Hergott are hosting the event. Rob and Natalie Marsh are co-hosting, with assistance from so many people and businesses near and far. I am super excited to see what this brings to the county. Thayer County itself is on a mission to get in top notch condition for the event along with the surrounding towns and counties. National Epilepsy Awareness Month

November is National Epilepsy Awareness Month. Epilepsy affects about two million people in the United States. Epilepsy is a disorder in which a person has two or more unprovoked seizures. Unprovoked means the seizures are not brought on by a clear cause such as drug withdrawal, heart problems, or extremely low blood sugar. In other words, epilepsy is a condition of recurrent, unprovoked seizures.

Epilepsy is more common than you might think. According to the Epilepsy Foundation, millions of Americans are living with the condition. Although it can strike either sex at any age, epilepsy is most often diagnosed in children and in older adults. As you age, your risk for epilepsy also increases. The seizures may result from a hereditary tendency or a brain injury, but often the cause is unknown. Many use the term "seizure disorder" instead because "epilepsy." However, almost all seizure disorders are epilepsy.

People with epilepsy experience brief disturbances in the normal electrical functioning of their brain. This can affect the entire brain, which is called generalized epilepsy, or just part of it, known as partial epilepsy. When these strong surges of electrical activity occur, they affect the consciousness, movement patterns, and sensations during episodes called seizures. Although many people have seizures, not all of them are epileptic.

The source of epilepsy is the human brain. Although the symptoms of a seizure may affect any part of the body, the event that produces the symptoms occurs in the brain. Where in the brain the event happens, how it spreads and how long it lasts all determine the type of seizure and its impact on



the individual.

So why do people develop epilepsy? Unfortunately, researchers don't have all of the answers, and for the majority there are no known causes. Because the causes of epilepsy are so varied, establishing a medical history is usually one of the first steps a physician will take when diagnosing the condition.

Epilepsy isn't like heart disease or cancer, where certain lifestyle habits can affect your level of risk and allow you to take preventive measures against developing these conditions. Epilepsy can affect anybody. Because one of the causes may be a brain injury, it is important to protect yourself and your family from a head injury as much as possible. You should always wear a helmet when doing certain activities. This means the whole family, not just the kids.

Managing a condition like epilepsy can be complex and frustrating. Sometimes, seizures make it hard to work, go to school, drive, and take part in social activities. Sometimes epilepsy treatment makes these activities harder, too. How epilepsy is perceived or how people are treated can often be a bigger problem than the seizures.

The Chelsea Hutchison Foundation that serves individuals and families affected by epilepsy, is hosting a "Stomp Out Epilepsy" 5K on Sunday, September 24, starting at 2 p.m., at the Fire Hall in Hebron. For more information visit STOMPNebraska.org.

When she graduated as an LPN in 1967, nurses wore dresses, white support socks and lace-up shoes, topped off with a cap.

"They wanted women to look very professional back then. I was told no earrings and the only jewelry we could wear was a wedding band and watch with a second hand," Wehrbein said.

The home-health nurse also remembers a black pen was used to chart for the dayshift, a green pen was used for the afternoon shift and red for the nightshift.

Patients were admitted the night before their surgeries and very few men were nurses. Cancer was a "death sentence."

LaVernway went after the driver under Hall's lead. Hall pursued the passenger, 20-year-old Manual Mondragon, who ran up a flight of stairs behind a building to the second-floor landing and hid behind a stack of wood. During the pursuit, Hall fired a warning shot.

As Hall reached the landing, Mondragon suddenly jumped out and fired three times at Hall, hitting him in the stomach, left chest and hips, from a little more than an arm's length away.

Hall managed to club Mondragon over the head with his shotgun. It is unknown why Hall chose not to fire. He may have not been able to considering his proximity to Mondragon and the narrow landing. It's also possible the gun wasn't recharged after Hall fired the warning shot.

Instead of using his shotgun and not removing his sidearm from its holster, Hall hit the man and thought he was down, so Hall turned around and started down the stairs. But Mondragon got up and went after Hall, who spun around and fired, fracturing Mondragon's pelvis, wounding him in the head, chest and arms and causing him to drop his gun.

Hall then went in search of his partner.

LaVernway had heard the shots and was heading Hall's way. He heard Hall say he'd been shot and could see Hall had been wounded at least twice when Hall was back in the police car before he was rushed to Denver General Hospital.

The shooting went out over the airwaves at 1:20 a.m. Officers in seven police cars responded, along with two cars of detectives.

The man LaVernway had chased, Charles Montoya, age 20, literally ran out of his low-cut moccasin type shoes. He hid out at a truck body company and stashed one of two stolen guns. Montoya and Mondragon had broken into a car three days prior and took two handguns. Mondragon had the other gun, the one used to shoot Hall.

Mondragon was taken to the hospital for his wounds. He was interrogated during treatment and the two lead investigators discovered a third person who had participated in an aggravated robbery.

When asked if he knew Hall was a police officer, Mondragon said yes.

"I recognized his uniform all right," he told investigators.

Mondragon was charged with second degree murder. He was already a felon for burglaries. This time around, Mondragon was also charged with being a habitual offender, which carried a mandatory life sentence.

Mondragon's first trial was over in a flash because

a defense attorney erred in outlining to prospective jurors the penalties for murder and manslaughter.

The second trial saw Mondragon's attorneys basing their defense on self-defense. Prosecutors were going for first-degree murder.

Montoya and the third person to partner with he and Mondragon, Robert Kimball, were transported from their cells to testify. Each had been sentenced to 25 to 35 years for the robbery. In testifying, both either invoked the Fifth Amendment or claimed they didn't remember anything.

Eventually, the jury was taken to the crime scene, where the shooting was reconstructed. Entered into evidence was Mondragon's signed confession.

After the trial, the jury deliberated for six hours and found Mondragon guilty of second degree murder. The judge's immediate sentence was 25 to 50 years in prison. A surprise from the conviction was Mondragon didn't receive the death penalty, court officials said.

The same day Mondragon was found guilty, a minor accused of slaying a police officer in a Denver community was also convicted. He was sentenced to life in prison.

Mondragon had to return to court for the robbery and the habitual offender charge. He ended up receiving life in prison plus 25 to 35 years for the robbery. The sentence was later reduced to 25 years to life. He was sent to the state hospital two years later and diagnosed with schizophrenic hrenic reaction, chronic undifferentiated type. Mondragon was at the hospital until his release. He died in 1995.

Hall's funeral service was held at Olinger's Mortuary Chapel in Colorado and he was buried at Crown Hill Cemetery in Wheat Ridge, Colo.

His mother, Daisey Hall, died in 1974 and is buried across from Hall. Mary Hall never remarried and is buried next to her husband. She died in 1978.

The year Hall was killed, 104 other officers were killed in the line of duty. Hall was the 46th Denver Police officer to die while doing his duty and the 10th to die in the area where he was shot, dating back to 1891.

November is National Epilepsy Awareness Month. Epilepsy affects about two million people in the United States. Epilepsy is a disorder in which a person has two or more unprovoked seizures. Unprovoked means the seizures are not brought on by a clear cause such as drug withdrawal, heart problems, or extremely low blood sugar. In other words, epilepsy is a condition of recurrent, unprovoked seizures.

Epilepsy is more common than you might think. According to the Epilepsy Foundation, millions of Americans are living with the condition. Although it can strike either sex at any age, epilepsy is most often diagnosed in children and in older adults. As you age, your risk for epilepsy also increases. The seizures may result from a hereditary tendency or a brain injury, but often the cause is unknown. Many use the term "seizure disorder" instead because "epilepsy." However, almost all seizure disorders are epilepsy.

People with epilepsy experience brief disturbances in the normal electrical functioning of their brain. This can affect the entire brain, which is called generalized epilepsy, or just part of it, known as partial epilepsy. When these strong surges of electrical activity occur, they affect the consciousness, movement patterns, and sensations during episodes called seizures. Although many people have seizures, not all of them are epileptic.

The source of epilepsy is the human brain. Although the symptoms of a seizure may affect any part of the body, the event that produces the symptoms occurs in the brain. Where in the brain the event happens, how it spreads and how long it lasts all determine the type of seizure and its impact on



the individual.

So why do people develop epilepsy? Unfortunately, researchers don't have all of the answers, and for the majority there are no known causes. Because the causes of epilepsy are so varied, establishing a medical history is usually one of the first steps a physician will take when diagnosing the condition.

Epilepsy isn't like heart disease or cancer, where certain lifestyle habits can affect your level of risk and allow you to take preventive measures against developing these conditions. Epilepsy can affect anybody. Because one of the causes may be a brain injury, it is important to protect yourself and your family from a head injury as much as possible. You should always wear a helmet when doing certain activities. This means the whole family, not just the kids.

Managing a condition like epilepsy can be complex and frustrating. Sometimes, seizures make it hard to work, go to school, drive, and take part in social activities. Sometimes epilepsy treatment makes these activities harder, too. How epilepsy is perceived or how people are treated can often be a bigger problem than the seizures.
